

#### II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 9:00 a.m.

Lester Carlson: [Written Testimony read by Senator Rodriguez]

Sen. Lou Leon Guerrero: [Written Testimony]

Glenn Leon Guerrero: I come before you today to testify in favor of my son in his appointment in GEDA. I've known Henry for about 7 years who married my daughter Alexandra six years ago. Henry is an out of the box thinker. Managing GEDA requires this type of leadership. The decisions we have made in the past put us where we are today. He is not just a visionary or a dreamer. He is a strategists and a planner. He is strong; he can execute and set the infrastructure in place so that if we want to get into a better place, he'll help us get there. Unfortunately, he may not be in that position 20 years from now to see the fruits of the decisions he and we make today.

I want to point out that I, like Senator Lou, believe in Henry. His priorities are in the right place. He knows and he's a member of this community. I could recall on the last couple weeks, I would call him up in regards to the government. First, he would assess the situation and if he realizes that if it can take a little while longer, he's ask if he can call me back because he might be feeding his sons. My point is, Henry has his priorities right. He knows what is right from wrong. I fully support him and I am proud to say that he is my son.

Michael Ady: I met Henry about 5-6 years ago when he came to my office looking for some furniture. He came to buy the furniture and business had to move and we asked what do we do with the furniture and he said he'll work on a payment plan and he did. He paid his bill timely every month and he made it happened. As Lou said, as we baby boomers are getting older, I feel like we are not doing are jobs if we do not provide this kind of opportunity to people like Henry. As he moved into the government, he was there to answer my questions. If we don't have somebody in the position that can think outside the box and create these opportunities and we have really good people within the staff of GEDA and I have heard nothing but good reports in their willingness to work with Henry.

Vice Speaker Cruz: I would like to thank Senator Lou Leon Guerrero for testifying. She came and spoke to me about Henry. I asked her to please bring Henry in and discuss the documents. I was hoping that she would have gone through the documents with him. [Vice Speaker hands out documents. Please see attachment] since she was the one who gave the strongest testimony in favor of Henry, I would like to go through the documents. Senator, there is no question that the documents show that Henry is no longer in business with these and you have mentioned that a couple of times. I mentioned to you my concerns whether as you ended, he is a man of honor, and I don't say that very likely but I want you to go through the documents. I was hoping that if and when you went through the documents, as a banker and as a senator, you would be able to see some of the problems. The company that I was very concern about is the company in the first document, the articles of the organization of Downtown Pacific Ventures. You see, it's stamped there April 2, 2004 on the front. It signed on page 7 by everybody and it's notarized, all signatures. This document from the law form, you would notice a document number on the bottom left side of the page.

It's ND40401. DPV Articles

You'll know that the documents are dated April 2, 2004. In that document, everything is notarized. [Senator distributes documents]

You remember the legislation in 2007 when they passed the law corporations have to do an annual lasting of their members? That is also a requirement to get your license. From what you have just been provided. These are the documents of Downtown Pacific Company that have their annual stamp from August 21, 2007 and Alliance is still a member, which I do not know if Henry was still a part of Alliance, which is another issue, but you'll notice at the bottom of the document the law firm was using a different kind of notation.

It used a different notation of G0024958.DOC1.

In 2008, the law firm used the same in the document G0034031.DOC1.

You'll not in 2009, they start using a different kind of numbering system. The firm changed its way and it has a document number. It says 361407 for 2009.

For 2010, it has a number, this time it's sequential. It is definitely not the file number for the company because it's different. It says 372739.

For 2011, the document is 383695.doc.

Why I point that out is that the law firm used different kind of ways of denoting the document they prepare annually. There was a change over in 2009 from having the G designation and just having a number. Now, I then turn your attention to documents that for some reason how they were filed in Rev & Tax and marked as amended report and it's stamped dated September 26, 2012.

It's the Limited Liability Company 2007 Annual Report for Downtown Pacific Ventures, LLC. This one is dated and signed by Edward J. Calvo and dated September 13, 2012. You see that the number for that document is marked 394632.

Also, for some reason, filed on September 26, 2012 was an amended report for 2007 and dated September 13, 2012 and was signed by Edward J. Calvo, Managing Director.

When we talked, my concern to you was how long Henry was in the corporation and we discussed about the fact that you knew about the Downtown Pacific Ventures and that it was in 2007. If you look at it, it's a unanimous consent of Downtown Pacific Ventures, where they

allowed Henry to sell and transfer their interest of alliance services and transfer it to a John P. Calvo.

You'll note the date on that, 2004, and that is eight days purportedly was organized. If you look at the next document, this is his assignment as a withdrawal as a member and dated April 30, 2004. You'll note on the unanimous Consent on the front page, for 2004 document, it interestingly enough have numbers that was only used by the law firm in 2009. For that Unanimous Consent, the number is 394683.

For his assignment, it's 394701. If you look at the chart, you'll know that interestingly enough, it's sequential. The documented supposedly signed on April 30, 2004 are sequentially numbered before the document numbered in 2009, 2010, 2011 and 2012. This is the reason why it had me wondering that the documents were actually prepared.

Lou Leon Guerrero: I do understand and in my testimony I stated that it may raise concerns and that's why there was the question of the integrity of Henry. I don't know, I am not a member of the law firm of Calvo & Clark. I cannot answer why these are not in sequential. The only thing I can say is, I did talk to several people about two of these documents. Why is it that Henry invested in a company that started in April 2, 2004 and divested in the same month of that year? I asked him that same question. The response he relayed to me was that when they were forming this company, they were requesting for capital calls. It got to the point where he could not continue with the capital calls, therefore, he divested. I don't know why the short time frame and they were already getting the capital before the company and Henry was asked for more money and he said he couldn't do it so he had to divest.

There are a lot of possibilities of explanation of that. If this is such a compelling concern for you, then I suggest that you talk to Calvo & Clark.

Vice Speaker Cruz: Senator, you're the one that came in and testified on his honor. I'm just asking because of his honor into question.

Lou Leon Guerrero: I don't know if Henry did that versus the law firm. Henry may not know anything about it

Vice Speaker Cruz: He signed a document dated April 30.

Lou Leon Guerrero: He is going for the Director of GEDA. He will have people below him that will pay attention to all the details and you have to trust these people that he has hired to do the work. This is the same as myself as a CEO. I do not know all the details of the documents. I hire people who are certified, qualified, gone through the training and gone through the experience and expertise to help me run the business. I'm sure Henry is going to be just as vigilant about the competency of his staff. You are absolutely right, in the financial industry, details are very

important. If I was going to be so detail about the numbers of the documents having to coincide, I cannot run the company as a CEO. I might as well fire the employees and run the company myself, which is very unrealistic.

When I spoke to Henry, he said to me that he was not involved in the making of these documents. He was not a part of drafting these documents. His only responsibility is to read the document and agree with it and sign of. I know PTC was formed in 2004. When I spoke to Henry's wife, Henry came back in 2002. They started dating in 2005 and got married in 2006 and when they started dating, he was no longer part of the company. I have to also trust word of people and I trust Ali's information because she is the one familiar with the chronology of events.

Vice Speaker Cruz: Did you hear him on Travis Coffman? He said was still a member...

Lou Leon Guerrero: No, I didn't hear him in Travis Coffman's... I also spoke with Travis because you mentioned it when we met. He said that he did not have documents in front of him to be informed of the dates. We all know that as leaders. When we are asked questions, we say things and we may not have the right dates, the right information, the right facts and so forth. Does that mean that my integrity, then, is discolored because of that? Absolutely not. That's all I'm saying. My testimony is based on discussion with Henry and believe me there were frank discussions that I'm not even going to say here. You know me, I ask the questions and I am very blunt with the questions.

Vice Speaker: Yes, we were blunt with each other and I told you that I would have been happy if he had told me that there were no documents to doctor these documents. If he had been honest...

Lou Leon Guerrero: I don't think he was intentionally lying to you Vice Speaker. If you put yourself in Henry's shoes, a young guy who has no experience in dealing with such an esteem body that is pressuring me to get the documents. He would try to get the documents because he wants to meet the requirements...

Vice Speaker Cruz: So, you're saying that if a borrower would come in and know that they doctored some of the documents...

Lou Leon Guerrero: If I knew for a fact that the documents were doctored, of course we do not accept that.

Vice Speaker Cruz: Okay, I am just pointing out to you that if you look at the sequential numbers on this...

Lou Leon Guerrero: Besides the documents, when you make a loan to somebody, and I've learned this, there are 5 Cs you have to go through. Each of those Cs mean different things

(Character, Credit, Collateral...) they say to you, it's about Character, Character, Character, Character, Character. So I have made loans to people who are not credit worthy who were delinquent, charged off, foreclosed, filed bankruptcy but when I meet with that person and feel their character and that their word tells me 'I'm going to pay you, Lou, no matter what,' I give that person that loan.

Vice Speaker: in our vote, it is also an issue of character and I'm just asking, if the person is not honest with me, should I or can I, with the documentation I have before me, and he will not own up to the fact that these documents were doctored at a later date. What is the character and what should I say?

Chairman Rodriguez: Mr. Vice Speaker, there were accusations that were made that documents were doctored, which is not verifiable by the Committee. So, I just want to caution the members in making statements like that.

Lou Leon Guerrero: in my testimony, Mr. Vice Speaker, I did say that if this document is a compelling concern, then vote your conscience. If you look at the whole picture of Henry, he's experienced, educated, his work and so forth, I don't believe that it's that compelling and that I would vote for his favor. Bottom line is, these documents say that as of today, he is no longer a member of that company. Whether the dates don't jive or the documents at the end of the day he is no longer a member of that company. That is why I took the time to come here and testify on behalf of Henry. I don't believe he's lying, he's dishonest. I think if you have a great concern, the only people who can answer this is Calvo & Clark.

Vice Speaker: I thank you for that. I mentioned to you that if we could please not have this move forward because I would question his character and also the character of the new chairman of the GEDA Board who signed of as the managing partner and the firm and I will report this on the panel because this needs to be investigated.

Lou Leon Guerrero: Do what you have to do. What I'm saying is I did talk to Henry. Like I said, if he knows he's right he's going to go forward with whatever means he has. I certainly feel like you have to do what you have to do because you are elected to protect the interest of the people.

Senator Respicio: I appreciate the back and forth between the Vice Speaker and Senator Lou. One issue for me is Henry suitable to be GEDA administrator? I believe he is. Did Henry get that legal advice? I believe he did. That is my opinion. I do agree with Senator Lou that the Law firm should be the one asked. If you look at the chronology the Vice Speaker makes a very compelling argument, which makes this confirmation difficult in a sense that these concerns are being brought forward. This is unfortunate for Henry and his family that he gets caught up in this situation. I'm just going to reconcile in my mind, saying this with caution, this is a matter for the law firm to sort out and defend.

Senator Yamashita: this is about character, youth, preparing our next generation, success. It is looking about the whole picture and the right answers. It is also about understanding public service. For someone who wants to step into this and continues to want to step into this after this, it talks about character as well. It also talks about the youth, as we make decisions when we're young, I too, think back on the decisions and what could've been different and should've been different. That's what that is. The question of character and integrity is in front of us and we need to ask the right people. I don't know about how the code or numbering systems change and what causes that. I, too, had my conversation with the candidate and I understand that he realized that the restaurant business was not his gig. I do understand that he said that was not working for him. How he moved forward in regards to legal decisions, I don't know why it's out of sequence. I do appreciate all the variables in front of us.

Herbie Perez: I am here in front of you in support of Henry Taitano. I know that there are questions in regards to his affiliations with PTC but I want you all to know that I am his mother and I know what he does. I requested for him to step out of that business. Henry does not know anything about restaurants. In the opening of that restaurant, I had to provide the freezer from my house because Henry could not afford it. At any business you start, you cannot make profit. I sent him to school and I know no one is perfect to say that they don't make mistake. We make mistake and we realize that later in life. There is such thing as second. Please give this opportunity to the young generation to lead us. We, seniors, I respect the youth to lead us in this island. Henry wanted to come back to Guam and I encouraged him not to but he said he wanted to serve his community. if your son is being mentioned with all this discredit, I sure don't appreciate that. I have supported every one of you, especially to the Democratic Party. I am loyal and I do not appreciate you discrediting my son. Anyone has question, that is already 2004, why are we still bringing that back? I'm with DOE I cannot say that I know everything but we are dependent on our subordinates. Those numbers needs to be referred to legal. Henry is very aggressive and has intention to do things the right way. Henry one of my sons where when he says yes to something and I say no, he'll still say yes. I respect that because in the end it shows that he is correct. I'm asking you to support him and let him lead. I heard several remarks from GEDA when he worked with them. If we are looked at who we are affiliated with, then maybe none of us will have jobs. I respectfully and humbly ask for your support for Henry Taitano.

Monte Mesa: Monte Mesa- Good morning Mr. Chairman and Senators, my name is Monte Mesa. I'm here today, first of all, let me say this in Chamorro. (Translation in Chamorro.) - I am here and happy to support Henry Taitano. I know that what is being said today, it is not too nice, for the work of GEDA. But, I would like to let you know that whether Henry is the Director, don't forget that there are 5 Board members and that Henry alone, unilaterally, cannot authorize what GEDA will do for that is why there are Board members. That is why these board members approve all that is done and proposed for the betterment of the land. I would like to support Henry because I know he is what they need. Even I, know that he will do what is good for our island community. Knowing that the tourism industry is the number 1 industry. Henry has many ideas that will work for this industry. Henry Taitano: Hafa Adai Senators and thank you again for your time to be here. I wrote something earlier and it's not a formal testimony. I decided that for today, I will speak candidly why I'm here today and so, I'll read you what I have and go from there.

First, I would like to start by thanking this legislative body for the opportunity to be here today, for giving my appointment consideration once again.

I thank the board of GEDA and the Governor for giving their continued trust, confidence and support of my appointment. I would also like to thank, to extend my sincere gratitude to those who have reached out to express their support and have gone out of their way to communicate back today with their public testimony and presence.

Last time I faced this body, regarding this issue, I spoke at length about the position, the agency and what I thought it would take for GEDA to succeed in its goals and objectives. Today, my message would be much different. It will likely be the most important thing I communicate to this body and the people of Guam in this process.

My message today, is about why I accepted this opportunity to serve. Why am I doing this? Who am I and what is my intent? My answer is quite simple. I love this island, I love our people and I want to do what I can to help our community become an even greater place to live. This position would give me the opportunity to continue to do what I love doing. I consider this opportunity to be one of the greatest honors I have ever been given in my life. It truly is a blessing and I believe with all blessings comes the responsibility to cherish it, respect it, honor it and use it for good.

This confirmation process has made me reflect back on my life and the decision I made to join government service in the first place. It brings me back to a conversation in late 2010 with then Governor-Elect Eddie Calvo and Frank Arriola who is now our current Chief of Staff. They sat me down and they offered me a position to serve in the administration as the governor's Economic Advisor. Honestly, I never had any intention at that time to pursue a government position. I did help Governor Calvo and his campaign develop initiative involving economic development and our quality of life. I was honored to volunteer my time at that point. But I was not doing it with the intent of working for his administration. Although I was appreciative of the consideration, I intended on respectfully declining that position, life was very comfortable for me back then. I had a great job and was doing well financially. With what I considered greater opportunities ahead, I had two young children and was doing what I could to provide a great life for them. Conversations with Gov. Calvo then I changed my mind and it has changed my life. He told me that he thought that it was great what I was doing for myself and my family, but that he wanted to offer me an opportunity to do something great, to do some great things for Guam.

I don't know what the exact words were but, it sounded something like, Henry, you have your whole life to pursue personal success, but I would like you to consider the great opportunity to serve your people and the community you love. It will not be easy, you will have to take a pay cut, and it will come with great responsibility and public scrutiny. But if you accept this position, you will have the great honor of helping us make a difference in the lives of our people and improvements in this island that you will appreciate in your life as a Guamanian.

His words brought a powerful message that reminded me that I truly loved and enjoyed in life. He reminded of how great it feels to do something good for other people. And made me realize

that he was offering me a position, that as a job. What a blessing! Since then I have been reminded of this blessing many times. One of the first was, I got a call from my aunt Nita about 2 days into the administration. She didn't support us at all, in fact she was very against this administration during the campaign. But she called me and I was sitting at my desk in Adelup, a desk I had to bring in because we didn't have money to buy desks, you know, waiting for things to be put into the office. She said now that you are at Adelup, I need your help. You need to help me figure something out. And I said, yeah, what can I do? So she told me a story about a family who was living in a van, and the father was trying to find a clean place to let his kids shower. I remember that story, I don't know the family personally, but I went home that day and I hugged my kids, and I thank God for the blessings that he has given me. And I vowed that day to remember that for the rest of time I'm in public service. There are a lot of other stories that remind me about why I am here, and why I'm here today. We had the ground breaking for affordable homes, and the irony is that I, you know, I grew up really with a silver spoon in my mouth, I got to go to the best schools money could buy because of the hard work and dedication of my parents. The thing about affordable homes is that my Father's business is actually low-income rental. So thankfully for the programs GHURA is that they could pay rent when people couldn't afford it. He had the resources to support my mom in providing for my life. That is something that I wouldn't forget. I would leave the campuses at St. John's, Harvest and FD struggling everyday to feed their family, and I would never forget that because of the Department of Education, I grew up in this building, my mom's office was just down the hall. I never forgot that what God provided my family in order to give me what I have and it is part of why I feel that this is such an honor. It is not an entitlement, it's an honor. There are amazing people behind me who have expressed their trust and support in me, and yes, I did come back to Guam and why not, I wouldn't want to live anywhere else. Things were difficult, but they always are if you are trying to accomplish great things.

In these last couple of years, I've seen great things that just changed the person I am, forever. The look on people's face when we do ground breaking for affordable homes, the tax refunds, that was a very heated argument, debate, between this administration and this body. But to see the face of peoples faces who waited in line 3 hours for a 50 dollar check. It reminds me everyday of why we are doing this. The recent stories of these Guam soldiers, I cant even imaging what their families are going through. I have relatives who are in the Guard who have left off island who are currently in Afghanistan, risking their lives, to provide economic opportunities for their kids. Yes they are patriotic, but they are also trying to provide their children. And sometimes, those are the options they choose.

One of the reasons why I am here today is to help us provide other options, not that military service isn't honorable, because it really is, it's probably is one of the greatest honors. But, I wanted to help develop this economy, this island, so that our children can have many choices of what to do and how to succeed and how to serve our island.

I've been blessed my whole life, and now I have the opportunity to share those blessings. And what they have done for me by serving Guam and its beautiful people. My blessings came from God and hardworking parents, but they came through opportunities they used to succeed, opportunities this community provided, and I don't forget that.

I'm committed no matter how difficult this has been or will be in the future. When the vote first came down that first round, I got a call from Auntie Lou Leon Guerrero and Governor Calvo, Frank Arriola all sorts of people calling me, encouraging me to stay committed and to be okay with it. Honestly, I was handling it quite well in fact I think it was harder on my family than it was on me. I've been at Adelup for 2 years, for me I understand the process in getting legislative support and you know its not easy and it shouldn't be. This is a very serious and important position and it should come with that public scrutiny. But it is also part of why I am so honored to do it. It is not an entitlement, just because I came back to Guam it doesn't mean I should be GEDA Administrator, just because I have certain degrees or whatever. It's not! That doesn't entitle me to this position. I'm passionate about it, and I care deeply about what were trying to accomplish, and that's why we're here today. If confirmed, I vow to serve this community and GEDA with the integrity and honor our public deserves and that this position demands.

Senators I know that my integrity, my honor, my character have come into question because of document numbers and all sorts of things. But at the end of the day, I have no interest in that business or any business those guys are involved in. My mom is right, she never wanted me to open that place or investment, but I'm so proud and glad that I had her support and that I was able to experience those things. Whether issues with paperwork or those sorts of things, possibly I cannot answer most of it, and Sen. Cruz, I am not going to even try to get into a legal debate with you and your expertise. But I do know that there was a time, Sir, when you were appointed to be a judge, and people in this community, churches even questioned the things you felt or believed and you were given the opportunity probably by a legislative body as well, maybe some had doubts, but you were give the opportunity and because of that you were able to serve this community for decades, and you've done ground breaking things in the legal field that no one can question as far as their impacts. All I'm asking Sir, is for the same consideration. I did not lie to you, I did not doctor any documents. And I know that this is not a court of law, but if it was I would be innocent until proven guilty. And I just ask Sir, that you consider that and take my word for it that I plan on executing the authority as the administrator with great honor, with great respect and you will see that with my actions. If I am given that consideration and I am confirmed by this body.

For those who have supported me on this panel and thank you also for those of you who met with me recently I have tried to meet with all of you, I continued to dedicate myself to this, you know I was asked, why would you want to go through all of it all over again. You know if I had something to hide, I wouldn't want to go through it. Who would want to have their mother to come up here and talk about, you know, these sorts of things. And I feel bad for Auntie Lou, I don't want to put that on these people, but they feel compelled to do so, to defend my integrity

and my honor and my character. I need to do the work and that's what I need to do. I can say a whole lot of things, but at the end of the day, I need not forget these people who deserve opportunities and I need to focus on what I can do to help. And that's why I'm here.

So, thank you for your support, thank you for your time, thank you for your consideration and even thank you for your criticism when it does come, its important, I'm glad we are all engaged in this. I'm glad that GEDA is getting all the attention, and unfortunately, maybe for things about me that aren't the best, but the attention that we need, we need to have on the issues so that we can improve it, so that we can make things better.

I humbly sit here today, honored, truly honored, that the board and the Governor have once again, appointed me here today, and that you are considering it, and I just want to thank you.

Vice Chairman Ada: I thank the Governor and the GEDA Board in reappointing you and seeing the potential that you have. I thank you for your willingness to step up to the plate and go through this process once again. It says to me a couple of things. First, it says that you have nothing to hide. Second, not only that your family and friend believe in your character and integrity, it also says that when you came out the first time, you could've just ran, but you didn't. you stood your ground and believe in what you wanted to do.

Going back to this confirmation reminds me when my daughter was with the Attorney General's office during the transition. She was the attaché for Doug Moylan. KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, desiring to become a limited liability company under and in accordance with the laws of Guam, and to obtain the benefits conferred by said laws upon limited liability companies, do hereby mutually agree upon and enter into the following Articles of Organization.

ARTICLE ONE

The name of the limited liability company shall be:

**DOWNTOWN PACIFIC VENTURES, LLC**

ARTICLE TWO

The limited liability company may carry on any lawful business whatsoever. Good morning Senator Dennis Rodriguez and members of the committee.

Thank you for the opportunity to offer testimony on behalf of Henry Taitano as the Executive Nominee for the Director Position of GEDA. I am here in the capacity of a business woman and as the mother of Joaquin Cook who has been friends with Henry since early elementary to the present. As a result of that friendship, I was able to get to know Henry. We all know how that works and what that experience brings to the familiarity of a person.
