Honorable Senator BJ Cruz,

Foremost it is an honor to be nominated to sit as a Board of Trustees for PBS Guam. I think this best way to bring my qualifications, interests, and character to light is to provide the following narrative: As a single parent, I raised my daughter in Guam and Seattle, during this time I received a BA in English, a Masters of Science Degree in Education Technology, and a Juris Doctorate. I returned to Guam and practiced for several years until I decided when my daughter became an adult, to pursue my passions in the Arts. In the last two in half years, the path of pursuing my passion in Arts has led me to this nomination.

Currently, I completing my second book, a sci-fi/fantasy Novel, the Editing component is completed (funded by Guam CAHA). Also, I am done with my first set of oil paintings, which I hope to have a full exhibit by early next year (see attached). And, I am working towards completing my first documentary I filmed in Washington State about the Village Concept experienced in Guam and its benefits on children and society. It is an effort that I am working on with the assistance of Guam PBS and UOG/MARC.

My efforts in putting this documentary together has guided me through the technical, academic, professional, administrative, and programmatic aspect of filming. As a result of this immersion, I have submitted two fellowship and one grant application earlier this year in partnership with PBS and UOG/MARC to the National Endowments of the Humanities to fund the pre-production of three different documentaries all related to Guam. It is my intent to submit one of the applications to two other funding opportunities this August.

In the process of writing for the fellowships and grants, I learned a great deal about the productions process PBS is engaged, the community and audience it serves, and the administrative structure in which PBS operates.

Perhaps most enlightening is my experience in Washington state filming, February of this year. I met young and old independent film producers. Seemingly, the trend is that independent producers are becoming more the norm because affordable technology has made the film industry more accessible. In my discussions with PBS workers in Seattle, their struggle is picking completed documentaries ready for viewing to sponsor and showcase because the submission from independent producers are frequent.

These independent producers helped me in providing feedback and insight to making films. These successful independent producers, to name a few, were store clerks, teachers, waiters, and blog writers who completed documentaries and films during their free time. Instead of PBS and local governments subsidizing six figure grants to create educational public films and productions, the trend was that independent producers were absorbing the small costs, work, and production and then seeking assistance for distribution of the film, with the exception of competing for large grants for large scale productions. I do believe Guam is ready for this dynamic.

On Guam, I have met students from GCC's visual and media high school program while discussing my efforts to create a documentary, and received assistance from their post-secondary program graduates. So from an institutional level, we are creating a base competency to harvest an active media and interactive social network community that PBS can engage like in other PBS affiliated areas.

I hope that my education and knowledge as a lawyer and teacher can help in developing PBS to be as competitive as other PBS affiliates. And to perhaps one day fulfill the implications of an observation made by an independent producer who commented to me: Guam PBS seems to have the best advantage, all around, in doing the documentaries and film productions of the Asia, Oceania, and Micronesia region more than any other PBS affiliate or learning broadcast company.


