

Mr. Antolin:

Good morning Senator, first of all pay my condolences to the Guam legislature of the loss of your colleague this morning. It's always hard to lose somebody who was a colleague that you worked with for the longest time but, I'm here this morning in support of the confirmation of Ms. Fe Ovalles to be a board member of the Guam Housing Corporation. I told your good staff I'll be bringing a written testimony this afternoon so I'll deliver it to your office, sorry about that. I've known Ms. Ovalles basically personally as far as my kababyan and professionally with her businesses, so I think it's a good added advantage with her background with finance and her business to be part of the Guam Housing Corporation. She'll be the second female on the board so that gives a bit of an advantage of having more gender representation on the board. I've known her for many years. We have worked together both in opposite sides and now on the same side and I enjoy her company and I welcome her presence and their business acumen and all of her experience put together. I do believe she'll be an asset. We've been waiting for the second female member for quite a while now. I'm just glad it's being filled by someone like Fe. So you know I support her and welcome

Si Yu'os Ma'ase Ms. Ovalles for the many years you have made Guam your home. Thank you for stepping up to the plate and volunteering because it truly is a labor of love. At this time, I'm going to go ahead and yield to the Vice Chair of this committee, Vice Speaker Cruz, for his comments or questions.

Vice Speaker Cruz

Thank you! I really have no questions. I've known Fe for more years than we'd both like to have meant but I'm very happy that the administration has recognized her value and to what she will be able to bring to the Guam Housing Corporation and the programs that they have so I'm very supportive of this nomination madam Chair.

Ms. Ovalles

Thank you Mr. Vice Speaker.

Senator Barnes:

Thank you Vice Speaker, Senator Chris Duenas?

Senator Duenas

In his opening remarks, Senator Duenas speaks in Chamorro. I am very happy for you today, Fe and I made a commitment today to myself to at least take part one, I call it "kada diha" to speak in Chamorro. It has always made me happy whenever I am in your presence, especially at meetings, when I hear you speak Chamorro and when I hear people around you speak Chamorro and you know the language and that's

something that is dear to me and to you personally. Other than that, as the Vice Speaker spoke about your capabilities, your business acumen, I think stands for itself. I was also very thrilled to hear your efforts and you just put it out there and your testimony that one of your key initiatives will be to concentrate on homes for veterans and those you know that category of our population that needs help as well. So, I just wanted to conclude by saying, you know Fe, the management team up there I'm sure you're aware is outstanding and in the next few months and the next few years to see a large cash infusion so I think the dynamics are going to be incredible continuously moving forward so you're on board for a very good ride. So I just wanted to close by saying I appreciate the Governor for your appointment and I look forward to your hard work and I look forward to voting on the affirmative of your confirmation. Si Yu'os Ma'ase madam Chair.

Senator Barnes

You're very welcome Senator Duenas. I will too disclose for the record that I've known Ms. Ovalles more than half the years that she's been here we go back to the early 80's. More importantly here is that you have stepped up to the plate and you did bring up something that was very promising as it relates to making sure that we have some way and some draw to work closely with the veterans. Is there any other thing that you could add to the plethora of things that Guam Housing Corporation offers right now that could be good for Guam Housing Corporation and the people of our island?

Ms. Ovalles

I believe it would be the physical state of the housing corporation. I believe if you are able to cut down your delinquencies and monitor that, that would be sure funding that will be used for other people that need homes. I am very vigilant on that having a business of my own on the collection business but aside from that, I would like also to pursue, if its allowed by our statue, to be able to link with the credit bureau and really look at the state of the financial of this person we're lending. For individuals not to be able to damage their names in terms of future lending activities, but I guess for them to be coached on how they should be able to handle their finances. I know there are counseling services that the housing corporation also provides that could be injected in to all of this just to make sure they know these are responsibilities. The government is helping them to have their first home but keeping their credits clean good and in a viable approach will be something that they themselves will enjoy. Probably in the long fall I always tell my children you have the bank as friends because when you get your
