I. OVERVIEW

The Committee on Municipal Affairs, Tourism, Housing and Historic Preservation convened a public hearing on Bill No. 108-33 (LS) on Wednesday, May 13, 2015 at 9:00 AM in I Liheslatura's Public Hearing Room.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 9:16 A.M.

Senator Tina Muna Barnes: We will quickly proceed to Bill No. 82-33 (COR). I have with us to speak is the chairperson from CAHA, Mrs. Monica Guzman; DOA Director Mr. Anthony Blaz; and also the chairman of the Board for GVB, Mr. Mark Baldyga. Bill No. 82-33 (COR) ladies and gentlemen is "An act to appropriate funds from the FY 2014 Fund Balance of the Tourist Attraction Fund for the payment of operational needs of the 2016 Festival of the Pacific Arts Activities, payments to the employees of the Government of Guam resulting from the enactment of the CWA, Competitive Wage Act, and to fund the balance of payments due to law enforcement officers." You are all listed both from the government and from the public corporation; and if I may just to give a history I'd like to ask your permission to yield to Senator Tony Blaz so he can give us a perspective from the Department of Administration side. So Senator Blaz if you could please proceed.

Senator Anthony C. Blaz: thank you Madam Chair and Senator Ada. Dångkolo Na Si Yu'os Ma'ase' for giving me this opportunity to comment on Bill 82-33; "An act to appropriate funds from the FY 2014 Fund Balance of the Tourist Attraction Fund for the payment of operational needs of the 2016 Festival of the Pacific Arts Activities, payments to the employees of the Government of Guam resulting from the enactment of the CWA, Competitive Wage Act, and to fund the balance of payments due to law enforcement officers." So madam chair I was going to ask to remove the competitive wage act because that's not the issue before us; only to pay the outstanding balances for the law enforcement officers for DOC and GPD for overtime and other personal needs like any court judgments that will come very soon; there's a hearing on Friday I believe for one of those issues.

Senator Tina Muna Barnes: when you say hearing, is that a public hearing or court hearing?

Senator Anthony Blaz: court hearing; just to verify the 43 hours for law enforcement officials.

Senator Tina Muna Barnes: So noted Senator Blaz and we'll make the appropriate amendments to that to concur with the statement from DOA.

Senator Anthony Blaz: reads his written testimony attached. Dångkolo Na Si Yu'os Ma'ase' and Senseramente, Madam Chair and Senator Ada.

Senator Tina Muna Barnes: Buen Prubuecho Senator Blaz. At this time I would like to go ahead and ask GVB to make their statement and then have the Chair of CAHA close.

Jon Nathan Denight: Thank you again Madam Chair and Honorable Senator Ada. Mr. Denight reads his written testimony which is attached.

Senator Tina Muna Barnes: Si Yu'os Ma'ase' Mr. Denight. Chairman Guzman.

Monica Guzman: Good morning Madam Chair, Senator Ada I'm Monica Guzman Chairperson for the Guam Council of Arts and Humanities and I am here today to support Bill No. 82. As you know hosting the Festival of Pacific Arts on Guam is going to be a massive effort that's going to require the entire island. Over the last few years we've had hundreds of volunteers who have been meeting to plan and coordinate the programming portion of the festival. Through funds from the Tourist Attraction Fund we've also been able to host many capacity building workshops in partnership with the Guam Visitors Bureau and CAHA, and these have been beneficial to our artists and our cultural practitioners. This year alone we're going to have five different workshops; last year we had four; the year before that we had three. What we're doing also for hosting the Guam, the Festival of Pacific Arts in 2016 is as part of the Guam Delegation, we are including a hundred and fifteen delegates from our Diaspora in the states. We have a committee in California and spread over the continental U.S. that are doing outreach to ensure that we reach as many of our artists and cultural practitioners that are living overseas. We feel that this is a very unique opportunity to bring our Diaspora home to participate in this because we are one Chamorro people. I understand the concerns raised by the previous speaker, but what the Festival of Pacific Arts will bring to Guam is it will; it's a format and a venue to really bring together our artists and our cultural practitioners to enhance what is so unique about Guam; and what is unique about Guam is what the Guam Visitors Bureau will be able to market overseas to encourage more visitors to Guam and that is our culture; our arts and our culture and I'd like to thank the Guam Visitors Bureau for putting culture as one of their points; as one of their priorities in the 20/20 tourism plan and because of that and the partnership that GVB and CAHA has had over the years, we're fully in support of this appropriation and if I may it says here on the Bill that it's for \$2 million for the festival. If there's any opportunity to increase that, maybe another million or so, we would really appreciate it. Thank you very much.

Senator Tina Muna Barnes: Si Yu'os Ma'ase' Madam Chair and bringing that to light for additional funding; maybe if you can just explain to the committee and to the listening audience out there, the whole invitation and what Guam did not just this term; how many years ago did Guam seek to host this event; who are we expecting; how many people; and what is the total bill for this that Guam will have to pay host this very, very enormous event to showcase Guam.

Monica Guzman: Thank you very much Madam Chair. In 2008 the Governor along with the Executive Director of CAHA made a proposal and bid to host the festival in American Samoa and at that time the Governor actually flew and attended the Council of Pacific Arts and Culture meeting to make the pitch to host the festival here. There'll be twenty seven pacific island countries and territories that have been invited to participate. Governor Calvo sent the letter of invitation out to all of these countries in March. We anticipate all of them coming to Guam from as far away as Easter Island, down south to Papua New Guinea and Palau. It'll be a two week festival, May 22 to June 4th 2016. We estimate approximately 2500 delegates will be coming to Guam which we will host, accommodate, and feed for the two week period and we estimate an initial budget of \$13 million dollars to successfully host this festival. Of that \$13 million dollars, we anticipate \$2 million dollars to be raised privately; \$5 million dollars of government appropriations and the \$6 million dollar balance will be mostly in-kind products and services. So I know that the Festival Director now, Rose Ramsey is looking into the details of the budgets and trying to fine tune that a little bit more, but we estimate about \$13 million dollars and hopefully it will not cost that much.

Senator Tina Muna Barnes: but we need to secure the \$13 million dollars.

Monica Guzman: in cash and in-kind, yes. Our Corporate Business Community has been very supportive of this effort in reaching out to them; they have come forth, but there's still more that needs to be done in the next year. It's probably three hundred and ninety some days before opening ceremonies.

Senator Tine Muna Barnes: And the Chairman of the event is?

Monica Guzman: Yours truly Mr. Nathan Denight, is the Chairperson for the Festival of Pacific Arts, Coordinating Committee.

Senator Tina Muna Barnes: Mr. Denight, or Mr. Chair, would you like to add to that?

Jon Nathan Denight: As the newly appointed Chairperson of the Organizing Committee I would just like to say of the Festival of Pacific Arts, one of the real benefits I see is our local community, all the artisans and cultural practitioners are preparing for this major event so for the last four years we prepared for the 2012 Festival of Pacific Arts in the Solomon Islands, but since then our people have been preparing from all the different disciplines from the dancing and performing arts to the crafts people; carvers, weavers. What this is really doing is building our cultural plant, factory, where people are really going back and looking at ancient traditions that haven't been necessarily promoted or practiced. A good example, I know Joe Quinata and Ruby Santos they are working on the Bilabatuyan and they have recruited about a hundred people to participate and learn the instrument, so these are people from all walks of life, not just Chamorros but young people, the elderly, native Chamorros. Everyone is trying to learn this instrument so I'm looking forward to the opening ceremonies and seeing them, the hundred people perform an instrument that is very cultural that we see hanging on the walls at many places but you never get to see anyone play it. These are things I think are important and because everyone is practicing and getting better, and working on these traditions, there's going to be more knowledge spread to the community which means that they'll be able to offer these traditions and practices not just to our local community but to our visitors as well. So we'll just have more people practicing our culture, encouraging them to practice our culture leading up to this major event; so it's kind of like when you have the Olympics, there's all the teams, just like Japan, everyone on the swimming teams, all the different teams cause in 2020 they'll host the Olympics, they want to have a good showing. They're all practicing; everyone is working hard to have a good showing as the host country. So for Guam FestPac is that same initiative where culture is at the top of everyone's mind; and for example our Master Blacksmith, Frank Lizama, I'm very good friends with his son, he cuts my hair, and I went over to his house and they have about thirty people coming three times a week, young people, elderly people, from all walks of life learning how to blacksmith; with the passing of our Master Blacksmith, Mr. Lujan it's important to see these traditions passed on from generation to generation, or else they get lost so I think that's the real importance of having this event here; is really getting everyone really excited and ready for the event, is going to be one of the real long lasting effects. So even after the festival, the festival is two weeks, but I think the effect afterwards is where we're going to see real benefits. Speaking from the tourism aspect we've been promoting this event for the last four years. We have the flyer and different promotional materials online translated in to eight different languages, including Russian. So, we're expecting to see those visitors

come and experience our Guam culture and then all the other cultures of the pacific; and the other major event is all the PR, the public relations and the media exposure; so hosting these major events like the Olympics, the real benefit is all the PR, all the media focused, and attention on Guam because of us hosting this major event. So I think it's going to really solidify our position as the hub of Micronesia and a great opportunity for our Micronesian brothers and sisters. Many of them couldn't afford to go to the Solomon Islands because of the cost; and so the CNMI is asking for even to send an extra hundred from what they're allotted, an extra hundred delegates so just really building up our Micronesian culture and supporting our the other islands and giving them an opportunity to participate in FestPac is a real benefit; and then you know showcasing Guam against our other island brothers and sisters, but it's still a friendly competition against Hawaii, Samoa, and Tahiti; you know they're our brothers and sisters but under tourism they're our competing destination. I would like to invite them to our home town and show them our culture and kind of show off a little bit what we can do right here on Guam and expose our culture and put it up against all these other pacific island cultures, which are quite frankly, more well known than our culture. It's just a great opportunity. I guess I keep rambling, so you can tell how passionate I am about the event; and so thankful for Monica, and Senator, Madam Speaker, and Vice Speaker Cruz, Governor Calvo and everyone who's been involved in promoting this event for many years because this is 2008; it's going to be eight years in the planning and making so you can see how major this event is; and the private community for supporting the event and I think it's really showcasing and you can see the amount of resources we're putting into it, but that really showcases how serious and committed we are to promoting the Chamorro culture. So thank you very much for allowing me to speak a little bit.

Senator Tina Muna Barnes: Thank you Mr. Denight; I do want to note that you did hit a solid button there and talked about the Olympics and how this is the Olympics of the arts and culture and traditions; and how though the similarities in the traditions and being able to collaborate and share that. Madam Chairwoman for CAHA I would like to ask you of the 27 country nations that will be here, you noted that there are 2,700 delegates right?

Monica Guzman: Approximately 2,500 to 3,000 delegates.

Senator Tina Muna Barnes: So how many additional tourists or followers of this Festival of the Arts will it bring from around the world; how many additional tourist or participants, or how many will come to this attraction or what's being followed?

Monica Guzman: In Previous festivals, they have said that there are as many as ten thousand additional people that go to the festival; you're talking family and friends.

Over the last four years just on the festival website there's been inquiries from as far away as Peru, from Germany, from Europe of course all over the United States, and throughout the South Pacific. There are people going on to the website saying I want to come to Guam, what hotel, where can we stay, where are your venues? So of course all of those requests we have been forwarding to the Guam Visitors Bureau. I'd like to just add Madam Chair that this week we have two visitors from the Secretariat of the Pacific Community that are here to meet with the different committees. This afternoon they will be attending the FestPac Coordinating Committee meeting at 2:00 p.m. Over the week they've been meeting with the various programming sub-committees; and they had scheduled to come here because of the Guam Micronesia Island Fair as the kick off and countdown launch. Unfortunately they will not be able to come back for the rescheduled date but they're here and they're very excited. They've been doing the site tours and doing all the courtesy calls that they need to do with our leadership and they are impressed with what we've done so far; and I know that Nathan and the Festival Director had a briefing with them yesterday so a lot of work has been done and a lot more work will continue to be done over the next twelve months.

Senator Tina Muna Barnes: Thank you and I know it's fast approaching because you said it; it is from May 22nd to June 4th 2016 am I right? One more question if I may and it's a financial question because I know that we've been talking numbers and as you know resources is the most vital thing in order to make a successful event you're going to need the money to be able to host this enormous event and I want to say you spoke about the \$13 million dollar figure and I want to make sure that we're right. I want to ask how much do we have so far? I know we have this pending bill, how much more are we going to need because it's very crucial; you talked about the private corporations and the vendors coming in to assist, but really from the governments perspective how much more are we going to need? And you talked about the readjustments from the Festival Director, how soon will those new solid numbers come in before the fiscal year and for the event?

Monica Guzman: Thank you Madam Chair, the revised budgets will probably be; I would imagine that the Festival Director will complete it within the next 30 to 60 days.

Senator Tina Muna Barnes: We'll need it a little bit sooner because we have this Bill on the agenda.

Monica Guzman: Okay. I know that in the Trust Account we have \$2.6 million; and that's how much we have in the operations account at CAHA; there's a little under \$200 thousand so we're still a long ways from our goal.

Jon Nathan Denight-I think the projected goal is \$6 million total cash.

Joseph Cameron: notwithstanding the fact that we do have some generous donors from the private industry, there were some cash payouts to CAHA over a period of time leading up to the festival. So we're looking at \$3.1 million cash right now notwithstanding any other monies that needs to come in.

Senator Tina Muna Barnes: That would include the 1% set aside that we had from the Arts?

Joseph Cameron: No that would be additional. Thank you.

Senator Tina Muna Barnes: Thank you, so we still need the cash from the government to host, and the total is at \$6 million cash and \$7 million will be the in-kind.

Monica Guzman: Yes, thank you; and so the request to increase that appropriation from \$2 to \$3 would be greatly appreciated. Also, if I might add, we are 374 days, 12 hours, and 35 minutes until FestPac.

Senator Tina Muna Barnes: Fast-coming; so Madam Chairperson for CAHA, I truly appreciate it, and to the panel members here thank you very much; As Oversight Chair of Tourism, I find it very important to make sure that these two critical Bills, we'll try and get on the May agenda. I do know that the committee will look at the necessary substitutions and the numbers; the prerequisites that will be needed so that we have a full deliberation when we try to get It on the floor for the May session. So our committee will be calling for the additional numbers to make sure. We thank you for being here today and we know that this event is fast-coming and I do know that the

resources we have out there are tight, if not very scarce and I know that Guam has an obligation to host this event, but also to preserve and protect our community; and I know with the judgments that you stated, that some of these Bills for law enforcement, as they continue to protect our community, have to be addressed. Thank you very much. I will call this Public Hearing on the two appointees for Ms. Craft and Mrs.

Calvo; and the two Bills; Bills 82 and 83 publicly heard, and we adjourn this at 11:27 a.m. Si Yu'os Ma'ase', Si Yu'os Un Binendisi. Yes, Biba Fest Pac Senator Blaz. Thank you.

The public hearing was adjourned at 11:27 A.M.
