The Committee on Municipal Affairs, Tourism, Housing and Historic Preservation convened a public hearing on Bill No. 110-33 (LS) on Wednesday, May 13, 2015 at 9:00 AM in I Liheslatura's Public Hearing Room.

II. SUMMARY OF TESTIMONY & DISCUSSION The public hearing was Called-to-Order at 9:16 A.M.

Chairperson - The Committee on Tourism, Municipal Affairs, Tourism and Housing is back from recess and we have two more items on the agenda which is Bill No. 82-33

(COR) "An act to appropriate funds from the FY 2014 fund balance of the tourist attraction fund for the payment of operational needs of the 2016 Festival of the Pacific Arts activities, payments to the employees of the government of Guam resulting from the enactment of the competitive wage act, and to fund the balance of payments due to law enforcement officers" and Bill No. 83-33 (COR) "An act to appropriate funds from the FY 2014 Hotel Occupancy Tax (HOT) surplus fund for the payment of capital needs of the Guam Memorial Hospital Authority, operational funding for the Guam Visitors Bureau, and funding requirements for the Hagatna Restoration and Redevelopment Authority". I have Dr. Lizama here and staff from the radiology department and they have other appointments to go to so if it's okay, I'd like to hear Bill 83-33 (COR) first. Dr. Lizama you may proceed.

Dr. Lizama - Thank you Senator Barnes and Senator Ada. Thank you for the opportunity to be before the committee on Bill 83-33. GMHA surely faces financial challenges and other challenges with a new hospital coming up soon would affect the way we live or care for the people of Guam. Certainly this bill addresses some of our concerns with regards to upgrading our equipment at the hospital that will meet the needs of all the people of Guam as GMH remains the community hospital for the whole community. The bill addresses the use of the surplus of the HOT in the amount of 1.6 million dollars for purchase of a catscan unit. That equipment has been around for many years and has sure undergone some major repairs issues. We have been down for providing this service and has impacted patient care. For the past couple of years we have almost spent 500 to almost a million dollars in repairs. This unit has met its lifetime span and the breakdown of various parts of the equipment has affected its reliability. Part of our capital needs has been addressed is getting a catscan unit. It is very much appreciated in this bill. I do want to point out at this time, I have hired three new radiologist at the hospital. We are looking at hiring in-house staff support. With that we are expanding service and offering better support for the needs of the community so that in this point of time we are focusing in providing full support instead of risking the needs or sending patients out to the community to get the support that we don't have. I have Dr. Senthil to my right who is an interventional radiologist, Dr. Miller to my left who is also an interventional radiologist. The opportunity for new service is very exciting Senators and I want to share this because it is really critical. Two weeks prior to my doctors coming on island we had a young person who suffered a subarachnoid hemorrhage that on Guam prior to this last month or two would have been a terminal event because it requires immediate transport to a facility to stop the bleeding. We were able to provide that service on Guam so that person has been

undergoing rehabilitation. I'm sure you've all heard about aneurism some people have suffered. With the upgrade on our catscan machine our specialists would be able to help our people on Guam. This upgrade would help our staff to help better our community and the people of Guam. I did speak with you Senator as we introducing new service with the capability of the new catscan unit, we may also need new supplies to support my 3 new interventional radiologists. We are very grateful for the consideration. With that I close my testimony.

Chairperson – Thank you Dr. Lizama and I appreciate your testimony. This legislation talks about the purchase of the catscan machine and you're also talking about purchasing new equipment. Do you have a breakdown of the materials that you need or the scope of the 1.6 million needed? I am appreciative of the radiologist team that is here before me and I want to make sure that we are going to do this, let's do it right. I can always work with the oversight on health if you'd like.

Dr. Lizama – This bill is to purchase the catscan and the additional equipment is what I'm asking this body to assist GMH in purchasing the new equipment to help my doctors provide that service to the people of Guam.

Chairperson – What I will do is work closely with you and my staff to delineate in further detail on how we can accomplish that so that when we get this legislation on the floor we don't mix apples and oranges. I just wanted to make sure that I stated that for the record.

Dr. Lizama – I will be submitting those new services that we are hoping to provide with that new catscan upgrade. So, Senator is that ok?

Chairperson – Yes, of course. Let me just start with whomever.

Mark Miller – I recently arrived on Guam but I've been here before. I'm looking forward to participating in the expansion of the department and its services. There have been two revolutions with CT scanners. The new scanners now can look at one person from the head to the bottom of their abdomen. That was just never possible. With the new services you can see things that would normally require an interventional radiologist. Just as an example, my brother went to the University of Pittsburgh on December 23rd and he died on December 24th. He was sent out from the hospital for chest pain and that's common here on Guam. With this scanner you could actually see

the coronary arteries. This machine is not like the CT we have now. It's really a new world of medicine compared to what we have now. I couldn't be more ecstatic about it and it's going to be a good thing for your health. Thank you!

Chairperson – Thank you! Dr Senthil, please proceed.

Dr. Senthil – Thank you Senators, please excuse me because I just came out of surgery. I started at the hospital in February. As Dr. Lizama and Dr. Miller were saying, this scanner is going to be very useful in advancing to what we could do in radiology. It can pick up diseases of the coronary and other parts of the heart, non-invasively. If the findings from the scan are found negative, it could help them to avoid unnecessary procedures. It could be helpful both ways. Aside from the coronary issues that Dr. Lizama stated, this catscan can pick up those bleeds and avoid from having to undergo surgery. In the long run it helps the patient and the hospital, by cutting down costs and avoiding invasive surgery. Thank you!

Tom Greening – I am the manager of the Radiology department. The scanner that we got installed from the Navy is called a 16 slice scanner. Our main workhorse right now is a 64 slice scanner and the life expectancy of any radiation producing machine is 5-6 years and maybe 7 at the most. Our 64 slice is pushing 10 years and in the past 2 years, we spent almost half a million dollars putting new parts in it. That's why they say to trade them off or get new ones every 5-6 years. We are doing things now at GMH that we couldn't do 2 years ago. We would like to do more than what we're doing now. Dr. Lizama would like to expand our services to help our patients. We help out our cardiologists, the ones from Modesto when they come and then we order special supplies for that. We would like to do more. As Senator Cruz said that he's getting to that age and stage when he's gonna need our services and of course we'll be there, but we need your help. We need more money and some more equipment to help take care of you. Thank you!

Chairperson – If there are no other comments, I would like to thank all of you for your testimonies and dismiss this panel. I will ask you to stay as long as you can, but if you have to leave, you may. At this time, for Bill 83, we also have Jon Nathan Denight, Mr. Cameron, and former Senator Al Ysrael, Mr. Baldyga, please come up.

Mark Baldyga – Hafa adai Madam Chair and Senator Ada. I'd like to just say thank you for all your assistance for tourism, first of all. The board's position is merely the same

as Mr. Denight's so just to mirror our support for both bills 82 & 83, we are in support of both and we appreciate your support for us as well.

Jon Nathan Denight – Before I speak, just want to let you know that our long time receptionist, Ms. Emily Quinata was taken to GMH and hopefully Dr. Lizama and his team will be able to help her. Our thoughts and prayers are with her, she has been with GVB for more than 20 years. Mr. Denight reads his written testimony, which is attached. Again thank you and un dangkulo na si yu'os ma'ase for your support to the Guam Visitors Bureau. Thank you Madam Chair!

Chairperson – Senator Ysrael.

Alfred Ysrael – Thank you Madam Chair. I come here with a very heavy heart. Mr. Ysrael reads his written testimony, which is attached. Mr. Ysrael is not in support of this bill as well as bill 82-33.

Chairperson - Thank you Senator Ysrael. Mr. Cameron?

Joseph Cameron – Before I read on, Madam Chair, I can't help but agree with Uncle Al here about bond proceeds. But to let you know that there was a law for the HRRA for getting taxes, but a lot of that money was taken over to DOE. For us not having our golden egg, we are reaching out. Mr. Cameron reads his written testimony, which is attached. The HRRA thanks the authors of bills 82 & 83.

Chairperson – Thank you everyone for your testimony and I will dismiss this panel now and continue with bill 82.

It will drum up excitement as we lead into the festivities for the Festival of Pacific Arts.



Buenas yan Håfa Adai. Unfortunately, the HRRA is unable to provide a complete testimony regarding Bill 83-33 (COR) as it is the Board of Commissioner's policy to seek board approval prior to testimony submittal. Nonetheless, the HRRA welcomes this funding opportunity to help the development of our Capital City of Hagåtña.

The HRRA had already prioritized projects should funds become available to stimulate economic development opportunities within specified Hagatña areas of particular concern. Additionally, since 2011, HRRA has been in consultation with the U.S. Army Corps of Engineer (USACE)-Honolulu District on developing the Hagåtña River Basin. Since the 1945 Hagåtña River diversion and improper channeling to its present location and the 1976 imposition of the National Flood Insurance Program (NFIP) on Guam, lowlying areas, specifically, the City of Hagåtña stagnated. The NFIP made it difficult for residences and businesses to construct and stimulate any type of economic development due to higher construction and the annual flood insurance costs. Therefore, in order for the Hagåtña River channeling to occur, an updated Hydrologic Feasibility Study be conducted to determine the best management practices (BMP), the courses of action (COA), and the funding necessary for the selected COA. This will determine the funds required to design, ultimately channelize the river, and protect the Hagåtña area from inland flooding opening development opportunities.

The HRRA through GEDA contracted the Matrix Design Group to provide for a Hagåtña Masterplan with options for providing sustainable development district plans. District plans are short-range (five (5) to six (6) years) multi-topic plans that consider only a portion of a jurisdiction such as the "Hagatña Capital & Cultural District"; "Paseo Planned Development District"; "Hagatha River District"; the "Adelup Redevelopment Area" to name a few. District plans are detailed plans than long-range general plans. These district plans guide specific implementing programs along with its funding recommendations for supportable, manageable growth, such as zoning ordinances, capital improvement, and economic development programs. These plans stimulate economic

Lastly, as part of HRRA's restoration and redevelopment efforts to provide a sense of place, reinvigorating annual activities that stimulate cultural, social, and economic benefits to Guam and the city of Hagåtña would serve as an incentive for investment and renaissance opportunities. Reviving the May Fair, the Agricultural Expo, Barrio Fiestas, the Cultural Sporting Micronesia Challenge Cup (Carabao Races, Kåcha-Kamyu; Coconut Tree Climbing; Talaya; Acho Atupat; Batu; Canoe Races); the Liberation Carnival, First Tier Athletic events, Musical Concerts, etc... would serve this end.


