# COMMITTEE REPORT DIGEST

# I. OVERVIEW

Bill 112-33 (COR) was introduced on June 1, 2015 by Vice-Speaker Benjamin J.F. Cruz and was subsequently referred on June 1, 2015 by the Committee on Rules to the Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement.

The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement convened a public hearing on June 26, 2015 at 1:00 pm in *I Liheslaturan Guahan* Public Hearing Room to receive public testimony on Bill No. 112-33 (COR).

## **Public Notice Requirements**

Public Hearing notices were disseminated via email to all senators and all main media broadcasting outlets on June 19, 2015 (5-Day Notice) and again on June 24, 2015 (48-Hour Notice).

The public hearing was Called-to-Order at 1:00pm.

## **II.** SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Ada called the Public Hearing to order and yields to the sponsor to give an introduction of the bill.

**Vice-Speaker Cruz**: He started by saying that Bill No. 112 finalizes the land purchase of the Tuncap family from the Department of Public Works and Department of Land Management. For close to twenty years, the agencies couldn't transfer the land over because the transaction was completed after the time period required in Public Law 21-14.

Chairperson Ada continues by calling those who have signed up to give testimony.

**Michael Borja**, *Director*, *DLM* (written testimony): Mr. Borja reads his testimony in favor of the bill.

Chairperson Ada ends the public hearing for Bill No. 112-33 (COR).

#### **III. FINDINGS AND RECOMMENDATIONS**

The Committee on Transportation, Infrastructure, Land, Border Protection, Veterans' Affairs and Procurement hereby reports out **Bill 112-33 (COR) as introduced**, with the recommendation to report out.

# AN ACT TO AMEND SECTION 3(b) AND SECTION 9(a) OF PUBLIC LAW 21-14 RELATIVE TO AUTHORIZING THE MAGA'LAHEN GUAHAN TO SELL LOT NO. B, TRACT 111 LOCATED IN THE MUNICIPALITY OF TAMUNING.

**BE IT ENACTED BY THE PEOPLE OF GUAM:** 

Section . Legislative Findings and Intent. *1 Liheslaturan Guåhan* finds that
twenty-three (23) years ago, Public Law 21-14 was enacted that provided for
numerous land transactions, including the sale of Lot No. B, Tract 111 in the
Municipality of Tamuning to owners of the property adjacent to Lot No. B, Tract
111, David D. and Dolores R. Tuncap.

7 I Liheslaturan Guåhan further finds that when Public Law 21-14 was passed into law, the Tuncap family began the proceedings for the conveyance and 8 9 purchase of Lot No. B, Tract 111, which included the requirement pursuant to 10Public Law 21-14 to acquire two (2) appraisals. The Tuncap family acquired two 11 (2) appraisals in 1993. As of this date, the Tuncap family has finally paid in full the purchase price of Lot No. B, Tract 111 based on the appraisals that were done in 12 13 1993 and has requested the Department of Land Management to file a Quitclaim Deed to finalize the purchase of Lot No. B. Tract 111. 14

15 Section 9 of Public Law 21-14 delineates the provisions in which an 16 appraisal must be completed as "no earlier than six (6) months prior to the date of 17 conveyance or exchange of the parcels". This would deem the two (2) appraisals 18 done in 1993 stale.

*I Liheslaturan Guåhan* believes that the Tuncap family acquired the two (2)
 required appraisals in good faith and therefore *I Liheslaturan Guåhan* intends to
 amend Section 3(b) and Section 9(a) of Public Law 21-14 to allow the two (2)
 appraisals that were completed in 1993 to be used as the sale price determination
 so they can finally purchase and request approval for a Quitclaim Deed for Lot No.
 B, Tract 111.

# 7 Section 2. Section 3(b) of Public Law 21-14 is hereby amended to read 8 as follows:

9 "(b) In addition, the Governor shall sell Lot No. b, Tract 111, to the 10 landowners whose lands abut such Lot No. B on the northern, ocean side of Lot 11 No. B, such sale to be a series of sales to each such owner whose land so abuts Lot 12 No. B on its northern side, of that portion of Lot No. B immediately adjacent to 13 such owner's property, at such parcel's fair market value at the time of the sale 14 utilizing the two (2) appraisals conducted in 1993 for fair market value of the 15 property."

# 16 Section 3. Section 9(a) of Public Law 21-14 is hereby amended to read as

17 follows:

"Section 9. (a) The land sales and exchanges described in Sections 2, 3, 4, 5,
6, 7, and 8 of this Act shall all be subject to the following provisions to determine
the current fair market value of a parcel, with the exception of Section 3(b) of this
Act.

Section 4. Effective Date. This Act *shall* take effect upon its enactment.

Section 5. Severability. *If* any provision of this Act or its application to any person or circumstance is held invalid, the invalidity *shall not* affect other provisions or applications of this Act which can be given effect without the invalid provision or application and to this end the provisions of this Act is severable.



Buenas yan Hafa Adai! The Department of Land Management supports Bill No. 112-33 which amends P.L. 21-14 that authorized David and Dolores Tuncap to purchase Lot No. B, Tract 111, which is adjacent to their existing property in Tamuning. Because the period of time taken to complete requirements of P.L. 21-14 had expired, the Department of Land Management was unable to finalize the land sale and issue a Quitclaim Deed. This bill modifies the law to permit the closure of this land sale.

The Department of Land Management also coordinated with the Department of Public Works, Rights of Way Division, to ensure the land purchased by the Tuncaps is not part of the land needed for the expansion of Ypao Road. This lot is not required for the road development. Additionally, the Tuncaps have paid in full the amount identified by the appraisals. We, therefore, ask that this bill be favorably reported out of committee and passed by this Legislature.
