COMMITTEE REPORT DIGEST

Bill No. 114-33 (COR), As Introduced – J.T. Won Pat, Ed.D. / B.J.F. Cruz – "An act to *amend* Section 1(x)(2), Chapter V of Public Law 32-181, relative to appropriating additional funds for equipment, supplies, and capital outlay for the Guam Museum."

I. OVERVIEW

Bill No. 114-33 (COR) was introduced by Speaker Judith T. Won Pat, Ed.D. and Vice Speaker Benjamin J.F. Cruz on June 2, 2015, and subsequently referred to the **Committee on Appropriations and Adjudication** on June 3, 2015.

The Committee on Appropriations and Adjudication convened a public hearing on Friday, June 12, 2015, beginning at 1:30PM in the Guam Legislature Public Hearing Room. The hearing for Bill No. 114-33 (COR) began at 1:54PM and ended at 2:02PM.

II. TESTIMONY & DISCUSSION

Chairman Benjamin J.F. Cruz announced Bill No. 114-33 (COR), and allowed the main sponsor of the legislation to give a few remarks.

Speaker Judith T. Won Pat, Ed.D. thanked Chairman Cruz and proceeded to provide her sponsor statement:

"The sum of Seven Hundred And Fifty Thousand Dollars (\$750,000) will be transferred from the Hotel Occupancy Tax (HOT) Surplus Funds to the Guam Museum Fund and is hereby appropriated from the Guam Museum Fund to the Department of Chamorro Affairs (DCA) for the sole purpose of funding the Guam Museum equipment, supplies, and capital outlay expenditures and I would like to thank Vice Speaker Cruz for co-sponsoring this.

"When I first took on [being] the oversight chair for [cultural affairs], I decided to go out and visit all my departments and agencies—the Guam Museum staff, [Guam Council on the Arts & Humanities] (CAHA), the [Guam Public] Library [System], DCA—just to get an idea of each department's [status]. One of the things that I have learned [is] the fact that there is some unforeseen delay in the building of the Museum and the need to now put an additional twenty (20) more pilings. Whatever funds were set aside for the Museum have already been expended. There are, however—1 broke it down, and Seven Hundred Fifty [Thousand Dollars] (\$750,000) is a far cry from what is really needed.

"The theater itself for stage lights, projection system and sound system, which is really estimated at Five Hundred Thousand Dollars (\$500,000). I know what DCA did was see if they could really do this by making some cuts and try to live within their means and have [that amount] then reduced to Four Hundred Sixty [Thousand Dollars] (\$460,000). Then there's the Museum store-and that's for the air conditioning, lights, flooring, finishing, computer data outlets-and of course it is critical to any museum if it is going to continue to generate any funds to helping to finance its costs and the opening, of course, of the museum and that is [estimated at] Two Hundred Fifty Thousand Dollars (\$250,000) reduced to Two Hundred [Thousand Dollars] (\$200,000). And then there's the curatorial work and area provisions—which are lighting, cold room, plumbing, design fee for revisions-and that's at Ninety-Eight Thousand Dollars (\$98,000). The specialty items-such as storage shelving for artifacts, the multi-room tables and chairs, the curatorial tables-comes out to Seventy-Six Thousand Dollars (\$76,000). Media production [includes] items for exhibit [that are] not in the contract-this is like a five (5) -day traveling exhibit-that's at Two Hundred Eighty Thousand Dollars (\$280,000). Then additional [Architectural and Engineering] (A&E) fees for the exhibit, the amendments, of course – [the second and fourth] amendments-extension, travel, extended services during construction, and the curatorial revisions fees, and you know all of that. About Ninety-Five Thousand [Dollars] (\$95,000) for Amendments 2 and 4; amended services during construction, Ninety Thousand [Dollars] (\$90,000); and the curatorial revisions fee, Nineteen Thousand [Dollars] (\$19,000). (The Speaker's cost breakdown of remaining capital outlay requirements is appended to this report.)

"What that all came up to was One Million Three Hundred Thousand Dollars (\$1,300,000), which is definitely very short when you think about Seven Hundred Fifty Thousand Dollars (\$750,000) and to meet the existing monies the Guam Museum is going to need to be fully operational—and everybody is [expecting] the museum to open up next year. And my fear is that we are going to have a museum minus the theater, the museum stores, the areas for shelving for

artifacts, and other needs to fully open a Guam and Chamorro Educational Facility. So I hope, of course, eventually our colleagues would see the need for this particular bill to support the Guam Museum."

Chairman Cruz asked Speaker Won Pat to provide the cost breakdown to the Committee to be included as part of the record, and recognized the sole individual present to provide testimony, DCA President Joseph A. Cameron.

Mr. Joseph A. Cameron greeted Chairman Cruz and Speaker Won Pat, provided written testimony (*appended to this report*) in support of the legislation in his capacity as President of the Department of Chamorro Affairs, and stated that his written testimony includes information relative to the equipment, supplies and capital outlay that the bill proposes to fund. He noted that his figures, which he had discussed with the museum designer, are slightly different but the costs total \$750,000.

Chairman Cruz reviewed Mr. Cameron's written testimony and read the figures:

"All right, we know that the testimony provided by DCA of Four Hundred Eighty Thousand [Dollars] (\$480,000) for the theater, Two Hundred Twenty [Thousand Dollars] (\$220,000) for the museum, and Forty Thousand [Dollars] (\$40,000) for the repository and allotted artifacts in storage, and Ten Thousand [Dollars] (\$10,000) for the curatorial furniture, coincidentally equaling Seven Hundred Fifty Thousand Dollars (\$750,000)."

Speaker Won Pat thanked Mr. Cameron and added:

"[Mr. Cameron and I] have had many conversations about this and I know [DCA] is definitely trying to live within its means. I know Mr. Cameron has reached out to the community to really help the Museum and make sure that we really don't have a museum that is partially empty-without office furniture for staff – but there are just very specific equipment needed for the museum versus administrative furniture. That's what this bill is all about: it's about being able to [get critical equipment], not [how] to address the administrative furniture. And there was also a discussion during [session] when they were throwing this number of Five Hundred Fifty-Two Thousand Dollars (\$552,000) that was appropriated to the Museum but the information was not totally accurate because that money was specifically for positions-and they were even for part time [positions] at half of a salary – for individuals to be hired and trained prior to the opening of the Museum. So the Five Hundred Fifty-Two Thousand Dollars (\$552,000) that was appropriated is not for the theater, the store, the repository and the curatorial furniture. [It is] strictly for personnel and I think that it's important that everyone understands that."

On account that there were no other individuals present to testify, Chairman Cruz

considered Bill No. 114-33 (COR) heard.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Appropriations and Adjudication to which was referred Bill No. 114-33 (COR) - J.T. Won Pat, Ed.D. / B.J.F. Cruz – "An act to amend Section 1(x)(2), Chapter V of Public Law 32-181, relative to appropriating additional funds for equipment, supplies, and capital outlay for the Guam Museum" hereby submits these findings to *I Mina'trentai Tres na Libeslaturan Guåhan* and reports out Bill No. 114-33 (COR), As Introduced, with a recommendation TO \underline{DDDS} .

"(2) Appropriation to the Guam Museum Fund. The sum of Five 4 Hundred Fifty Two Thousand Two Hundred Fifty Seven Dollars (\$552,257) shall 5 be allocated from the Tourist Attraction Fund appropriation in Subsection (x)(1) to 6 the Guam Museum Fund for the sole purpose of funding the Guam Museum 7 operations pursuant to § 87136(h), Chapter 87, Title 5 GCA and the sum of Seven 8 Hundred Fifty Thousand Dollars (\$750,000)shall be transferred from the Hotel 9 Occupancy Tax (HOT) Surplus Fund to the Guam Museum Fund and is hereby 10 appropriated from the Guam Museum Fund to the Department of Chamorro Affairs 11 for the sole purpose of funding Guam Museum equipment, supplies, and capital 12 outlay expenditures. Notwithstanding the general provisions of §30107.1 of 13 Chapter 30 of Title 11 GCA and this Act, theis allocation in this Subsectionshall 14 continue to be available until expended and is *not* subject to transfer or use for any 15 other purpose. Notwithstanding any other provision of law, the appropriation from 16 the Guam Museum Fund to the Department of Chamorro Affairs in this 17

<u>Subsectionshall continue to be available until expended and is not subject to</u>
 transfer or use for any other purpose."

3 Section 2.Effective Date. This Act *shall* become effective upon enactment.

4 Section 3.Severability. *If* any provision of this Act or its application to any 5 person or circumstance is held invalid, the invalidity *shall not* affect other 6 provisions or applications of this Act which can be given effect without the invalid 7 provision or application and to this end the provisions of this Act is severable.

Bureau of Budget and Management Research Comments on Bill No. 114-33 (COR)

The proposed legislation seeks to amend Section 1(x)(2), Chapter V of Public Law 32-181, relative to appropriating additional funds for equipment, supplies, and capital outlay for the Guam Museum.

The intent of the proposed legislation is to add the sum of \$750,000 to be transferred from the Hotel Occupancy Tax (HOT) Surplus Fund to the Guam Museum Fund, where the funds are appropriated from the Guam Museum Fund to the Department of Chamorro Affairs (DCA). This funding will entail the DCA to procure for the Guam Museum the needed equipment, supplies, and capital outlay to fill the newly built facility.

It should be noted that there are three (3) other proposed measures making appropriations from the HOT Surplus Fund. Legislative Bill No. 83-33 (COR) intends to appropriate to the Guam Memorial Hospital Authority (\$1,600,000); Bill No. 109-33 (LS) to the Guam Visitors Bureau (\$900,000); and Bill No. 110-33 (LS) to the Hagåtña Restoration and Redevelopment Authority (HRRA) under the Department of Chamorro Affairs (\$300,000). These Bills have all been passed by the Guam Legislature as of May 29, 2015. Considering these other proposed appropriations, there remains a balance of \$700,000 and leaves an unfunded \$50,000 of the \$750,000 appropriation from the HOT Surplus Fund within the subject Bill.
