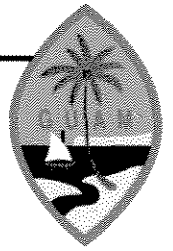

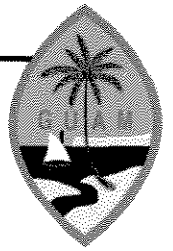

**I. OVERVIEW**

Bill No. 126-33 (COR) was introduced on June 8, 2015, by Senator Frank B. Aguon, Jr., and was subsequently referred by the Committee on Rules to the Committee on Guam US Military Relocation, Public Safety and Judiciary on June 10, 2015.

The Committee on Guam US Military Relocation, Public Safety and Judiciary convened a public hearing on Bill No. 126-33 (COR) on Monday, June 22, 2015 at 9:00AM in I *Liheslatura's* Public Hearing Room.

**Public Notice Requirements**

Public Hearing notices were disseminated via e-mail to all senators and all main media broadcasting outlets on Monday, June 15, 2015 (5-Day Notice), and again on Thursday, June 18, 2015 (48-Hour Notice).

The public hearing was Called-to-Order at 9:00 AM.

**II. SUMMARY OF TESTIMONY & DISCUSSION**

**Chairman Aguon:**

The public hearing held by the Committee on Guam U.S Military Relocation, Public Safety and Judiciary is hereby convened. On the agenda today we do have several pieces of legislation. The first item is Bill No. 111-33(LS), which is relative to the assignment of police officers. Bill No. 123-33 relative to expanding the powers of the magistrate judge. Bill No. 124-33 relative to authorizing the expenditure of funds from the judicial client services fund to support language assistance services at the judiciary of Guam.

**Chairman Aguon:**

Bill No. 125-33, which is relative to advancing compliance with the peace officer standards and training commission by designating probation officers of the Superior Court of Guam as uniformed officers and by adding the Chief of Probation to the peace officers standards and training commission, and then finally we will conclude today's public hearing with Bill No.126-33 relative to authorizing Government of Guam employees to join the Volunteer Deputy Marshall Reserve Program. For the information of the public, the initial notices were disseminated electronically on Sunday, June 14<sup>th</sup> with the first notice of public hearing, and then subsequently on Monday June 15<sup>th</sup>. The notices went out also to the senators as well as some additional stakeholders. The second notice of public hearing for this particular public hearing was disseminated to the community and to the stakeholders on Wednesday, June 17<sup>th</sup> and also on June 18<sup>th</sup> disseminated to all the Senators. I want to, on a personal note as Chairman of the Committee thank our media partners for assisting in this process and ensuring the community is aware of some of the pieces of legislation that will be entertained this morning so thank you very much to our media partners. As we proceed with the first item, I would like to recognize and thank the Senators who have joined us this morning thus far. The Senator to my immediate left is Senator Tina Muna-Barnes thank you very much Senator for joining us. To her immediate left is Senator Camacho Torres and to my right is Senator Tony Ada. Thank Senators for joining us in this public hearing this morning.

Ok, we will proceed to final piece of legislation on the docket, is Bill No. 126-33 and its relative to authorizing Government of Guam employees to join the volunteer Deputy Marshal Reserve Program and Mr. Chief Justice. Thank you Mr. Chief Justice or Mr. Tenorio on Bill No. 126-33.

**Chief Justice Torres:**

Just quickly, Bill No. 126-33, again this was just something I touched on in my State of the Judiciary as our Volunteer Deputy Marshall Reserve Program and one of the impediments to recruiting for the program is that it doesn't authorize unlike the reserve program for the Department of Public Safety, the police department authorized Government of Guam employees to join this reserve program and we think that opening that up, and I don't understand the rationale of wanting to exclude necessarily Government of Guam employees from joining the Volunteer Deputy Reserve Marshall Program but we think by opening up and removing that restriction as is currently authorized for the police department will enable us to look at bigger pool of potential recruits and make the program more successful. Our Chief Marshall is here to discuss the testimony in that regard.

**Chairman Aguon:**

Thank you Mr. Chief Justice. Please identify yourself for the record.

**Chief Marshall Edward Toves:**

Good morning Mr. Chair and Senators my name is Edward Toves. I am the Marshal of the Courts at the Judiciary of Guam. The current law right now prohibits the full time employees from the other Government of Guam agencies to be eligible for the Marshals Reserve Program. I feel that that is unfair compared to other Government of Guam employees not being restricted to become police reserves. The Judiciary, the people of Guam will actually would benefit from tapping on the talent and the experience that come from other law enforcement agencies in Gov. Guam to become Marshals Reserves. It will sure add to our operations as far as efficiency is concerned and it will benefit the entire people of Guam actually.

**Chairman Aguon:**

Thank you very much Chief Marshal Edward Toves.

**Mr. Tenorio:**

Thank you Mr. Chairman. Just to let you know what I think our vision, our working vision is for this program. The first one of course was removing the prohibition. The way we see it is, I think what we are looking at is at the beginning of the fiscal year we are looking at maybe 12 reservists to restart this program, and I think the prohibition, I'm still researching it. It looks like it may have been advocated at the time by the superior court to restrict that, but really there is a lot of inner workings or coordination that I think that's positive when all of the law enforcement entities are able to do joint things. Right now I tell you I have about five probation officers and marshals that are in the police reserve. I used to have two in the airport police reserve but they are all at the Guam Police, you know they are able to get some training and able to do some field operations when necessary. What I'm looking at is having a combination. Removing the restriction would have an open call, but its my intention to get experienced and maybe some of the younger ones that are just graduating from basic law enforcement academy that don't have the kind of work experience that is necessary for them to even break in to law enforcement. I think I've heard some of the critiques from the legislature into the various agencies you know that it is kind of hard to break in and mean while every year there is about 30 people that are graduating from Guam Community College basic law enforcement academy. In fact Captain Terlaje who is head of our training division is the cadre for the last three years along with police officers and customs officers to really try and give these students an integrated learning about the law enforcement culture and the various things that are required of them. So I think that removing the restriction will allow us to take a look at maybe getting some of those that are jointly trained with us to help in specialized field operations, but for the bulk of it really, I'm looking at using this as a way as part of our overtime strategy. You know we always have our weekend Magistrates. Every Saturday the court will always be in session, and if it is on a three-day holiday, it could be twice, and so part of that is to approach it. We've managed to be I think the least of the law enforcement officers for overtime consumption. This year you know I still have about \$100,000, I just asked for a number that has been accumulated in comp time that we are going to try and make sure

Everybody takes within the period of time, but it kind of just goes to show that with at least some of this flexibility and with the stipend that will come in and really our having the opportunity to work under experienced officers. In fact, one of our Captains Ted Padua who is retired I've asked him to return as a reservist and that also might be something we are looking at for the law enforcement officers that are retired but still want to work a little. They still have to meet the POST requirements. We've embraced POST. I think we've been very strategic and I guess very ambitious and proactive. We just had last weekend our second diagnostic test. We only have two more this year then next year I will do it monthly as we get to the mandatory date and give everybody the opportunity to really respond well. I did mention in the probation side but we have established an excellent working partnership with GCC to make sure if there are any gaps in training, including by the way all of our military guardsman and reservist who are in making sure they have a process now to go ahead and review all of the military training they have, translate that into civilian training and make sure we provide for any gaps there. So my goal is including with the marshal reserve we hope to start in October 1<sup>st</sup>, you know we have a very high expectation and high goal for full compliance with POST by the time the deadline comes. The same standard will be applied to the marshal reservists.

**Chief Justice Torres:**

As Josh mentioned, I mean besides the importance of complimenting the work that our marshals do. This is really a cost saving measure for the court to be able to look at the reservist as opposed to overtime for our uniformed officers. It's a way that we feel we can reduce the amount that's being spent on overtime and actually provide a savings to the government as a result of utilizing the reservists, but we do need the restriction removed on government employees for all the reasons we already mentioned and I think there's good symmetry when we work with the police department and allow some of their full time employees to be able to come and work as marshal reservists. That cant be duplicated and this prohibition really prevents that.

**Chairman Aguon:**

Thank you very much Chief Justice Torres and Mr. Tenorio. Vice- Speaker Cruz?

**Vice-Speaker Cruz:**

Thank you very much. Mr. Chief Justice last week the Governor signed a piece of legislation that we passed here to allow for the Chief of Police to select COFA citizens to serve as volunteer reservists. Would you have any objection to my including that to this legislation?

**Chief Justice Torres:**

Absolutely not. We already actually have COFA citizens serving existingly.

**Mr. Tenorio:**

Yeah I think we have one full time, but I think we would welcome the, what I see that's reflective of a priority of our government to make sure the law enforcement is responsive or reflective of our communities, but yes we would welcome that.

**Chief Justice Torres:**

I actually whole-heartedly endorse that.

**Vice-Speaker Cruz:**

Thank you. The other thing this morning I was listening to Chief San Nicolas on the radio and the GFD has the authority to establish a volunteer reserve group, but he said he has not established his because he doesn't have the funding for it. Have you provided for this in your current budget request?

**Mr. Tenorio:**

Yes, in our budget submission there is \$65,000 dollars that we have dedicated for the Marshall Reserve Program, and that is based on having 12 reservists. It could expand if we choose to expand those numbers. If we just move it internally from personnel but our budget request includes that yes.

**Vice-Speaker Cruz:**

Do you already have rules and regulations as to when they get compensated because I know in the police department they have to have 42 hours and I'm just wondering if.



**Mr. Tenorio:**

We do. What we'll do is submit to the chair. The rules were promulgated maybe more than a decade ago and I just need to ask did you have a reserve program before? So they were bringing up to the point to get it done but it just never got implemented. We have, we reviewed the rules extensively. We are happy with them. We believe it could work with the framework and we'll submit it.

**Vice-Speaker Cruz:**

It's a special peeve of mine and I'm sure that the Chairman suffers it with me that these volunteers, please make sure they get paid on a timely basis. I really think it's.

**Mr. Tenorio:**

You have our commitment. We will.

**Vice-Speaker Cruz:**

Thank you.

**Chairman Aguon:**

Thank you very much Mr. Vice-Speaker. Senator Tony Ada.

**Senator Tony Ada:**

Thank you Mr. Chair. Just one question on the you know you were talking about the hours. Is there a minimum is there a minimum hours that the volunteer must warrant?

**Mr. Tenorio:**

I believe the minimum is 40 a month.

**Senator Tony Ada:**

40 a month?

**Mr. Tenorio:**

42 hours a month.

**Senator Tony Ada:**

42 hours a month. Is the marshal division a 24/7 division?

**Mr. Tenorio:**

It's not but it operates six days a week.

**Senator Tony Ada:**

So how would an individual then be able to make the 42 hours every month?

**Mr. Tenorio:**

It could be that on the weekend duties is about maybe five to six hours everyday and then there's some judges that are ending court at seven or eight o'clock. So we would factor that in to kind of the shift work so it could be that we bring somebody in from four to eight for five days a week. Depends on what their work schedules are for their dominate jobs, but we are confident that they will be able to meet that. There's also field work.

**Chief Justice Torres:**

Yeah. Often times they would execute warrants in the evening.

**Mr. Tenorio:**

The protective orders I think is something to protect the domestic violence court. Those are the areas. I can tell you the areas that we are doing the overtime. It's the weekend Magistrates. It's the protective orders at the end of the day coming in and out of the domestic violence court and then when there is bench warrants or warrants of arrest actually that are issued at the end of the day by the criminal trial judges. It's usually that, the urgent ones that we end up, and I forget she just reminded also Erica's House. We have Erica's house operating seven days a week. So we have our marshals there on Sundays also.

**Chief Justice Torres:**

We don't think there would be any problems with that complement making their hours. So yeah.

**Senator Tony Ada:**

Thank you. Thank you Mr. Chair.

**Chairman Aguon:**

Thank you very much Senator Tony Ada and thank you very much Chief Justice, and Chief Marshall Toves, Mr. Tenorio, and Captain Terlaje. Thank you very much for joining us this morning. This concludes the committee's agenda this morning. As was mentioned a little earlier the committee will continue to receive written testimony for the subsequent ten days from this hearing date. And then the committee report will be closed there after so thank you very much again.

The public hearing was adjourned at 10:11 AM.

2 **Section 1. Legislative Intent.** It is the intent of *I Liheslaturan Guáhan* to  
3 remove the prohibition on full-time government of Guam employees from joining  
4 the volunteer deputy marshal reserve program so that government of Guam  
5 employees may be considered for selection.

6 **Section 2. Enhancement of the Volunteer Deputy Marshal Reserve**  
7 **Program.** § 8114.1 of Chapter 8, Title 7, Guam Code Annotated, is hereby  
8 *amended* to read:

9 **“§ 8114.1. Eligibility and Recruitment.** A volunteer must be qualified as a  
10 Superior Court of Guam Deputy Marshal, and have graduated from either the  
11 Guam Police Academy, the Basic Law Enforcement Academy or a qualified law  
12 enforcement academic program within Guam.

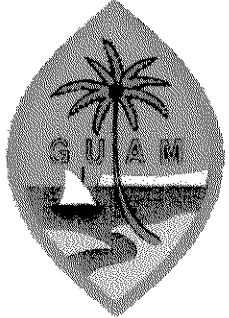

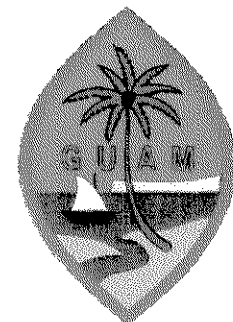

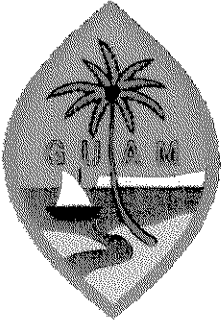

Hafa Adai Senator,

I am in support of Bill No. 126-33 to amend the current law for the Volunteer Deputy Marshal Reserve Program (VDMRP), and to authorize full time Government of Guam employees to join the VDMRP

Under Section 8114.1 of the current law, for Eligibility and Recruitment purposes, it indicates, "NO full-time employee of the Government of Guam shall be eligible for the Program."


This prohibits the Judiciary from recruiting eligible and well trained candidates from other Government of Guam Law Enforcement agencies, such as from the Guam Police Department. There are no restrictions prohibiting other full time Government of Guam employees from joining the Guam Police Civilian Volunteer Police Reserves.

The current law for the Volunteer Deputy Marshal Reserve Program may have been initially written to prevent conflicts of interest, which has been mentioned to me and may be potentially foreseen. For example, a full time employee from a Government Guam law enforcement agency, such as a GPD officer, makes an arrest of a person who eventually becomes a defendant during a trial. This GPD Officer who is a Deputy

Marshal Reservist is assigned to escort this same defendant in court or even escort the jury during this defendant's trial. To prevent this conflict, rules or policy will be implemented that will prevent this conflict of interest.

By allowing this bill to pass, it will greatly benefit the people of Guam who deserve Government efficiency. There are many talented and well trained candidates for the Deputy Marshal Reserve Program that are full-time Government of Guam employees. We should permit them to serve and contribute to our island and not have unfair restrictions under the existing law pertaining to the eligibility for the VDMRP.

*Hafa Adai!* Thank you for providing me with the opportunity to submit public testimony IN FAVOR of Bill No. 124-33 (COR), *AN ACT TO AMEND § 8114.1 OF CHAPTER 8, TITLE 7, GUAM CODE ANNOTATED, RELATIVE TO AUTHORIZING GOVERNMENT OF GUAM EMPLOYEES TO JOIN THE VOLUNTEER DEPT. MARSHAL RESERVE PROGRAM*, which you introduced.

Bill No. 126-33 (COR) would remove the prohibition that exists in current law for Government of Guam employees to become members of the Judiciary of Guam's Deputy Marshal Reserve Program. The same prohibition does not exist for the Guam Police Department Civilian Volunteer Police Reserve Program.

Several of our law enforcement officers are past or current members of the Guam Police Reserve. In the past, they have also been members of the Guam International Airport Authority Police Reserve Program.

If enacted, Bill No. 126-33 (COR) would yield significant benefits to the Judiciary and the island. A strong marshal reserve program, would allow the Judiciary to better control its overtime costs by alleviating the demand on full-time marshals. In short, there would be a cost-savings with no sacrifice on safety or security.



**STANDARD OPERATING PROCEDURES FOR THE CIVILIAN  
VOLUNTEER DEPUTY MARSHAL RESERVE PROGRAM FOR THE  
SUPERIOR COURT OF GUAM**

**A. PURPOSE**

To establish procedures and guidelines governing the daily operational standards of the Volunteer Deputy Marshal Reserve Program (VDMRP) of the Superior Court of Guam.

**B. OBJECTIVE**

The primary objective of this SOP is to standardize the operational procedures and guidelines of the Volunteer Deputy Marshal Reserve Program (VDMR) to include:  
(1) program administration; (2) operations; and (3) training.

## **SECTION I. ORGANIZATIONAL STRUCTURE.**

- A. The Administrative Director of the Superior Court of Guam shall have overall administrative authority over the Volunteer Deputy Marshal Reserve Program (VDMR). The VDMR program shall be considered a program within the Marshals Division of the Superior Court of Guam. The VDMR officers shall be under the overall supervision of the Chief Marshal, and under the immediate supervision of a regular sworn deputy marshal who will have the title of Deputy Marshal Supervisor and/or Deputy Marshal I, II, or III.
- B. All VDMR officers shall be of equal rank. Each VDMR officer shall maintain the title of "Deputy Marshal Reserve Officer." No regular sworn deputy marshal will be under the supervision of a VDMR officer.
- C. Upon assignment to a unit within the Division, the VDMR officer shall be under the overall supervision of the Chief Marshal. However, upon assignment within division/section, the VDMR officer shall follow all directives and instructions of the respective supervisor relative to the unit's field operations and mission.

## **SECTION II. QUALIFICATION AND REQUIREMENTS.**

- A. The applicants for the Guam Civilian Volunteer Deputy Marshal Reserve Program must meet the following requirements:
  - 1. Citizenship - Must be at least 18 years of age, provide proof of eligibility to work in the United States and Guam, and have a valid firearms identification.
  - 2. Criminal Records - Applicants must have no criminal conviction other than minor traffic violations. Applicants are required to submit a current (within two (2) weeks of submission of application) Police and Court Clearance.
  - 3. Education - Graduation from high school or G.E.D. equivalency certification card.
  - 4. Language - Thorough knowledge of the English language.
  - 5. Eligibility and Recruitment: - A volunteer must be qualified as a Superior Court of Guam Deputy Marshal I, and have graduated from the Guam Police Academy, the Basic Law Enforcement Academy or other qualified law enforcement academic program within Guam. No full-time employee of the Government of Guam shall be eligible for the Volunteer Deputy Marshal Reserve Program. All candidates must have a valid chauffeur driver's license in order to qualify for the position.

Minimum Experience and Training for the position of a Superior Court Deputy Marshal I:

1. Graduation from a recognized college or university with an Associate's degree in Criminal Justice, or closely related field in the human and/or social service field plus one (1) year work experience in the legal or law enforcement field; or
2. Graduation with a Certificate in Basic Law Enforcement (inclusive of 45-66 credit hours) from a recognized college or equivalent law enforcement academy plus one (1) year work experience in the legal or law enforcement field; or
3. Any equivalent combination of experience and training which provides the minimum knowledge abilities and skills required for the position.

**SECTION III. CERTIFICATION AND TRAINING.**

- A. The training and certification program for VDMR officers shall consist of the following.
  1. The Chief Marshal shall be responsible for training the VDMR officers. Training guidelines shall be formulated by the Chief Marshal with the concurrence of the Human Resources Administrator. Training for VDMR officers shall include but limited to knowledge of the divisions operations and disposition of documents for each section except criminal, physical agility, firearms night and day qualification. In no case shall a VDMR officer perform any independent tasks until completion of the on the job training program.
  2. VDMR program's on the job training plan and certifications shall set the standard required which must be met by all VDMR officers.
  3. Training for VDMR officers will be at the expense of the Superior Court of Guam. Training will be scheduled to maximize the opportunity for selected personnel to participate. Due to the nature of the marshal's mission, attendance at training sessions is compulsory. Three (3) unexcused absences from training shall be grounds for immediate dismissal from the VDMR program. The Chief Marshal shall submit his written recommendation for termination to the Administrative Director for final approval.

**SECTION IV. PERFORMANCE STANDARDS AND REQUIREMENTS.**

- A. Upon selection to probationary duty, VDMR officers shall undergo eighty (80) hours of on the job training to be completed within a two (2) month period. Reserve officers who fail to meet this time completion requirement may request an extension of the probationary period in writing for cause to the Administrative Director. Failure to



meet this requirement will result in termination from the VDMR Program. The Chief Marshal shall document and submit his recommendation for termination in writing to the Administrative Director for final approval.

1. Each VDMR officer shall be thoroughly familiar with and comply with the Superior Court/Marshals Division Policies and Procedures as well as its Rules and Regulations. Violations of these rules and other applicable orders may constitute grounds for termination from the VDMR program.
2. Standards of conduct and performance for VDMR officers shall be the same as those required of regular sworn deputy marshals.
3. Each reserve officer shall be assigned to the appropriate section within the Marshals Division during the probationary performance period. Moreover, each reserve officer will be assigned to a Deputy Marshal Supervisor who will supervise the VDMR officer's eighty (80) hours on the job training and evaluate the probationary performance period.
4. Deputy Marshal Supervisor shall submit a written performance evaluation to the Chief Marshal. If it is satisfactory, then the VDMR officer may function as a full fledged VDMR officer.
5. After satisfactorily completing his/her probationary performance requirement a VDMR Officer shall be primarily assigned to the following tasks: service of civil documents, service of traffic and small claims documents, summons, civil jury, levies, non-family violence temporary restraining orders, marshal sales, civil jury escort, courtroom security, court security (i.e., Erica's House, Judicial Building security posts), and honor guard duty. A VDMR Officer shall perform any other assignments as required by the Chief Marshal.
6. In addition to normal regular duty assignments, VDMR Officers may undergo periodic certification or additional training as required.
7. The Chief Marshal shall ensure that all required certifications and training are obtained.
8. Each VDMR officer shall obey and follow all lawful directives and/or orders (both written and oral) by Deputy Marshal Supervisors or Deputy Marshals supervising them.
9. CVDMR officers who violate Superior Court/Marshals Division policies, rules or regulations may be terminated from the program. The Chief Marshal shall document and submit his recommendation for termination in writing to the Administrative Director for final approval.

## SECTION V. DUTIES AND RESPONSIBILITIES.

- A. As the primary objective of the VDMR program is to provide support and supplement the regular deputy marshals. In order to receive compensation VDMR officers must perform 42 hours of work per calendar month. VDMR officers may perform these 42 hours at anytime within the calendar month in coordination with the unit of assignment and concurrence with the assigned Deputy Marshal Supervisor. Failure to meet this minimum requirement may be grounds for termination from the Marshals Division. Duties and assignments expected (but not limited to) of reserve officers are as follows:
1. Field assignment.
  2. Administrative Duty.
  3. Crime Prevention.
  4. Community Relation (i.e., honor guard, funerals, state funerals, swearing in ceremonies, special judiciary ceremonies, emergencies, etc.).
- B. Due to possible conflicts of schedules with the VDMR officer's primary employment, it is understood that regular scheduling may not be possible. To alleviate any unnecessary problems, the reserve officer may submit in writing to at the Chief Marshal via the assigned Deputy Marshal Supervisor a request for relief, and at the discretion of the Chief Marshal he/she may defer, exempt or reschedule the duty requirement. In any event, the 42 hour obligation must be satisfied. In order to receive the compensatory stipend of \$450.00 per month the VDMR officer must complete a minimum of 42 hours of duty per month. The purpose of the stipend is to cover uniform maintenance and other expenses associated with such service.
- C. Any VDMR officer who, without approval approval of the Chief Marshal misses his/her regularly scheduled assignments within a calendar month may be suspended or terminated. The Deputy Marshal Supervisor assigned shall conduct a review of any such incident and will submit a written report to the Chief Marshal. The Chief Marshal shall determine whether suspension is warranted and shall provide a report to the Administrative Director of his administrative decision to suspend a VDMR officer.
- D. Work assignments for reserve officers will based on the requirements of the Division. Whenever possible, reserve officers will be given an opportunity to select their primary work hours, however, Marshal Division requirements shall have precedence over any personal preference.
- E. Whenever a VDMR officer is involved or becomes aware of any incident that may affect the VDMR Program, that officer shall report in writing to the Chief Marshal via assigned Deputy Marshal Supervisor the circumstances and events that are involved. This shall be done not later than two (2) working days following the incident. The Chief Marshal shall provide a report with a recommendation of administrative action for the Administrative Director's final disposition.

## **SECTION VI. UNIFORM AND EQUIPMENT.**

- A. All VDMR officers are required to read and fully comply with Marshal Division regulations relative to the Code of Conduct, Uniform, Use of Non-Deadly Force, Court Issued Property and other applicable policies and procedures. A VDMR officer shall sign a written acknowledgment he/she knows and understands the Superior Court of Guam's policies.
- B. Each VDMR officer will be issued the standard set(s) of deputy marshal uniforms, Superior Court VDMR officer Identification and VDMR officer badge. Any such issuance is based upon availability of equipment. The following standard set of uniforms will be issued to the VDMR officer pursuant to the Court's uniform policy.
  - 1. One (1) set each Class "A" (long sleeve formal)
  - 2. One (1) set Class "B" (short sleeve everyday)
  - 3. One (1) set Class "C" (pullover polo or t-shirt)
- C. All equipment and uniforms received shall be signed for and maintained by the VDMR officer in accordance with the standards set forth in the Uniform Policy, Court Issued Property Policy, and all other applicable Court standards. All court issued equipment, uniforms, Superior Court VDMR identification, and VDMR officer badge shall be returned to the Chief Marshal upon termination from VDMR Program.
- D. A VDMR officer may use his/her personal firearm when on assignment, provided that his/her personal firearm has been cleared for use in writing by the Superior Court of Guam's designated Range Master, Chief Marshal and final approval by the Administrative Director.
- E. A VDMR Officer shall wear his/her VDMR uniform and use their equipment only when on assignment.

## **SECTION VII. COMMAND AND CONTROL.**

- A. For the purpose of command and control, the Volunteer Deputy Marshal Reserve Program will be under the overall supervision of the Chief Marshal and under the immediate supervision of a Deputy Marshal Supervisor or Deputy Marshal.
- B. All VDMR officers shall be of the rank of Volunteer Deputy Marshal Reserve Officer and under no circumstance may a reserve officer be placed in a supervisory capacity of any regular uniformed officer.
- C. VDMR officer duty assignments will be under the authority of the Deputy Marshal Supervisor or Deputy Marshal with the concurrence of the Chief Marshal.

- D. VDMR officers will be responsible for providing their assigned Deputy Marshal Supervisor with current notification information relative to their addresses, contact phone numbers and emergency contact numbers. Each VDMR officer will be responsible in notifying their assigned Deputy Marshal Supervisor any change in status pertaining to these information not later than one (1) week after the change or sooner if possible. Deputy Marshal Supervisor's assigned shall provide the Human Resources Division with the current information provided by the VDMR officer.
- E. Each VDMR officer shall submit a monthly VDMR performance report (VDMR timesheets) to the Chief Marshal or his/her designee, via Deputy Marshal Supervisor assigned. These reports must be received by no later than the seventh (7<sup>th</sup>) day of each month for the preceding month. Reports received after this period may not be processed in time and could result in the VDMR Officer not receiving credit for hours worked for. VDMR officers must submit these monthly reports regardless of how many hours worked.
- F. The following system shall be adhered to in calling VDMR Officers to duty:
  - 1. Routine duty assignments will be scheduled and announced biweekly or as is applicable (emergencies).
  - 2. Reserve Officers may request, in advance, specific dates and times of scheduled duty and the CVDMMR Supervisor shall make every attempt to accommodate the request but Division needs will take precedence over any personal preference.
  - 3. In emergency cases, i.e. typhoons, man-made or natural disasters, each VDMR officer shall be responsible in making all possible attempts to report to their assigned section and Deputy Marshal Supervisor for instructions and assignments. VDMR officers with legitimate reasons for non-reporting must make it known to their assigned section and Deputy Marshal Supervisor before or on the onset of the emergency. The Deputy Marshal Supervisor shall inform the Chief Marshal accordingly.

**SECTION VIII. ADMINISTRATIVE RESPONSIBILITIES.**

- A. The following are administrative responsibilities that provide guidance to the administration and operations of VDMR Program.

- 1. **ADMINISTRATIVE DIRECTOR**

The Administrative Director shall have overall administrative discretionary authority in administering the Volunteer Deputy Marshal Reserve Officer Program for the Superior Court of Guam, and provide recommendations to the Judicial Council as deemed necessary.

**2. CHIEF MARSHAL**

The Chief Marshal as the division head for the Marshals division, shall oversee the operations of the Volunteer Deputy Marshal Reserve Program and serve as the certifying authority for all VDMR officer's who complete the minimum forty two (42) hours worked for payment processing. The Chief Marshal shall also provide recommendations to the Administrative Director as deemed necessary.

**3. HUMAN RESOURCES ADMINISTRATOR**

The Human Resources Administrator shall be responsible for the recruitment processing of all individuals submitting resumes for the Volunteer Deputy Marshal Reserve Program. In addition, the Human Resources Administrator shall review for approval all Training guidelines and programs, and for the VDMR program submitted by the Chief Marshal, and make periodic recommendations to the Administrative Director as deemed necessary.

**4. CONTROLLER**

The Controller shall be responsible for establishing and implementing a payment procedure for all VDMR officers who have been certified by the Chief Marshal as to completing the forty-two (42) duty work hours per month minimum requirement.

**5. DEPUTY MARSHAL SUPERVISOR**

- a. Supervise the daily operations of the VDMR Program.
- b. Maintain all VDMR administrative affairs (training records, personnel files, time sheets, etc.).
- c. Maintain liaison with division units with assigned VDMR officers.
- d. Ensure written certification that a VDMR officer is fully trained and able to handle assignments given to them.
- e. Prepares monthly reports VDMR officers activity/performance reports.
- f. Assign VDMR officer duty assignments.
- g. Mark recommendations to Chief Marshal and identifying training needs. May assist in the development and implementation of training needs.

**3. VOLUNTARY DEPUTY MARSHAL RESERVE OFFICER**

- a. Perform work assignments as directed.
- b. Maintain proficiency of deputy marshal duty standards.
- c. Be thoroughly familiar and comply with all Court/Division policies, procedures, rules and regulations.
- d. Maintain periodic contact with the assigned section and Deputy Marshal Supervisor to insure pertinent and applicable information are received and confirmed.
- e. Promptly submit monthly VDMR reports and timesheets, as required.
