Bill No. 211-33 (COR)

I. OVERVIEW: The Committee on Health, Economic Development, Homeland Security and Senior Citizens conducted a Public Hearing on December 10, 2015. The hearing convened at 1pm in I Liheslatura's Public Hearing Room. Among the items on the agenda was the consideration of Bill 211-33 (COR) - An act to amend §§ 122317and 122318 of Article 23, Chapter 12, Part 2, Title 10, Guam Code Annotated Relative to Extending the Timeline for Obtaining Exemptions and Exceptions for Social Worker Licensure Upon the Promulgation and Enactment of the Rules and Regulations; Sponsored by Senator Dennis G. Rodriguez, Jr.

II. SUMMARY OF TESTIMONY & DISCUSSION.

Senator Dennis G. Rodriguez, Jr.: (Bill Title Read). We have Ms. Christine Bias, Josephine Nakamura. Okay you're just here for support not to provide testimony. We have written testimony from Hope Cortez, Mr. Burns, Mr. Al Silverio. If I didn't call your name but you've signed up just to indicate your support and not wish to testify, thank you. I'd like to recognize Vice-Chair of the Committee, Senator Tony V. Ada, thank you senator for being here. (Recognized Ms. Hope Cortez).

Ms. Hope Cortez: Good Afternoon Honorable Senator Rodriguez, Chairman of the Health and Human Services and Vice-Chair Senator Tony V. Ada. (Read Written Testimony).

Senator Dennis G. Rodriguez, jr.: Great thank you very much Ms. Hope, maybe I can ask Al as the other board member and then after that we can open up questions. (Recognized Mr. Al Silverio)



Mr. Al Silverio: Hafa Adai and good afternoon, my name is Al Silverio. Thank you Senator Rodriguez and Senator Ada for your support and for letting us provide testimony this afternoon. (Read Written Testimony).

Thank you.

Senator Dennis G. Rodriguez, Jr.: Al, thank you very much for your testimony as well as Ms. Hope and I appreciate the statements you've made. The bill that we have before us is to extend the timeline first and foremost so that the board can go through the process of promulgating and establishing those fees that you talked about and establishing the mechanism on how we collected. So we just want to make it clear that we're not here yet to entertain that. I know that Senator Espaldon wrote me a small note and was asking about "Fee Schedules?" based on your testimony. So that's not what we're here for today but I appreciate that information that you're providing and I realize that the board has worked very hard in developing this and so what's very important here today is that we extend this timeline and this will be the second time that we had move this timeline just really to give the board the opportunity to work through the details and ensure that this timeline is extended so that no one loses the opportunity to be able to receive licensure once the fees and all the procedures are set in place. Okay so just real quick. (Recognized Senator Espaldon).

Senator James V. Espaldon: Thank you Mr. Chair. Yes that was clear. I appreciate the clarification.

Senator Dennis G. Rodriguez, Jr.: Thank you very much Senator. (Recognized Mr. Craig Burns).

Mr. Craig Burns: Hafa Adai, thank you Mr. Chairman, Mr. Vice-Chairman, Senator Espaldon. I want to thank you for the opportunity to testify in support of Bill No. 211-33 (COR) which will extend the timeline for obtaining exceptions and exemptions for social worker licensure upon the promulgation and enactment of the rules and regulations. My name is Craig Burns, I'm here as the president of the Guam Chapter of the National Association of Social Workers, we represent more than one-hundred (100) of the social workers and social work students here on Guam and as well as a professional association in the National Association of Social Workers which represents over one-hundred-thirty-thousand (130,000) social workers nationwide. I want to express my appreciation and gratitude to both the Office of Senator Rodriguez for working with the Guam board of Social Work to respond to this moment of concern in a quick expeditious manner for those aw aiting word on exception and exemption in the licensing law. So while the December 10, 2015 deadline for exception and exemption is in fact today as you mentioned, we're here to extend that timeline to give the board the opportunity to continue and to complete the process. So I and the social work community on Guam recognize the dedication and hard work the volunteered members of the board



and during the town hall meeting they held on November 24, 2015 over thirty (30) other social workers and myself were there and we were given insight into the progress that's been made in the past 18-months and how close they are to getting the social workers on Guam licensed. So the most important thing for this law is that we do it right as oppose to doing it right now and so again thank you for introducing this bill to extend the timeline. So I just want to express in support of the Guam Chapter of the National Association of Social Workers for the passage of this bill and as a final thought I'd also like to express the Chapter's strong support for the passage of the fee schedule and the rules and regulations so we can get the social workers licensed in continue with work that we do supporting in helping Guam's neediest and most vulnerable populations and I'll submit thorough written testimony by close of business tomorrow.

Senator Dennis G. Rodriguez, Jr.: Okay thank you very much, are there anyone else that wish to make any oral testimony? I know we have a bunch of you that signed up and I understand that you're here to support so we'll ensure that is included on the record. If not we'll go ahead and adjourn this hearing but just to want publicly state that we're going to continue to work with the social work board, I know that there is already some information that the board has put together to implement a fee schedule and I've offered and I'll state that here publicly that if it's submitted officially with the resolution from the board that we can pursue that here through the legislature in terms of a bill and having a public hearing and then enacting it into law so that we can kind of cut the timeline down in moving that forward. Great so if there's nothing else, we'll keep the record open for a few days and anyone who wish to submit written testimony they can do so by dropping it off to the legislature or email senatordrodriguez@gmail.com or fax over to my office as well. Thank you very much and a Merry Christmas everybody.

AN ACT TO AMEND §§ 122317 AND 122318 OF ARTICLE 23, CHAPTER 12, PART 2, TITLE 10, GUAM CODE ANNOTATED RELATIVE TO EXTENDING THE TIMELINE FOR OBTAINING EXEMPTIONS AND EXCEPTIONS FOR SOCIAL WORKER LICENSURE UPON THE PROMULGATION AND ENACTMENT OF THE RULES AND REGULATIONS.



BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Finding and Intent. *I Liheslaturan Guåhan* finds that the members of the Guam Board of Social Work continue to require additional time to promulgate the requisite rules and regulation, as authorized pursuant to \$122312 of Guam Social Work Practice Act, as enacted on Dec 10, 2012, and amended on June 24, 2014 (P.L. 32-167).

I Liheslaturan Guåhan further finds that the statutory timelines by which existing, currently practicing social workers may obtain either exemptions or exceptions necessary for the renewal of their licenses will expire on December 10, 2015. This will effectively result in the inability of over two hundred (200) social workers from continuing their practice in the allied healthcare workforce. It will likewise negatively impact the thousands of clients requiring their services.

It is the intent of *I Liheslaturan Guåhan* to once again accommodate the Guam Board of Social Work by extending the date by current social workers may obtain exemptions or exceptions for the renewal of their licenses, and to provide time during which they may promulgate their rules and regulations, as well as

Rules and Regulations December 10, 2015, or within eighteen (18) months of the date of the enactment of this Act, whichever is later;

- (b) a person who self-identifies as a social worker and possesses a Bachelor's, Master's, or Ph.D. degree in the field of social work from an accredited or unaccredited social work degree program upon enactment of this Act. Those granted exceptions must obtain a social work license by upon the promulgation of the Rules and Regulations, December 10, 2015, or within eighteen (18) months of the date of the enactment of this Act, whichever is later; and
 - (c) a person who possesses a non-social work degree, but possesses a degree in a related social science, to include degrees such as psychology, sociology, counseling, human relations and human services, political science, criminal justice, and any other degrees as approved by the Board; and who self-identifies as a social worker may apply for an exception to obtain social work licensure meeting the following requirements:
 - (1) provide a written request for exception from licensure requirements to the Board;
 - (2) provide a written declaration that they are individuals in good standing based on satisfactory employment performance evaluations and with no ethical complaints in the course of their employment with the job title "social worker";
 - (3) sign a declaration statement that they will abide by the National Association of Social Workers Code of Ethics:
 - (4) submit three (3) letters of verification; one (1) from their current employer acknowledging that he/she is an individual in good standing, and

- Section 5. Effective Date. This Act shall become immediately effective

Bill 211-33 Testimonial

I am Al Silverio, Secretary of the Guam Board of Social Work (GBSW). I am here in support of Bill 211-33, specifically regarding the proposed fee schedule based on the Economic Impact Study (EIS) submitted earlier.

.

The proposed \$300 Social Work license fee will be valid for two years and is highly competitive with Texas, Oregon and Hawaii. These states have similar ratios of Social Workers to their respective populations. They also have similar Social Worker career growth patterns as Guam.

The proposed fee schedule will support the operations of the GBSW for at least five years based on projected rates of annual new applications and renewals. This fee schedule will give stability and ensure a smooth transition as new board members continue the licensure process. We also believe this is sound fiscal planning based on ensuring sustainability of the licensure process.

The Association of Social Work Boards (ASWB) is a nationally-recognized organization that serves all 50 states plus Guam and Saipan. It will receive the payment directly from Guam applicants along with all required documentation such as transcripts, references and clearances. ASWB will store these materials online and will be accessible only by the GBSW to determine licensure eligibility. ASWB will then remit the GBSW \$200 of the \$300 they receive from each applicant.

The money will be deposited in a specific Department of Public Health and Social Services (DPHSS) account managed by the Health Professional Licensing Office (HPLO) and the GBSW. This administrative process saves the Government of Guam expenses by eliminating the need to establish a Social Work license office and the necessary operational costs such as staffing, fringe benefits and other administrative expenses.

A third party annual auditor is included in the ASWB services. ASWB is audited annually by an external auditor and maintains a finance committee that reviews fiscal activity that works with the auditing firm. Lifetime licensure will not be implemented to help ensure timely review of all licensed individuals and to resolve any issues in a timely manner.

The GBSW EIS passed the scrutiny of our legal counsel. The GBSW is confident that the proposed fee schedule represents responsible fiscal planning and endorses its implementation.

Hafa Adai! I am Hope Marie Pangelinan Cortez, Vice Chairman of the Guam Board of Social Work. I am in favor of Bill 211-33 (COR) for the following reasons:

- The extension will help over 200 social workers remain in their current employment and will allow for service continuity for the individuals and family members who rely on these service providers; and
- The Guam Board of Social Work is a five-member board with four board members appointed at this time. One position is currently vacant and the term of one board member will commence by the end of this month- December 2015. The extension will allow more time for board members to review applications with appointed members available. More time at the review stage will foster a thorough review of each application while reinforcing the purpose of The Social Work Practice Act, which is consumer protection.

Within these past two years, the board and community members engaged in several work groups to establish rules and regulations, the development of an economic study, and fee schedule. The Guam Board of Social Work has accomplished much to include receiving membership services from the Association of Social Work Boards (ASWB) - the national organization which overseas all social work boards and administers the national social work exam across the nation, Canada, and Saipan. Three of our board members have received national Social Work Board Member training from the Association of Social Work Boards. The board has engaged in national conversations on licensure mobility to ensure that Guam is represented. The Guam Board of Social Work has established a formal application for each of the five different certification/licensure tiers and will be the first board in Guam to accept applications on-line.

In conclusion, while much has been accomplished there is still more to be done locally and nationally. The Guam Board of Social Work will continue to work hard towards implementing social
