COMMITTEE REPORT DIGEST

Bill No. 212-33 (COR), As Introduced – B. J.F. Cruz – "An act to authorize the Attorney General the use of funds for experts in federal litigation case."

I. OVERVIEW

Bill No. 212-33 (COR) was introduced by Vice Speaker Benjamin J.F. Cruz on December 2, 2015, and subsequently referred to the **Committee on Appropriations and Adjudication** on December 3, 2015.

The Committee on Appropriations and Adjudication convened a public hearing on Monday, December 28, 2015, beginning at 4:00PM in the Guam Legislature Public Hearing Room. The hearing for Bill No. 212-33 (COR) began at 4:01PM and ended at 4:18PM.

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on December 18, 2015, and December 26, 2015, via email. Copies of the hearing notices are appended to the report.

II. TESTIMONY & DISCUSSION

Chairman Benjamin J.F. Cruz announced Bill No. 212-33 (COR), recognized the members of the Committee on Appropriations and Adjudication (Committee) in attendance, and acknowledged the Deputy Attorney Generals from the Office of the Attorney General (OAG), Mr. Fred S. Nishihira and Mr. Kenneth D. Orcutt, as the individuals present to testify.

Deputy Attorney General Fred S. Nishihira, Consumer Counsel Division, OAG, greeted the members of the Committee and apologized on behalf of Attorney General Elizabeth Barrett-Anderson for her absence. He noted he and Deputy AG Orcutt were requested to provide testimony on the measure due to their involvement with the implementation of Guam Public Law No. 33-01, which, in part, authorizes the Attorney General to procure consultants and experts to comply with the January 16, 2015 United States District Court of Guam Order relevant to the 1991 Settlement Agreement in Civil Case No. 91-00020. He further remarked that the success of P.L. 33-01 is evidenced by the improvements to inmate access to services within the Guam corrections system, and expressed that the OAG is confident the government of Guam will be in full compliance with the Consent Decree by 2016. He proceeded to read written testimony (appended to this report) wherein Attorney General Barrett-Anderson expressed full support of the passage and enactment of Bill No. 212-33 (COR), noting that only \$79,155 of the funding authorized in P.L. 33-01 has been expended for the two expert witnesses contracted for the Consent Decree case. The letter adds that consequently the OAG is contemplating spending \$75,000 to contract a third expert for a separate federal case. The letter also requests to further amend the language in Section 3 of the measure to encumber remaining funding for technological infrastructure improvements for OAG.

Chairman Cruz thanked Deputy AG Nishihira and opened the floor for questions.

Senator James V. Espaldon, in reference to the OAG written testimony, asked Deputy AG Nishihira for clarification on the encumbrance of the \$435,000, specifically on whether the OAG anticipates the necessity of bringing in additional witnesses for compliance with the Consent Decree.

Deputy AG Nishihira replied:

"So we anticipated using the expert witnesses [and consultant] that we have. We have a psychologist on board, Dr. Jason Perez, as well as the University of Connecticut. And [OAG Chief of Staff Ms. Jacqueline Z. Cruz] has the exact numbers. But of those funds that we had anticipated [to spend], we realized that we would not need all of it. So the contract may be, for example, two hundred and fifty thousand dollars (\$250,000) but maybe we've used only eighty thousand [dollars] (\$80,000) of that."

Senator Espaldon pointed out, using the scenario Deputy AG Nishihira presented, that the OAG has \$170,000 to expend.

Deputy AG Nishihiri responded:

"Correct. We're requesting if we could use it elsewhere because the parameters in [P.L.] 33-01 were rather limited. So this [bill] will allow us to expend it elsewhere. And the reason why we didn't spend as much money as we anticipated was because it took a lot of work upfront and as we went along we needed the experts less and less. So it worked out well. You look at the Consent Decree, where we are now, and within less than a year, we plan to file motions to get out of it—if not this month, next month [or] very soon. So the experts have worked well but we're keeping them on board to make sure that as we implement, they can monitor and ensure that we're able to sustain these new implemented policies and procedures."

Senator Espaldon asked for further clarification, reiterating that with only \$79,000 of the funds actually expended out of \$435,000 that has been obligated, OAG has about \$300,000 left to use to continue with the case.

Deputy AG Nishihira replied:

"We still anticipate using some of the funds but not exhausting all of it. For example, if we plan to bring the University of Connecticut out five (5) times, now it's only three (3) times. So the contract has decreased. The need for the experts has decreased. We could do a lot more via Facetime (a general reference to videotelephony products and technology)."

Senator Espaldon remarked that he wanted to ascertain that the use of the word "obligated" does not mean "encumbered", which would mean that the funds must be spent on specific items and will not be available for any other expense.

Deputy AG Nishihira suggested that the OAG Chief of Staff would be better suited to explain the matter to the Committee.

Ms. Jacqueline Z. Cruz, Chief of Staff, OAG, introduced herself and stated to Senator Espaldon that the term "obligated" did in fact mean "encumbered". She pointed out that the low level of expenditure has not even amounted to even half of the amount of money actually encumbered.

Senator Espaldon continued his inquiry, beginning with a calculation of deducting \$435,000 from the \$700,000 that P.L. 33-01 authorized.

Ms. Cruz interjected, noting that the OAG received only \$580,000 of the authorized funding of \$700,000 pursuant to P.L. 33-01.

Senator Espaldon stated that based on the OAG officials' statements before the Committee, the agency has about \$200,000 remaining after the obligation of \$435,000, and reiterated his interpretation of the intent of the bill as a request for permission to encumber those funds for other uses, including improvements to the agency's technological equipment.

Ms. Cruz confirmed Senator Espaldon's appraisal, adding that the OAG currently has \$174,000 available from its P.L. 33-01 appropriation.

Deputy AG Kenneth D. Orcutt added that the OAG has an additional estimated expenditure of \$75,000 for contracting another expert for a separate case.

Chairman Cruz offered clarification:

"Just to make things clear, we thought there was seven hundred thousand [dollars] (\$700,000) that had been unexpended from [fiscal year] 2014. In [P.L.] 33-01, we gave the Attorney General the authority to expend any of those funds for expert witnesses in the [Guam Department of Corrections] (DOC) case (Civil Case No. 91-00020). The funds have not been completely expended. Four hundred [thousand dollars] (\$400,000) of it has been obligated, but not all of it may be necessary to complete the solution of the Consent Decree. So [Attorney General Barrett-Anderson] has asked for authorization to get further, additional expert witnesses to assist in other cases that she's contemplating taking in the federal court and that was written into Bill No. 212-33 (COR).

"[Attorney General Barrett-Anderson] is asking for some technological equipment [but] that's not in [the measure as introduced]. That's an amendment she is asking for that may not necessarily be granted. We may just be giving authorization as per [the bill as introduced] only for expert witnesses. If there's any money left over then we might think about doing the technological equipment that she's requesting. But right now, as written, Bill No. 212-33 (COR) is only for expert witnesses for other federal cases – both the Layon case (Civil Case No. 02-00022 relative to the closure of the Ordot Dump and construction of the Layon Landfill) and the Davis case (*Davis v. Guam*, No. 13-15199, 9th Cir. 2015) – to assist in those two cases. If there is anything left over after that, we may have a third bill to complete all the seven hundred thousand [dollar] (\$700,000) expenditure."

Senator Michael F.Q. San Nicolas, addressing Chairman Cruz, also requested clarification, stating that he was under the impression that Bill No. 212-33 (COR) is a measure to free up resources for the potential need for a special prosecutor to independently investigate the illegal retroactive payment in December 2014 of salary adjustments to Adelup employees.

Chairman Cruz responded:

"That has not been discussed with the Attorney General as to whether or not [the unexpended funds from the P.L. 33-01 appropriation] is going to be used [for that purpose]. It was not contemplated in the introduction of Bill No. 212-33 (COR). If she wants to send testimony to say that she would like to have money from the unexpended funds for the special prosecutor, she can do that. It wasn't in [this measure] and it's not in her testimony today. The only thing she's adding is equipment, which we had not discussed before. So no, [the bill is not for the purpose of hiring a special prosecutor in the investigation of the illegal retroactive payment to Adelup employees].

"What she was hoping to do was to get expert witnesses to assist her in the Davis Case and in the Layon Case—whatever was going to be necessary to complete both of those cases. That's all that was contemplated by [Bill] 212. If she sends a letter that she'd like to expand [her spending authority] to include something else, then we might do that before the hearing but it's not in any of the testimony either."

Senator San Nicholas again sought the Chairman's answer, rephrasing his original inquiry:

"Just to clarify, Bill No. 212-33 (COR) does not in any way authorize a special prosecutor for that purpose?"

Chairman Cruz shook his head no.

Senator San Nicholas addressed the OAG representatives and continued his line of questioning regarding the funding for a special prosecutor for the Adelup retro pay matter:

"If the Attorney General did want to utilize the services of a special prosecutor for that case, would [that] require an addition appropriation or does the OAG have the resources and the authorization already to take that course?"

Ms. Cruz responded that she would have to look at the agency's finances on the account to answer the question.

Senator San Nicholas continued:

"The reason why I'm asking, Mr. Chair, is because there [have] been public statements that those are the directions that the OAG may be taking. I was under the assumption that the availability of this resource was to authorize her to go ahead and use these funds for that purpose. But now that it's clarified that that's not what this bill is going to do. I'm just curious if she was stating that she is going to be using a special prosecutor, where would the funds be coming from for that?"

Deputy AG Nishihira stated that he would consult the Attorney General regarding these speculations, specifically the utility funds from the P.L. 33-01 appropriation for the recruitment of a special prosecutor, and provide the Committee an answer.

Senator San Nicolas continued:

"The only reason I'm asking is because it looks like what we have here is kind of like a side account for the OAG to be able to utilize for expert witnesses that [are] not needed on a regular basis. So if we're going to be making funds available for those special circumstances to which the Attorney General needs to have an additional resource to be able to tap into—that's kind of uncommon but necessary—then perhaps just adding authorization language so that she doesn't come back and say 'I never got the money for that.' We don't want to have to keep constantly jumping through those same hoops. That was the reason I wanted to make the inquiry, Mr. Chair."

Chairman Cruz replied:

"I appreciate the question. I wanted to make it very clear that when I introduced [Bill] 212, [the funding of a special prosecutor for the investigation of the illegal Adelup retro pay] was not the intent. And I was not going to say it was when I knew that it wasn't. So I want that very clear. But if the Attorney General feels that she may need authorization for that, I would have no objection to adding that amendment between now and [the next legislative session].

"Hopefully, we'll get an answer from the Attorney General as to whether or not she—with all the public pressure the papers are putting, I'm sure that at some time she's going to need to say whether she does or does not have the requisite funds to address an independent prosecutor so she can send us a note. But I just want to make sure that people are clear that even if [Adelup's illegal retro payment of salary raises] was an issue that I had raised, I was not going to hijack a bill that I had introduced well before I had raised that issue and try to make it look like I'm bootstrapping it in. If that's the Attorney General's request, we will deal with it."

Chairman Cruz, on account that there were neither additional questions from the Committee nor other individuals present to testify, considered Bill No. 212-33 (COR) as heard.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Appropriations and Adjudication to which was referred Bill No. 212-33 (COR) - B. J.F. Cruz - "An act to authorize the Attorney General the use of funds for experts in federal litigation case" hereby submits these findings to *I* Mina'trentai Tres na Liheslaturan Guåhan and reports out Bill No. 212-33 (COR), As Introduced, with a recommendation TO <u>10</u> <u>MS</u>.

Dear Vice Speaker Cruz:

Hafa adai. 1 fully support Bill 212-33 (COR), an act to amend P.L. 33-1 to authorize the Attorney General to use funds for experts in federal litigation cases. In addition, I am hereby requesting to further amend the language in Section 3 as contained in the attachment.

Public Law 33-1 gave our Office the funding mechanism to secure expert witnesses for the DOC Consent Decree case. The use of expert witnesses was a game changer. The case has been open for almost 25 years and now with outside expert guidance, I am glad to report that we are in the final stages of completion and exiting the consent decree. We are supporting the amendment in hopes of duplicating similar results with other federal cases.

As for cost, of the 2 experts we have contracted, approximately \$435,000 has been obligated and only \$79,155 has been expended. We plan on extending these contracts, and are contemplating a third expert in a separate case which we anticipate will cost about \$75,000. However, we still anticipate a minimum of \$200,000 may be unobligated, which will provide the resources we need to significantly improve our current network and technological investment.


