COMMITTEE REPORT DIGEST

1. OVERVIEW

Bill No. 214-33 (COR) was introduced on December 3, 2015 by Senator T.A. Morrison, and was subsequently referred by the Committee on Rules to the Committee on Municipal Affairs, Tourism, Housing and Historic Preservation on December 4, 2015.

The Committee on Municipal Affairs, Tourism, Housing and Historic Preservation convened a public hearing on Bill No. 214-33 (COR) on Thursday, January 7, 2016 at 6:30 PM at the Umatac Mayor's Office, Municipality of Umatac.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 7:00 P.M.

<u>Chairperson:</u> Good evening everyone and thank you for coming this evening. First of all, I'd like to apologize for being a tad late. God was definitely on our side and he wanted me to be here this evening to hold this public hearing and see the true beauty of the south. I'd like to invite everyone to come in a bit closer please. Thank you!

This public hearing by the Committee on Municipal Affairs, Tourism, Housing and Historic Preservation is now called to order. It is now 7:00 p.m. For the record and in accordance to 5 GCA, Chapter 8, Subsection 8107, notices were sent out via email to all Senators and all main media broadcasting outlets on Tuesday, December 29, 2015 (5-day notice) and the second notice on Monday, January 4, 2016 (48-hour notice). I also want to recognize the Vice Mayor of Agat for being here, Vice Mayor Susuico and also Mayor of Merizo, Mayor Chargualaf. Thank you both for being here.

Joining me this evening, ladies and gentlemen, are Senator Tommy Morrison and Senator Tony Ada. I'd like to thank them for joining me this evening. I want to recognize the MPC members who are present. I would like to say thank you to all of you for joining us this evening.

<u>Senator Thomas Morrison</u>: Thank you Madam Chair. I'm grateful for you holding the public hearing here in the beautiful village of Umatac. In all my 2-year term, I have never had the experience of having a public hearing at another venue until this evening and I am very grateful. It's a great thing for our people of Umatac to experience this and be able to testify. Great customer service! Thank you once again Madam Chair and thank you Mayor Quinata for having us here, and thank you also Glenn Leon Guerrero, Director of Public Works and Felix Benavente, Deputy of Public Works.

Senator Morrison reads comments below:

Thank you Madam Chair, and committee members for the opportunity to provide comments on Bill 214-33 (COR), relative to funding repairs to the Umatac Bridge Towers.

- The Umatac Bridge was built during the late Governor Ricky Bordallo's administration 30 years ago.
- As the Commissioner of Umatac during this period in Guam's history, my mother Cecilia "Chilang" Morrison worked closely with Governor Bordallo to replace the original bridge an old metal structure that barely withstood powerful typhoons and the demands of increased traffic activity.

- To the surprise of my mother and the residents of Umatac, the construction of the new bridge included a pair of towers which were wonderful additions to Guam's southern landscape.
- With the passage of Bill 214, we will finally improve the conditions at the towers which have deteriorated preventing residents and tourists alike from enjoying this magnificent landmark.
- Thank you, Madam Chair, and fellow colleagues for joining me, DPW officials and engineers, the Umatac Mayor's Office, and the Governor's Office during two site visits to the Umatac Bridge the first in 2014, and the second held in early 2015.
- Not only were we able to see first-hand the deterioration of various sections of the towers during the site visits we also observed many residents and tourists alike... that stopped by to take photos with the towers as their backdrop.
- Following the first site visit in 2014, the legislature through the FY 2015 budget law included the Umatac Bridge to the list of CIP's to be funded by the Tourist Attraction Fund... along with Tourist District Infrastructure Projects and the Tumon and Hagatna Bay Surveillance System Phase II.
- With bridge repairs yet to be made as of August 2015, Senator Frank Aguon, Jr. filed Bill 156 last year in an effort to move forward with much-needed repairs to the staircases, balusters, and electrical system.
- Bill 214 is the latest measure in our efforts to highlight the value the Umatac Bridge and its distinctive towers have not only to our visitor industry, but also to the people of Guam, particularly southern residents who commute to and from work via this wonderful landmark.
- With Guam set to host thousands of guests this summer during the largest cultural event in the Pacific... FESTPAC... it is not only timely, but appropriate, that we finally restore this historic landmark for all to enjoy.

<u>Chairperson:</u> Si Yu'os Ma'ase Senator Morrison and this time now I'd like to call everyone up to speak.. I would like to call up Mayor Quinata, Glenn Leon Guerrero, Felix Benavente and Rudy Quinata. Please come forward to testify. Please proceed, consige pot fabot!

Mayor Johnny A. Quinata: Thank you Madam Chair. I want to thank you Senator Morrison and Senator Tony Ada. I want to thank you all for bringing this hearing to the village of Umatac so our people can voice their concerns about the bridge. There's so much we can do but any little thing we can do really helps a lot. There's so many things that that bridge needs and it's about 22 years that the bridge has been like that. We know that the structural work is going to be done but the erosion is another concern. The river gets higher and higher every year and that will need to be addressed soon. The tourists continue to stop by to take pictures.

<u>Chairperson:</u> Si Yu'os Ma'ase Mayor. Mr. Leon Guerrero please proceed.

Mr. Glenn Leon Guerrero: My name is Glenn Leon Guerrero, Director of Department of Public Works and thank you for having allowing me here to testify. Also, Senator Morrison and Senator Tony Ada. I just want to give you a few facts on what the project will entail and I think you had some questions as well. The department's engineering division did an estimate a couple of years ago in 2013 and it was estimated about 217,000 dollars and majority of it was for stainless steel and 15,000 set aside for painting and another 15,000 for electrical upgrade. That was back in 2013 and has not been updated since. Today we think if the materials are on island, we estimate this to take about 90 days. As soon as this bill is passed we will begin the process.

Chairperson: Are you telling me the supplies are here already?

Mr. Glenn Leon Guerrero: No, Madam Chair, that's if the materials are on island.

<u>Chairperson:</u> Mr. Benavente would like to say a few words?

Felix Benavente: I am here to reiterate all of Mr. Leon Guerrero's comments as well.

Mr. Glenn Leon Guerrero: Madam Chair, I forgot to mention that we are here in support of the bill. Thank you!

<u>Chairperson:</u> Thank you Mr. Leon Guerrero and Mr. Benavente. Mr. Quinata, please state your name for the record and proceed.

Mr. Rudy Quinata: My name is Rudy Quinata and thank you for being here. I am here to support the bill. Thank you!

<u>Chairperson:</u> Si Yu'os Ma'ase Mr. Quinata. Senator Morrison, you had a question for Mr. Leon Guerrero.

<u>Senator Thomas Morrison:</u> Thank you Madam Chair. Mr. Leon Guerrero, I just to ensure the Director, put on record and for my colleagues as well and the general public, that to my understanding that Bill 214-33 (COR) is the direct savings from the DOA demolition project, is it clear that this funding source being appropriated will not impact this project?

Mr. Glenn Leon Guerrero: Senator Morrison, in P.L. 33-19 the funding source was appropriated for a million dollars from the Guam Preservation Trust for the demolition of the Manuel L. Guerrero DOA building. We are pleased to say that we are blessed because to date we have obligated up to 346,000 out of the million. We still need to do the grass and budgeting about 100,000 for that so clearly we have enough money to budget for this project.

<u>Chairperson:</u> Thank you Mr. Leon Guerrero and we will move on to the next panel up. You are welcome to stay for the duration of the hearing. I'd like to recognize the former Commissioner, Commissioner Morrison. The next panel of members are: Serena Quinata, Cory Quinata, Frank Acfalle and Frank Sanchez. I'd like to recognize the former Mayor, Mayor Frank Acfalle. Please proceed Serena Quinata.

Ms. Serena Quinata: Thank you very much everyone for being here. I just want to say thank you for having this hearing here. I am the daughter of Debbie Quinata, Maga' Haga'. I want to say that everyone had said everything about the bill already and I am in full support of the bill. I just want to add that Umatac is the original capital of Guam.

<u>Chairperson:</u> Si Yu'os Ma'ase Ms. Quinata. Mr. Quinata, proceed.

Mr. Cory Quinata: Thank you all for being here and I am in support of the bill. To save money, instead of stainless steel we should aluminum for the railings and the stairway. Thank you!

<u>Chairperson:</u> Si Yu'os Ma'ase Mr. Quinata. Mr. Acfalle, proceed.

Mr. Frank Acfalle: Good evening Madam Chair, Senator Morrison and Senator Ada. I thought you guys were here for the school. (just joking). I agree with Cory here to save money, use aluminum and I also suggest that the paint be removed and just be natural. I commend out hometown boy for bringing up this idea and I hope DPW keeps their word and follow through with this. I support the bill.

<u>Chairperson:</u> Si Yu'os Ma'ase! Mr. Sanchez, please proceed.

Mr. Frank Sanchez: Good evening everyone! I personally was one of the first locally hired person for the building of that bridge. The longer we wait for this bill to pass, the more money we need to do this project, so the less time we have on this bill, the more money we save. When it was painted, it throws off the natural beauty of the tower. Maybe a light grey would be better. The bridge is a history...a history by a dreamer..Governor Bordallo. He has done some tremendous things. So let's make this a reality, you Madam Chair, fight with the Democrats and I'll talk to those two to fight with the Republicans, not only for us here in Umatac, but for the tourist. What's the money making thing for Guam...our tourist! Thank you and I support this bill!

<u>Chairperson:</u> Thank you Mr. Sanchez. I would like to call up Mr. Joseph Cruz...Mr. Cruz would you like to come up and testify or are you just here to support.

Mr. Joseph Cruz: To support.

<u>Chairperson:</u> Mr. Raymond Cruz are you here to testify or just support?

Mr. Raymond Cruz: To support.

<u>Chairperson:</u> Ms. Maria Santiago, are you here to testify or just support?

<u>Chairperson:</u> Mr. Andy Santiago, are you here to testify or just support?

Mr. Andy Santiago: Oral testimony.

Chairperson: Ms. Ruth Tajalle, are you here to testify or just support?

Ms. Ruth Tajalle: To support.

Chairperson: Mr. Tomas Tajalle, are you her to testify or just support?

Mr. Tomas Tajalle: Oral testimony.

<u>Chairperson:</u> Ok, please come up. Mr. Fred Gofigan, please come forward. Consige pot fabot Mr. Tajalle.

Mr. Andy Santiago: I'm here to testify in support of the bill. There's a lot of things that we have disregarded on that bridge. The safety factor is very important. This is one of the icons for our tourism. When the river flows under the bridge, it needs dredging. So I'm here to testify that we need to address this thing and get it started, not only for us here in Umatac but for our tourists. I've witnessed a lot of tourists stop by to take pictures. I hope that we get this bill passed and get the work started. Thank you!

<u>Chairperson:</u> Si Yu'os Ma'ase Mr. Santiago. Mr. Tajalle, consige pot fabot.

Mr. Tomas Tajalle: Thank you Madam Chair. Senator Morrison, Senator Ada thank you for coming down here. First of all, it's an honor to have all you three Senators down here to address our concern, it's a long time overdue. I have to agree with a lot of the testimonies but I have to bring up the most important part of this bridge project to address the safety concern that needs to be addressed immediately. There's definitely immediate action that needs to be taken on the sidewalk. My concern are we just looking at cosmetically repairing the bridge or the structural sound of the bridge? Listening to a lot of people before me, it's something to be proud of. As time goes on, they are talking that the bridge is kind of sliding and loosing its composure due to erosion. I am concerned that we are only appropriating only 300,000 without a full estimate of everything. I'm afraid that it may give way. I have to take this opportunity to talk about our cemetery as well. It's the only public cemetery I believe and I'm pleading with you to do something, especially you Madam Chair, to find it in your

heart to do something about our cemetery. I brought it up to our Historic Preservation people as well. As we go on with this project, I hope this is not the last time we hear from you guys. Thank you for coming down here to address this issue to us.

Chairperson: Thank you Mr. Tajalle. Mr. Gofigan...

Mr. Fred Gofigan: Thank you Madam Chair, Senator Ada, Senator Morrison. Thank you for allowing us to testify on this bill. My concerns are and I only have one question: there are 2 major projects here and one of them is being addressed and they are both coming from the same funding source, the Preservation Trust? Are they going to be jeopardized in any way?

<u>Chairperson:</u> Yes, they are coming from the same funding source, the Preservation Trust but this particular portion is a savings from one million dollar DOA demolition project.

Mr. Fred Gofigan: So that would not jeopardize. Ok, so I am in support of this bill.

<u>Chairperson:</u> Ok, thank you Mr. Gofigan. Mayor Morrison would you like to say a few words? Yes, please come forward.

Mayor Cecilia A. Morrison: Thank you very much for coming down to our village and helping out with the needs of our community. It's a long time coming for all this positive outcome and advocacy for this community and it's really appreciated. My name is Cecilia Aguon Quinata Morrison and former Mayor of Umatac and 1'm really enjoying the retirement! It's not often that we get this kind of attention and we are happy to see the response from our community. It's a welcoming piece of short law and this money is not going to lapse and hopefully we would be able to use all of it. I thank you very much again, Senator Ada, my old friend and sweetheart, Senator Muna Barnes and of course, Tommy. We are all in favor for this and your continued support for this community.

<u>Chairperson:</u> Si Yu'ose Ma'ase! I want to say that we are very grateful to be here this evening to talk about this bill. I want to say for the record that with all the assessments, the cost for repairs and renovation is about 270,000 plus but we cushioned it to 300,000 to make sure that things get done. We will be working closely with the Department of Public Works. I will ask this august body here and yield to Senator Morrison, at the

beginning of this public hearing, it was customary to open the record to the public for ten (10) days to accept public comments, however I'm going to ask permission if we can finish the report and submit it for next week's session next week Wednesday. I just need permission from this august body and my colleagues. Senator Morrison, I ask your permission.

<u>Senator Thomas Morrison:</u> Thank you Madam Chair and I know that you understand the time sensitivity of this project, with that Madam Chair, I approve.

Chairperson: Senator Tony Ada?

<u>Senator Tony Ada:</u> Thank you Madam Chair, for a moment there, I thought Senator Morrison was going to say no. (laughing) Madam Chair, I definitely would like to see this bill move forward and on session floor next week and have the Governor sign it into law and get this project started.

<u>Chairperson:</u> You have the commitment of our colleagues and I need the public's permission by clapping your hands. Crowd claps loudly. Is there anyone else here that would like to provide oral testimony. Please come up. Mr. Aquiningoc, before you start your testimony, please give us a few minutes to change the tape. Just for the public's information, we are recording this public hearing so that we could air this on the legislative channel for the public to view.

Mr. Manny Aquiningoc: Buenas noches Madam Chair, Senator Morrison and Senator Ada. My apologies for being late, my name is Manuel Aquiningoc and I was born and raised here in Umatac, although I am a resident of Santa Rita. I'm pretty familiar with the subject of the bill today. I'm in full support of the bill and I do agree with a lot of the testimony presented tonight. I hope that we do take advantage of the offer that Director Leon Guerrero indicated that with enough funding we could accomplish this in 90 days. The only question I have in mind here is, have we considered or thought about the maintenance? That's what happened with this structure. When it was completed there was no maintenance on it and that's why it's the way it is.

<u>Senator Thomas Morrison:</u> Thank you Uncle Manny and I will work with DPW and implement it going forward. That is a good question and I will work hand in hand with DPW and the Mayor.

Mr. Manny Aquiningoc: Thank you, I'd like that. I challenge the community of Umatac to assist as well, especially with respect to graffiti. I challenge the people here to take part in that ownership and if we don't, the structure will go back to looking the way it is now. Thank you!

Chairperson: Thank you!

Mr. Antonio Quinata: My name is Tony Quinata from Umatac and I would like to elaborate on the maintenance. Go stainless steel or aluminum and there's no maintenance on it, it will dilapidate. It's just like owning a new car and you service your car every six years, of course it's going to break down. We need to look at the safety purposes also. I am in support of this bill.

Chairperson: Thank you very much Quinata. Yes, Mr. Sanchez.

Mr. Frank Sanchez: There's only one thing I'm asking you all, is that you don't put amendment after amendment, please leave this bill as it is. It's fine and dandy and we will work with DPW to work on this bridge. Thank you!

<u>Chairperson:</u> Si Yu'os Ma'ase, Mr. Sanchez. Ladies and gentlemen, Guam Visitors Bureau has submitted testimony in support of this bill. Chairperson reads letter, which is attached for perusal. Guam Visitors Bureau is in full support of this bill and it will be appended to the committee report.

Ms. Dianna Quinata: I am an MPC member and I have one question: I fully support the bill and should it pass when would the construction go under way?

Chairperson: I will yield that to the Director of DPW.

Mr. Glenn Leon Guerrero: I just want to qualify that the 90 days is construction time and if all the materials are on Guam then we are assuming 90 days, that's 3 months. Once the Governor signs the bill into law, we do a change order with GPT and go out to bid and then begin.

Ms. Dianna Quinata: I just had to ask that because we are planning the Heritage festival so we kinda want to know when it comes to posting our activities. Thank you! I just want to say that Umatac is truly a jewel of Guam! When the tourist come here,

they always take pictures of the bridge, the bay, the church, the monument and I've pitched this to Senator Morrison already, make a monument of Big John. If you saw a picture of Big John, he's like our Piti guy with the carabao, everybody knows Big John and he represents Umatac. So it's just a suggestion. Thank you!

Chairperson: Duly noted. Mr. Quinata..

Mr. Rudy Quinata: Suggested to paint the bridge gray, because the people of Umatac is gracious. As long as the Mayor Johnny Quinata, the maintenance of the bridge will be taken care of.

Chairperson: Thank you Mr. Quinata. Senator Ada you have a comment?

<u>Senator Tony Ada:</u> Thank you Madam Chair. Mr. Tom Tajalle you had a concern regarding the Umatac Cemetery. About two (2) terms ago, the late former Speaker Ben Pangelinan introduced an amendement that appropriated 250,000 dollars. It did not go under the radar, but it is on our radar and other projects as well but we will continue to work with you as well as Senator Barnes and Senator Morrison and myself. Thank you Madam Chair.

<u>Senator Thomas Morrison:</u> Thank you again Madam Chair for holding this public hearing in Umatac so that our people can testify and support this bill.

<u>Chairperson:</u> You are very welcome Senator Morrison. This is a bi-partisan bill and we will continue to work together. I have made that commitment to have that committee report done and on the session floor next week.
