I. OVERVIEW

Bill No. 27-33 (COR) was introduced on January 21, 2015, by Senator Frank B. Aguon, Jr. The bill was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on January 22, 2015.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a public hearing on March 12, 2015, in *I Liheslatura*'s Public Hearing Room. Among the items on the hearing agenda was Bill No. 27-33 (COR). The hearing convened at 10:01 a.m. and was recessed at 11:57 a.m. The hearing reconvened at 2:03 p.m. and was adjourned at 5:35 p.m.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas: Next on the agenda we have Bill Number 27-33 introduced by Senator Frank Aguon, Jr. I will go ahead and yield the floor to Senator Aguon for Bill Number 27-33.

Senator Frank Aguon: Thank you very much Mr. Chairman and also thank you for conducting the public hearing on this particular measure. Mr. Chairman, just a little bit of history with regards to the origination of this concept, there were a number of employees who brought to the attention of my office in regards to the application of the merit bonuses all the way back to 1992 and when the original legislation was enacted, there were a couple or a few intermittent years, fiscal years, where in fact, any merit bonuses as well as, in two different situations, the adjustments, the pay adjustments, the incremental pay were deleted as a result of budgetary considerations at that time. So, this would allow for the intermittent years since 1992 in which public employees who performed in a superior status or outstanding the opportunity to be able to apply equity across the board so I think the title Mr. Chairman is very explanatory in terms to be able to apply equity all the way back to 1992 and I certainly hope this legislation would receive the support of not only from members of this legislative body but also from the chief executive. One thing I just have to say, is that I was hoping that a representative, if not, the acting Director of DOA would be able to provide testimony only because prior to proceeding with this particular legislation we certainly need to look at the hard numbers and understand exactly what the financial implications would be. So, Mr. Chairman, thank you again for having this public hearing. Thank you.

Chairman San Nicolas: Thank you again Senator Aguon. We have no individuals who indicated they are going testify for Bill Number 27-33. Bill 27-33 is considered heard.

Upon the payment of these 5 merit bonuses, it was brought to the attention of I Liheslaturan Guahan that such 6 payments were restricted in fiscal year 2002 by Public Law No. 26-35, Chapter IV, 7 Section 4(a), due to the implementation of cost containment measures. I8 9 Liheslaturan Guahan further finds that it is estimated that over 1200 outstanding public employees may have been directly affected by the legal restriction outlined 10 above. 11 Therefore, it is the intent of I Liheslaturan Guahan to authorize I 12 Maga'lahen Guahan to make such merit bonus payments to the public employees 13

Notwithstanding any other provision of law, the compensation of public employees for meritorious ratings in accordance with §6203 of Title 4, Guam Code Annotated, for fiscal year 2002, is hereby authorized.

Section 3. Identification of Funding Source. I Maga'lahen Guahan in carrying out the provision contained in Section 2 of this Act shall utilize his transfer authority as provided for in Section 9, Chapter VIII, of Public Law No. 32-181, in identifying funds necessary to effectuate the authorization contained in the previous section of this Act.

Section 4. Reporting Requirement. The Director of the Department of Administration shall report to *I Maga'lahen Guahan* and the Speaker of *I Liheslaturan Guahan* no later than Ten (10) days following the initial implementation of any payments authorized in Section 2 above, and every Thirty (30) days thereafter, until such time full compliance with Section 2 of this Act is accomplished. Such report shall include the identification of the funding source or sources, and the date of remittance of such payments.

Section 5. Alternative Course of Action for the Implementation of Section 2 of this Act. Should *I Maga lahen Guahan* be unable to identify a funding source and implement the provision contained in Section 2 of this Act by July 1, 2015, he shall present to the Speaker and the Chairman of the Committee on Appropriations and Adjudication of *I Mina Trentai Tres Na Liheslaturan Guahan* a written plan highlighting a course of action and/or recommendation for addressing the intent of this Act. Such plan shall be presented no later than the date highlighted within this Section.

Section 6. Effective Date. The provisions contained within this Act shall be effective upon enactment.

Section 7. Severability Clause. If any provision of this Law or its application to any person or circumstance is found to be invalid, or contrary to law, such invalidity *shall not* affect other provisions or applications of this Law which can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.

Comments on Bill No. 27-33 (COR)

This intent of the proposed legislation is to recognize public employees with superior rating in Fiscal Year 2002 not compensated for meritorious performance in accordance with the provisions contained in § 6203, Title 4, GCA; authorizing the application of the merit bonus program for Fiscal Year 2002 and providing for such payment. The legislation will authorize *I Maga'lahen Guahan* to make merit bonus payments to those public employees by utilizing his transfer authority as provided in Section 9, Chapter XIII of P.L. 32-181.

Based on information obtained from the Department of Administration's Human Resources Division, the total count of employees affected is 409, estimated impact of FY2002 merit bonuses is approximately \$508,385. However, this amount does not factor in salary increments that were frozen in FY1996 and FY2002. Had increments been factored into such merit bonus payments for affected employees, overall cost would exceed \$508K.
