COMMITTEE REPORT DIGEST

I. OVERVIEW

Bill No. 293-33 (COR) was introduced on April 12, 2016, by Speaker Judith Won Pat, and Senators Tina Muna Barnes, Rory Respicio, Nerissa Underwood, and Tommy Morrison. The bill was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on April 12, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a public hearing on May 13, 2016, in *I Liheslatura's* Public Hearing Room. The only item on the hearing agenda was Bill No. 293-33 (COR). The hearing convened at 1:08 p.m. and was adjourned at 1:37 p.m.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas yielded the floor to Speaker Judith Won Pat to offer an opening statement on Bill No. 293-33.

Speaker Won Pat stated that the bill would authorize the deposit of money from dormant or inactive government accounts into the Housing Trust Funds to be used for the First-Time Homeowner's Assistance Program. She explained the establishment of the Housing Trust Fund and how it has helped many Guam families. She asked for favorable support for the bill.

Valerie Kaipat spoke in favor of the bill. She explained that her family are recipients of the program and are almost complete in obtaining their home. However, she further explained that she was informed of the unavailability of program funds and that Bill 293 will help with that issue.

Carlos Camacho spoke in favor of the bill. He stated that the bill will help in an area of the government that has limited financial resources. He believes that this bill will go a long way to help families realize home ownership. He explained how the homeowners' assistance program helps families with various costs that come with first-time home ownership including closing costs, insurance, and utilities. Mr. Camacho stated that the government of Guam needs to look into more sustainable funding sources for the program so that families can benefit in the future.

Joseph Diego spoke in favor of the bill. He stated that he works with USDA Rural Development and they administer a first-time homeowners' assistance program that works with the government of Guam. He understands the financial constraints that many families still face with owning a home and believes that any assistance they can receive will be beneficial.

Maria Miller spoke in support of the bill. She stated that the additional financial assistance will help many families realize home ownership.

Chairman San Nicolas clarified that the bill does not appropriate additional government funding but rather takes money that is already sitting in dormant or inactive accounts and makes it available to be used for the housing program. He stated that the Guam Housing Corporation submitted written testimony.

Speaker Won Pat thanked the public for their support. She commended Ms. Kaipat for sharing her first-hand account as an applicant and eventual recipient. She thanked the other people testifying for sharing their expertise in the housing and real estate markets and explaining how the housing program helps so many people. Speaker Won Pat further thanked the individuals in attendance for their support of the bill.

Chairman San Nicolas thanked all in attendance for their participation and indicated that the Committee will work to move the bill at the next session. Without other individuals present to testify, Chairman San Nicolas concluded the hearing for Bill 293-33.

III. FINDINGS AND RECOMMENDATIONS

At the request of the primary sponsor, an amended version of Bill 293-33 (COR) is being submitted.

The Committee on Finance & Taxation, General Government Operations, and Youth Development hereby reports out Bill No. 293-33 (COR), as amended by the Committee, with the recommendation TO DO PASS.

Testimonial with respect to Bill 293-33:

This Housing Trust Fund program is NOT a new concept; it was first set in place as far back as 1986 in some of the major housing markets across the country whereas Guam Housing Corporation has been trying to initiate this concept here since around 2000 while addressing it with greater emphasis to the public and private business over the past three or four years. It has taken a great exercise to get it to this point locally.

The first attempt at initiating this program here was with the establishment of the “First Time Homeowner Relief Program Act” of 1998 by the late Senator Ben Pangelinan and Senator Judith WonPat, P.L.24-180, however it was short lived as the funding source dried up after only six months. The funding for this program was through the General Fund and it demonstrated in short order that it was not sustainable .

This program was re-introduced through “The Housing Trust Fund Act” in January 2012 again by the late Senator Ben Pangelinan; P.L.31-166 and P.L 31-227 with, limited funds through Guam Housing Corporation’s operations, the account it uses to provide mortgage loans to its borrowers, which also could not continue, again these funds were exhausted in less than six months.

The Speaker, Dr. Judith P. WonPat was successful in finding another source of funding through the use of escheated funds, P.L.32-036, though limited again, however did allow the program to continue for a short time longer, it is again unfunded.

This program has been put into place three times so far and each time they were short lived, Guam Housing Corporation is once again unable to move this program forward, this means it has started and stopped three times, this will be the fourth attempt to fund this program, will we be back here again in a few months? The Guam Housing Corporation has provided solutions to help fund this program as well as to address the many other housing needs.

It is clear by the successes of this program, the Housing Trust Fund initiative has recognized that there is a need to support the accessibility and affordability of housing for the residents of Guam, and to finance support services that assist low to moderate income households in obtaining and maintaining affordable housing.

The positive economic impact on the housing market with only the single program on the three periods that had been funded so far has brought over \$ 73,865,315.00 in Real Estate, Banking, Escrow, Appraisers, and Title Insurance activity not to mention the trickle down economic expansion, while placing over 489 families in homes.(the \$ 2,954,612, The First-Time Home-owner's Assistance Act as funded through the Housing Trust Fund Act).

There are so many other problems that go well beyond first time homeowner assistance, as addressed in the Housing Trust Fund Administrative Rules (as proposed), we also need to secure lending capital for borrowers whom cannot find financing elsewhere, also we need to find solutions to help the Island's homeless families, there are families with children living in unfavorable conditions, squalors, a situation that should not be tolerated, with your help we can help them, we need funds to offset the Guam Housing Corporation's costs to administer these programs.

Guam cannot rely on the federal programs to sustain our local housing programs, we need to establish a *continual* revenue source to support our lower income families.

Yes we are clearly in favor of this Program and this Bill as it does address an additional funding source, it is a short term fix until a longer term, more fluid permanent funding solution can be addressed. The funding provided by this bill would allow the First-Time Home-Owner Assistance program to continue for about another nine to ten months.

Through this Bill 293-33 the Guam Housing Corporation could assist approximately 95 more families in fulfilling their dream of homeownership while putting another \$ 17 and a half million dollars into the economy.

The corporation currently has reservations for 24 more first time home buyers at approximately \$ 183,600.

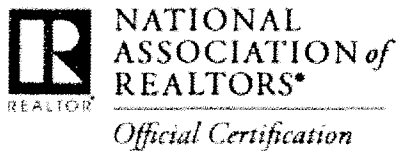

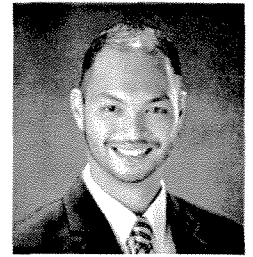
