

Thank you Mr. Chair for being expeditious to hear this bill. This bill is in fact, an adoption of the Family Medical Leave Act. It has twelve co-sponsors and I this is the time to hear what people in the public have to say. It is a much needed bill that is crafted for the specific environment of Guam and I do think it is a win-win situation for the government, the private sector and all employees of Guam. Hopefully we can get some support. We have a lot of support in the Legislature and I hope we can get some support from the public and I hope think can be a law one day. Thank you.

I just wanted to say that I agree with Anna, even those in the medical community who are part-time, I've heard of incidences where my son works, the girl who does payroll and accounting is a full-time, she couldn't take FMLA and ended up quitting just to take care of her dying father. She was denied FMLA.

#### Chairman Respicio

You signed up on behalf of the IAM United Organization?

#### Ms. Terlaje

Yes.

#### Chairman Respicio

Can you give the listening audience an idea what this organization is?

#### Mrs. Tupaz

I am a United Airlines employee and have been there for over twenty years as part-time employees. We are part of a union called "IAMW" which is "International Association of Machinist Airspace Workers" and we've been trying to put this under our contract but there are more pressing issues such as job security on our island.

#### Senator McCreadie

Mr. Chair, just so we are clear, when you go to Department of Labor, they don't consider an employee part-time or full-time, they consider the hours. One of the biggest differences in the federal FMLA, what we are trying to adopt, are those hours, 1,250 threshold. We are lowing that to 1,000. It's 50 employees minimum. We are lowering the threshold to 25. And we are also incorporating "in-laws" of married couples and immediate family members as well. FMLA encourages states that's even better than what they have. We are creating something that is specific to Guam.

Chairman Respicio thanked the panel for testifying and the senators present at the hearing.

# § 3602. Eligibility Requirements.

7 Except as provided in subparagraph (b) of this section, it shall be an (a) 8 unlawful employment practice for any employer, as defined in §3603(c), to 9 refuse to grant a request by any employee with more than 12 months of service with the employer, and who has at least 1,000 hours of service with the 1011 employer during the previous 12-month period, to take up to a total of 12 12 workweeks in any 12-month period for family care and medical leave. Family 13 care and medical leave requested pursuant to this subparagraph shall not be 14 deemed to have been granted unless the employer provides the employee, upon 15 granting the leave request, a guarantee of employment in the same or a 16 comparable position upon the termination of the leave.

- (1) In any case in which the necessity for leave as defined under
  § 3603(c)(1) is foreseeable based on an expected birth or placement, the
  employee shall provide the employer with not less than 30 days' notice,
  before the date the leave is to begin, of the employee's intention to take
  leave under such subparagraph, except that if the date of the birth or
  placement requires leave to begin in less than 30 days, the employee
  shall provide such notice as is practicable.
- (2) In any case in which the necessity for leave as defined under
   §§ 3603(c)(2) or 3603(c)(3) is foreseeable based on planned medical
   treatment, the employee:

- (A) Shall make a reasonable effort to schedule the treatment so as
  not to disrupt unduly the operations of the employer, subject to
  the approval of the health care provider of the employee or the
  health care provider of the son, daughter, spouse, or parent of
  the employee, or health care provider of the parent, son, or
  daughter of an employee's spouse, as appropriate; and
- (B) Shall provide the employer with not less than 30 days' notice,
  before the date the leave is to begin, of the employee's
  intention to take leave under such subparagraph, except that if
  the date of the treatment requires leave to begin in less than 30
  days, the employee shall provide such notice as is practicable.

(b) Notwithstanding subparagraph (a) of this section, it shall *not* be an
unlawful employment practice for an employer to refuse to grant a request for
family care and medical leave by an employee if the employer employs fewer
than 25 employees in Guam.

16 § 3603. Definitions.

17 For the purposes of this Article 6:

- (a) "Child" means a biological, adopted, or foster child, a stepchild, a legal
  ward, or a child of a person standing in loco parentis who is either of the
  following:
- 21 (1) Under 18 years of age.
- 22 (2) An adult dependent child.
- 23 (b) "Employer" means either of the following:
- 24 (1) Any person (including any individual, association, partnership,
  25 corporation, company, entity, or organized group of persons acting
  26 directly or indirectly in the interest of an employer in relation to an

employee) who directly employs 25 or more persons to perform services
 for a wage or salary.

20	(a) An employer shall not be required to pay an employee for any leave take
21	pursuant to §3602(a), except as required by subparagraph (b) of this section.
22	(b) An employee taking a leave permitted by §3602(a) may elect, or an
23	employer may require the employee, to substitute, for leave allowed under
24	§3602(a), any of the employee's accrued vacation leave or other accrued time

8 During any period that an eligible employee takes leave pursuant to (a) 9 \$3602(a) or takes leave that qualifies as leave under the FMLA, the employer 10shall maintain and pay for coverage under a "group health plan," as defined in 11 Section 5000(b)(1) of the Internal Revenue Code, for the duration of the leave, 12 not to exceed 12 workweeks in a 12-month period, commencing on the date 13 leave taken under the FMLA or under §3602(a) commences, at the level and under the conditions coverage, if any, would have been provided if the 14 15 employee has continued in employment continuously for the duration of the leave; provided that the employee shall continue to pay for the employee's 16 17 share of insurance premiums at the same level that would have applied if the 18 employee has continued in employment continuously for the duration of the 19 Nothing in the preceding sentence shall preclude an employer from leave. 20 maintaining and paying for coverage under a "group health plan" beyond 12 21workweeks. An employer may recover the premium that the employer paid as required by this subsection for maintaining coverage for the employee under the 22 23 group health plan if both of the following conditions occur:

24 25 (1) The employee fails to return from leave after the period of leave to which the employee is entitled has expired.

(2) The employee's failure to return from leave is for a reason other than
 the continuation, recurrence, or onset of a serious health condition that
 entitles the employee to leave under §3602(a) or other circumstances
 beyond the control of the employee.

5 Any employee taking leave pursuant to §3602(a) shall continue to be (b)6 entitled to participate in employee health plans for any period during which 7 coverage is not provided by the employer under §3605(a), employee benefit 8 plans, including life insurance or short-term or long-term disability or accident 9 insurance, pension and retirement plans, and supplemental unemployment 10 benefit plans to the same extent and under the same conditions as apply to an 11 unpaid leave taken for any purpose other than those described in §3602(a). In 12 the absence of these conditions an employee shall continue to be entitled to 13 participate in these plans and, in the case of health and welfare employee 14 benefit plans, including life insurance or short-term or long-term disability or 15 accident insurance, or other similar plans, the employer may, at his or her discretion, require the employee to pay premiums, at the group rate, during the 16 17period of leave not covered by any accrued vacation leave, or other accrued 18 time off, or any other paid or unpaid time off negotiated with the employer, as a 19 condition of continued coverage during the leave period. However, except as 20 otherwise provided in this Article or subparagraph (c) of this section, the 21 nonpayment of premiums by an employee shall not constitute a break in 22 service, for purposes of longevity, seniority under any collective bargaining 23 agreement, or any employee benefit plan.

(c) For purposes of pension and retirement plans, an employer shall not be
 required to make employer or employee contribution payments during the
 period of unpaid leave, and the unpaid leave period during which plan payments

are not made shall not be required to be counted for purposes of time accrued under the plan. However, an employee covered by a pension or retirement plan may continue to make contributions at his or her own expense in accordance with the terms of the plan during the period of the unpaid leave, and the employer may make corresponding employer contributions if required in accordance with the terms of the plan.

(d) During a family care and medical leave period, the employee shall retain employee status with the employer, and the leave shall not constitute a break in service, for purposes of longevity, seniority under any collective bargaining agreement, or any employee benefit plan. An employee returning from leave shall return with no less seniority than the employee had when the leave commenced, for purposes of layoff, recall, promotion, job assignment, and seniority-related benefits such as vacation.

# § 3606. Certification of Leave to Care for Child, Spouse, or Parent.

(a) An employer may require that an employee's request for leave to care for a child, a spouse, or a parent who has a serious health condition be supported by a certification issued by the health care provider of the individual requiring care. That certification shall be sufficient if it includes all of the following:

(1) The date on which the serious health condition commenced.

- (2) The probable duration of the condition.
- (3) An estimate of the amount of time that the health care provider believes the employee needs to care or the individual requiring the care.
- (4) A statement that the serious health condition warrants the
   participation of a family member to provide care during a period of the
   treatment or supervision of the individual requiring care.

(b) Upon expiration of the time estimated by the health care provider in
§3606(a)(3), the employer may require the employee to obtain recertification, in

1 employer's expense, that the employee obtain the opinion of a third health care 2 provider, designated or approved jointly by the employee and the employee, 3 concerning the information certified under §3607(a).

4 (f)The opinion of the third health care provider concerning the information 5 certified under §3607(a) shall be considered to be final and shall be binding on the employer and the employee. 6

7 As a condition of an employee's return from leave taken because of the (g)employee's own serious health condition, the employer may have a uniformly 8 9 applied practice or policy that requires the employee to obtain certification from his or her health care provider that the employee is able to resume work. 1011 Nothing in this paragraph shall supersede a valid collective bargaining 12 agreement that governs the return to work of that employee.

# § 3608. Miscellaneous Provisions

It shall be an unlawful employment practice for an employer to refuse to 14 (a) 15 hire, or to discharge, fine, suspend, expel, or discriminate against, any 16 individual because of any of the following:

- 17 (1) An individual's exercise of the right to family care and medical leave 18 provided by §3602(a).
- 19 (2) An individual's giving information or testimony as to his or her own family care and medical leave, or another person's family care and 2021medical leave, in any inquiry or proceeding related to rights guaranteed 22 under this section.
- 23 This Article shall not be construed to require any changes in existing (b)24 collective bargaining agreements during the life of the contract.
- 25Leave provided for pursuant to this Article may be taken in one or more (d)26 periods. The 12-month period during which 12 workweeks of leave may be

1 taken under this Article shall run concurrently with the 12-month period under 2 the FMLA, and shall commence on the date leave taken under the FMLA 3 commences.

4 In any case in which both parents entitled to leave under §3602(a) are (e)5 employed by the same employer, the employer shall not be required to grant 6 leave in connection with the birth, adoption, or foster care of child that would 7 allow the parents family care and medical leave totaling more than the amount 8 specified in §3602(a).

# § 3609. Reinstatement.

- 10Notwithstanding §3602(a), an employer may refuse to reinstate an (a) 11 employee returning from leave to the same or a comparable position if all of the 12 following apply:
- 13 (1) The employee is a salaried employee who is among the highest paid 14 10 percent of the employer's employees employed on Guam.
- 15 (2) The refusal is necessary to prevent substantial and grievous economic 16 injury to the operations of the employer.
- 17 (3) The employer notifies the employee of the intent to refuse reinstatement at the time the employer determines the refusal is 18 19 necessary under \$3609(a)(2).
- 20(b)In any case in which the leave has already commenced, the employer 21 shall give the employee a reasonable opportunity to return to work following the notice prescribed by \$3609(a)(3). 22
- 23 Leave taken by an employee pursuant to this Article shall run (c)concurrently with leave taken pursuant to the FMLA, or with other non-FMLA 24 25 leave taken pursuant to the employer's leave policies if such leave also qualifies 26 for leave pursuant to this Article. The aggregate amount of leave taken

pursuant to this Article or the FMLA, or both, shall not exceed 12 workweeks 1 2 in a 12-month period. The aggregate amount of leave taken pursuant to this 3 Article or other non-FMLA leave taken pursuant to the employer's leave policies if such leave also qualifies for leave pursuant to this Article, or both, 4 5 shall not exceed the greater of 12 workweeks in a 12-month period, or the 6 maximum amount allowed for the non-FMLA leave taken pursuant to the 7 employer's leave policies. It shall be an unlawful employment practice for an employer to interfere 8 (d)with, restrain, or deny the exercise of, or the attempt to exercise, any right 9 10provided under this Article." (1) The employee shall utilize existing vacation, personal leave, or 10(b)11 compensatory time off for purposes of the planned absence authorized by this 12 section, unless otherwise provided by a collective bargaining agreement. An employee also may utilize time off without pay for this purpose, to the extent 13 14 made available by his or her employer.

15 (2) Notwithstanding paragraph (1), in the event that all permanent, full-16 time employees of an employer are accorded vacation during the same period of 17time in the calendar year, an employee of that employer may not utilize that 18accrued vacation benefit at any other time for purposes of the planned absence authorized by this section. 19

20The employee, if requested by the employer, shall provide documentation (c)from the school or licensed child care provider as proof that he or she engaged 21 22 in child-related activities permitted in subdivision (a) on a specific date and at a 23 particular time. For purposes of this subdivision, "documentation" means 24 whatever written verification of parental participation the school or licensed 25 child care provider deems appropriate and reasonable.

1 (d) No employer shall discharge, threaten to discharge, demote, suspend, or 2 in any other manner discriminate against an employee in terms and conditions of employment because the employee has taken time off to engage in child-3 4 related activities permitted in subdivision (a). An employer who has been found in a grievance procedure, arbitration, or court proceeding to have violated 5 this subsection shall be required, if applicable, to reinstate or promote the 6 7 affected employee, and shall be liable to the affected employee for an amount 8 equal to three times the employee's lost wages and work benefits, in addition to 9 actual lost wages and benefits and other damages to which the employee may 10be entitled."

# Section 3. Effective Date. The provisions of this Act *shall* become effective upon enactment.

13 Section 4. Severability. *If* any provision of this Law or its application to any 14 person or circumstance is found to be invalid or contrary to law, such invalidity shall 15 *not* affect other provisions or applications of this Law which can be given effect 16 without the invalid provisions or application, and to this end the provisions of this Act 17 are severable.

Hafa Adai Senators, my name is Anna Alegre-Tupaz. I am here today to express my gratitude to Senator Brant McCreadie and the 12 other Senators who have proposed Bill 298-33 that will allow Guam working family workers a chance to qualify for FMLA to care for their health as well as their family members.

What started out as a personal quest for myself turned into a crusade after finding out that like me, my fellow part time coworker was denied FMLA by few hours to reach the 1250 hour threshold to qualify for FMLA. In another instance, a friend who works within the hotel industry was afraid to take leave to care for her toddler's illnesses in fear that she would lose her job, as she too, fell woefully shy of the minimum number of hours worked to qualify for FMLA. We aren't part-timers who just joined their respective companies. We are loyal and dedicated employees who have been with our companies for at least 15-20 years.

One thing I would like to ask you to consider as well would be to ensure that employers of Guam recognize that jury duty counts towards qualifying hours under the FMLA law. Left to interpretation, companies may not recognize this key civic duty and may not include it in the qualifying hours needed to meet the minimum hours under the FMLA provisions.

Honorable Senators, with your help, this bill would allow the working people of our island to qualify much easier for FMLA and would alleviate the stress of leaving their job in order to care and provide for their families or to participate in their civic duties.

I want to thank you for this opportunity to provide my testimony today and pray that this bill will become law, also I thank all of you for your service to our island and our people.

Also, most businesses excludes hours taken for vacation and sick which will dramatically drop the hours worked.

To allow any court summoned appearance and or duty such as petit, grand jury and subpoenas to be part of qualifying hours to determine eligibility for family leave, as this was the case that lead me to this quest. I was recently denied FMLA because my company did not include my jury duty hours to qualify for the leave.

#### Comments on Bill No. 298-33 (COR)

The intent of the proposed legislation is to add two (2) new Articles, Article 6 and 7 to Chapter 3, Title 22 of the Guam Code Annotated. The Article 6 is relative to the Guam Family Medical Leave Act; and Article 7 is relative to Child School-Related Leave.

Section 1, Article 6 §3602 relative to the Eligibility Requirements (a), reduces the number of hours of service with the employer from 1,250 hours as stated on the U.S. Department of Labor, Family Medical Leave Act (FMLA) to 1,000 hours to take up to a total of 12 workweeks in any 12 month period for family care and medical leave. This is a difference of 250 hours which equates to approximately 31 work days less to qualify. Eligibility Requirements (b), reduces the number of employees an employer employs to grant the request for FMLA from 50 to fewer than 25 employees and shall not be unlawful for an employer to refuse to grant such request.

Section 2, Article 7 §3703 adds the Leave for Child School-Related Purposes. §3703 (a) (1) relative to the Leave for child school-related purposes, an employer shall not discharge or discriminate against an employee who is a parent of one or more children to take up to 40 hours each year for the following child-related activities; to enroll or reenroll the child in school or licensed child care provider or to participate in the activities, and to address a child care provider or school emergency

Should the Bill become law it will establish the Guam Family Medical Leave Act similar to the U.S. Department of Labor, Family Medical Leave Act and the Child School-Related Leave Act similar to the Parental Involvement created via E.O. 98-20. There will be a financial impact on the Government of Guam which cannot be determined at this time absent additional information from the Department of Administration.

However, it should be noted that should department heads fill positions left temporarily vacant by employees who take leave pursuant to provisions therein, detailed employees who serve beyond thirty (30) days are compensable for that period pursuant to the Government of Guam's Personnel Rules and Regulations.
