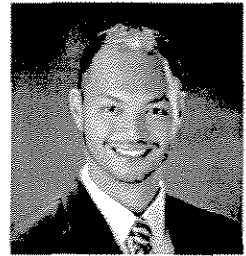

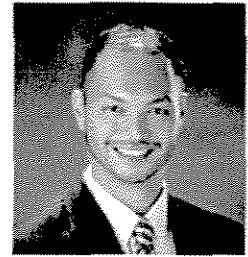

## COMMITTEE REPORT DIGEST

### **I. OVERVIEW**

Bill No. 3-33 (LS) was introduced on January 5, 2015, by Senators Tommy Morrison, Rory Respicio, and Brant McCreadie. The bill was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on January 6, 2015.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a public hearing on March 12, 2015, in *I Liheslatura's* Public Hearing Room. Among the items on the hearing agenda was Bill No. 3-33 (LS). The hearing convened at 10:01 a.m. and was recessed at 11:57 a.m. The hearing reconvened at 2:03 p.m. and was adjourned at 5:35 p.m.

**II. TESTIMONY & DISCUSSION**

Chairman Michael San Nicolas recognized Senator Tommy Morrison and offered that he provide brief opening remarks as the main sponsor of Bill No. 3-33 (LS).

Senator Morrison thanked Chairman San Nicolas for including the legislation on the public hearing agenda as the measure seeks to build upon the success of P.L. 32-60. According to Senator Morrison, Bill No. 3-33 (LS) was introduced at the request of Guam's mayors and vice-mayors, and officials from both the Department of Education and Department of Parks and Recreation. He offered that the legislation recognizes that some of Guam's youth and families who wish to use the different community recreational facilities have little to no access to basic sports supplies. Senator Morrison stated that the measure, if enacted, would support a long tradition on Guam where community recreational facilities serve as venues for youth and families to engage in safe and healthy activities.

Mr. Ray Blas and Mr. Bill Reyes followed by thanking the Committee for the opportunity to submit testimony in full support of the legislation. Director Blas, however, requested for the Committee to consider amending the bill to authorize his agency to procure vehicles to support the maintenance and operational needs of various parks and recreational facilities throughout the island.

Chairman San Nicolas thanked Mr. Blas and Mr. Reyes for their comments and then recognized Senator Frank Aguon, Jr. regarding a question for panel members.

Senator Frank Aguon, Jr. asked Mr. Blas if he would be open to the idea of implementing a limit on the amount of funds that may be used by his agency to purchase the necessary vehicles. Mr. Blas replied that he doesn't intend to purchase a fleet, but instead would procure a couple or a few vehicles that he expects would last for a long period of time.

Senator Aguon thanked Mr. Blas for his comments and offered that the idea of limiting the amount of funds mayors and Guam's parks agency may use to purchase vehicles and sports equipment would ensure that the funding source established by P.L. 32-60 remains available for its intended purpose – to repair existing sports and community recreational facilities.

Chairman San Nicolas followed by agreeing with the comments made by Senator Aguon regarding the need to limit the amount of funds that may be used to procure sports equipment, vehicles, and other items or services that may not be aligned with the original intent of P.L. 32-60.

Chairman San Nicolas proceeded to invite several mayors and vice-mayors to offer testimony on Bill No. 3-33 (LS). Included in the panel was Mr. Angel Sablan.

Mayor Rudy Matanane thanked the Committee for the opportunity to provide testimony in favor of the legislation. He shared that his village remains very active in supporting a variety of sports teams, despite the limited availability of community recreational facilities. Mayor Matanane concluded his testimony by suggesting that the legislature consider ways to protect the investments made through P.L. 32-60 from vandals and others who have no respect for the hard work and money that are put into developing these community facilities.

Mayor Ernest Chargualaf followed by sharing that in his seven years serving as mayor, he's had to deal with figuring out ways to support as many youth sports teams that request for sponsorships and/or assistance with the purchase of their uniforms and other sports equipment. Mayor Chargualaf informed the Committee that he continues to use his personal funds, in addition to the limited government funds assigned to his office, to help fund the needs of different sports groups that approach him for assistance. Mayor Chargualaf urged Committee members to act favorably on the measure as it would provide a level of flexibility for mayors to support sports teams – while repairing existing community recreational facilities.

Mayor Doris Lujan spoke briefly in support of Bill No. 3-33 (LS). Mayor Lujan shared that it was just this past fiscal year when her office and Municipal Planning Council were able to use funds made available from the Layon Landfill to help sponsor little league teams in her village.

Mayor Vicente Gumataotao also spoke briefly in support of the measure with the exception of how funds from P.L. 32-60 are divided among the Mayors' Council of Guam, the Department of Education, and the Department of Parks and Recreation. Mayor Gumataotao urged the Committee to consider dividing fund proceeds equally between mayors and the Department of Parks and Recreation.

Before providing his testimony, Mr. Sablan read into the record the respective comments of Mayor Paul McDonald and Mayor Robert Hoffman. Mayor McDonald, who also serves as the President of the Mayors' Council of Guam, submitted written testimony in favor of Bill No. 3-33 (LS), offering that the measure helps to promote safe and healthy alternatives for village teens.

Written comments submitted by Mayor Hoffman recognized the great strides that have been made by his village to transform the condition of various facilities at the Sinajana Community

Center that help to meet the needs of sports teams, adult high school students, and members of various non-profit organizations. Mayor Hoffman recommended for the Committee to consider amending the bill to allow funds to be used to support team sponsorships; authorize the procurement of computer equipment, musical instruments and similar items supporting the performing arts; and, permit the use of P.L. 32-60 proceeds as matching funds for federal grants. Mayor Hoffman's written testimony concluded by thanking the bill's sponsors for helping to recognize the importance of promoting active and healthy lifestyle programs within our villages, which would ultimately result in a decline in various crimes – as evidenced in his village.

Mr. Sablan proceeded by commenting in support of Bill No. 3-33 (LS) and recognized the challenges faced by Guam's mayors in trying to stretch limited public funds in order to meet the needs of various sports teams. Mr. Sablan informed the Committee that with an average distribution of twelve to thirteen thousand dollars (\$12,000 -\$13,000) to each village, mayors find it extremely difficult to secure contractors that are willing to repair different community recreational facilities. A number of mayors are left with no other choice but to save their allotments in order to build fund balances that are adequate for construction activities to occur.

According to Mr. Sablan, one hundred sixteen thousand dollars (\$116,000) from different sources was used by mayors in the previous fiscal year to sponsor youth teams and uniforms and to pay for the management of league which included the cost for umpire referee services. Mr. Sablan commented that while it would be great to have all of our community recreational in beautiful condition, it would be devastating to see these fields and courts empty because youth sports teams weren't able to afford uniforms and other basic sports equipment and supplies.

Vice Mayor Ken Santos followed by offering brief remarks in support of Bill No. 3-33 (LS). Vice Mayor Santos commented that as a baseball coach for over thirty four (34) years, he received little to no support from the government of Guam. He shared his excitement and optimism that the opportunities offered by the measure would encourage greater interest by Guam's youth in sports and other healthy lifestyle activities.

Chairman San Nicolas thanked Vice Mayor Santos for his testimony and then recognized Senator Nerissa Underwood, Ph.D. who had a question for Mayor Gumataotao regarding how funds proceeds should be divided. Mayor Gumataotao responded by suggesting that funds be evenly divided among nineteen (19) mayors with the Department of Parks and Recreation receiving one twentieth (1/20) of funds proceeds.

Chairman San Nicolas then recognized Senator Morrison for some additional comments surrounding the distribution of fund proceeds. Senator Morrison shared that the original plan at the time P.L. 32-60 was under consideration included the possibility of dedicating most of the proceeds to village mayors. However, according to Senator Morrison, this idea did not receive enough support. Senator Morrison proceeded by sharing an example in the Municipality of Barrigada where the village has partnered with the Department of Parks and Recreation to help address some of the needs of our youth sports teams. Between facilities available at Tiyan and the Barrigada Mayor's Office, youth sports teams have options on how and where to best conduct practices, clinics, and similar activities.



Mayor Dale Alvarez and Mayor Joanna Margaret Blas concluded the presentation by Guam's mayors in favor of Bill No. 3-33 (LS). Mayor Alvarez spoke briefly about the challenges he faced previously in attempting to gain funding and maintenance support from the Department of Parks and Recreation in order to repair community recreational facilities in his village. Mayor Blas commented that while her village currently doesn't have major recreational facilities, her office continues to find ways to help in the development of youth sports programs for the benefit of families residing in Asan-Maina.

Chairman San Nicolas thanked Mayors Alvarez and Blas and other panel members for providing testimony relative to Bill No. 3-33 (LS). Chairman San Nicolas concluded the hearing by stating that the Committee would take all comments into consideration as amendments are made to the bill. Chairman San Nicolas reiterated the importance of ensuring that the measure, as amended, maintains the essence of P.L. 32-60 and that repairs to community recreational facilities remain a priority.

### **III. FINDINGS AND RECOMMENDATIONS**

The Committee on Finance & Taxation, General Government Operations, and Youth Development hereby reports out Bill No. 3-33 (LS), as corrected by the prime sponsor and further amended by the Committee, with the recommendation TO PASS.

**“§ 5204. Limited Gaming Fund.**

(a) There is hereby created, separate and apart from other funds of the government of Guam, a fund to be known as the Limited Gaming Fund. All license fees, taxes and penalties collected under this Act *shall* be deposited in the Fund. The Fund *shall not* be commingled with the General Fund, except as indicated herein, *shall* be kept in a separate bank account, and *shall not* be used as a pledge of security or as collateral for government loans. The Director of Administration *shall* make an itemized quarterly report to *I Maga'lahaen Guáhan* (the Governor of Guam), and *I Liheslaturan Guáhan*, of the condition of, and a detailed description of all financial

1 activity within, the Fund. The Director of Administration *shall* further make  
2 an itemized annual report, which *shall* be made available to the general  
3 public.

4 (b) The Fund *shall* be used for the purpose of the administration of  
5 this Act, and as otherwise stated herein. *No more than* five percent of the

**1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

**2 Section 1.** A new § 5204(f) of Article 2 of Chapter 5, Title 11, Guam Code  
**3** Annotated, is hereby *added* to read:

**4 “§ 5204.Limited Gaming Fund.**

**5** (a) There is hereby created, separate and apart from other funds of the  
**6** government of Guam, a fund to be known as the Limited Gaming Fund. All  
**7** license fees, taxes and penalties collected under this Act *shall* be deposited  
**8** in the Fund. The Fund *shall not* be commingled with the General Fund,  
**9** except as indicated herein, *shall* be kept in a separate bank account, and  
**10** *shall not* be used as a pledge of security or as collateral for government  
**11** loans. The Director of Administration *shall* make an itemized quarterly  
**12** report to *I Maga'lahaen Guåhan* (the Governor of Guam), and *I Liheslaturan*  
**13** *Guåhan*, of the condition of, and a detailed description of all financial  
**14** activity within, the Fund. The Director of Administration *shall* further make



1 an itemized annual report, which *shall* be made available to the general  
2 public.

3 (b) The Fund *shall* be used for the purpose of the administration of  
4 this Act, and as otherwise stated herein. *No more than* five percent of the  
5 fund balance may be expended for this purpose, and funds *shall not* be  
6 expended for personnel costs. Said Fund *shall* be examined and reported  
7 upon by the Director of Administration as required by law.

8 (c) No claim for the payment of any expense incurred by the  
9 Department or any other agency in the administration of this Act, shall be  
10 made unless it is against the Fund. No other moneys of the government of  
11 Guam *shall* be used or obligated to pay the expenses of the Department.

12 (d) Moneys remaining in the Fund, after maintaining the stated  
13 reserves for administrative expenses of this Act, *shall* be appropriated in the  
14 following manner in each fiscal year:

15 (1) up to one third (1/3) of the available balance to the  
16 Mayors' Council of Guam for the repair and construction of village  
17 recreational facilities, including community centers, and for the  
18 procurement of sports equipment and supplies including but not  
19 limited to, team sponsorships and uniforms. Funds may also be used  
20 to purchase equipment required to support community programs  
21 administered by village mayors;

22 (2) up to one third (1/3) of the available balance to the  
23 Department of Parks and Recreation for the repair and construction of  
24 its facilities, and for the procurement of sports equipment and  
25 supplies; and

1                   (3) up to one third (1/3) of the available balance to the  
2 Department of Education for the repair and construction of its sports  
3 facilities, and for the procurement of sports equipment and supplies.

4           (e) The Mayors Council of Guam, the Department of Parks and  
5 Recreation, and the Department of Education *shall* present memoranda of  
6 request to the Department of Administration detailing the use of funds to be  
7 allocated to each entity. Funds *shall not* be expended for personnel costs.  
8 The Department of Administration *shall* release funds to each entity on the  
9 first Monday of each fiscal quarter.

10           (f) Prior to the encumbrance and expenditure of funds for sports  
11 equipment and supplies and equipment for community programs, pursuant to  
12 subsection (d) of this section, each Mayor and the executive officer of each  
13 agency identified in items (2) and (3) of that subsection, respectively, must  
14 certify that all sports facility and capital improvement projects within his/her  
15 jurisdiction are completed and that all funds identified for the projects have  
16 been expended or fully encumbered and additional funds remain to be  
17 expended or encumbered. Each Mayor, the Director of the Department of  
18 Parks and Recreation, and the Superintendent of the Department of  
19 Education shall provide such certification and an itemized report of such  
20 capital improvement projects' encumbrances and/or expenditures to the  
21 Executive Director of the Mayors' Council of Guam, the Director of  
22 Administration, and the Guam Education Board, respectively, and each shall  
23 provide a copy of such report to the Speaker of *I Liheslaturan Guåhan*.  
24 Such certification shall be required each fiscal year to encumber or expend  
25 such limited gaming funds for sports equipment and supplies."



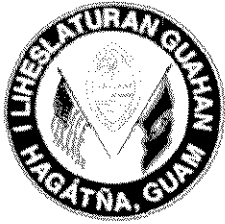

Dear Senator San Nicolas and Members of the Committee:

In 2000, the Sinajana Youth Center and Sporting Facilities were closed due to the lack of personnel and funding. This Youth Center, once operated by the Department of Parks and Recreation, had been a part of the community since the early 1980's. The Sporting Facilities were over 35 years old and have seen better times. With some creative rethinking, retooling and sound financial management, our office was able to reopen the youth center and re-open the baseball field and multi-purpose court to the community in 2005 thanks to Senator BJ Cruz's and Senator Tina Barnes's leadership and oversight.

The Sinajana Community Center and Sporting Facilities services hundreds of our village youth and youth from neighboring communities ranging from ages 7 to 77 seven days a week. Our center has been very active these past years, hosting 11 cycles of the Adult Education Courses (G.E.D.) in conjunction with G.C.C., our Annual SunSational Summer Camp and Christmas Camp for kids, as well as offering Zumba, music classes, numerous seminars and meetings as well as play host to a plethora of non-profit groups who use the center regularly.

We wish to thank Senator Morrison and the co-sponsors- Senators Respicio and McCreadie for introducing this legislation which will increase the flexibility of the Limited Gaming Fund.

We do have some amendments we'd like to suggest:

- 1) To allow the use of gaming fund 3260 to be used for sports related activities to include and authorize team sponsorship and uniforms. *(While this will certainly provide relief we want to assure this body and the public that we will be good financial stewards and equally support ALL sports and activities. We would still encourage athletes to continue to fundraise and earn what they can- which helps build character, togetherness, and a*

*deeper sense of responsibility to the team.) Some villages have more teams, sports and players than others and I anticipate hard decisions ahead for some of my colleagues.)*

- 2) To allow the purchase computer equipment, audio visual equipment/aides for our computer classes/labs and other related educational tools and equipments (*e.g. white-erase boards, desks, chairs, file cabinets*) (*Not everyone plays sports and this would be inline with increase students access to S.T.E.M. This will also enable us to meet the technology needs of tomorrow- a passion and platform that both you, Senator Morrison and I are big supporters of* )
- 3) To allow for the purchase of musical instruments and performing arts equipment and aides. I would be remised if this wasn't included. With all the amazing talent our island has to offer and the numerous studies that prove that music and performing arts have so many positives benefits and attributes this would enable us to prepare the next generation of creative minds.
- 4) Lastly, we ask that verbiage be included so we can use the funds to meet federal and private grant matching requirements. For example- our community has been working with the University of Guam's-Children's Healthy Living Program and there are possibilities to increase resources through micro-grants and fund matching.

We want to take this opportunity to also recognize Former Senator Chris Duenas (*a son of Sinajana*) who has been a champion in this field through Public Law 32-60 which gave our villages the resources and tools. With the previous two allotments totaling about 28 thousand dollars- many villages were able to perform repairs and upgrades to the facilities. We are not "there" yet and some have longer ways to go but this is a good start from all parties involved to get our community active, healthier and live better.

Since we have reinvested in our facilities through Compact Impact Renovation and Rehabilitation funds made possible by Governor Calvo, The Public Safety and Social Education Program funds made possible by this body, and private donations, we have seen a decline in crime, violence, and vandalism. National statistics will show that communities that offer youth and teen related programs have a decline in drug use, violence and teen pregnancy. So far the kids and teens have been great community partners and shown the respect and desire to become productive members of society. Since we've created an environment conducive for learning and fun, promoting healthy lifestyle choices and active lifestyles, the kids feel safer and cared for. We are firm believers that "*if you invest in your community- your community will invest in you...*" Thank you and *Si Yu'us Ma'ase!*

*Hafa Adai!* As the Co-chair of the Guam Non-communicable Disease (NCD) Consortium, developer/instructor for the BASES After School Program, Vice-president of Guam Amateur Baseball Association and resident of Guam, I rise in support of Bill 3-33.

In 2011, heart disease, cancer, stroke, diabetes were the top 4 leading causes of death in Guam. This has been the case for more than a decade now. These non-communicable diseases are deadly, have no known cure, and are very costly that puts heavy strains to our economy. According to the Centers for Disease Prevention and Control (CDC), in 2010, the total cost of cardiovascular diseases in the U.S. was estimated to be \$444 billion. That is about \$1 for every \$6 spent on health care. We anticipate these numbers to mirror Guam's medical costs.

One of the major risk factors for all these chronic diseases is obesity and physical inactivity, especially in the youth population. Preventing youth obesity and increasing physical activity is evidence-based approach that will not only lower NCD rates in our community, but also save millions of dollars in medical cost associated with obesity. In fact, in 2008, CDC has estimated that the total cost of medical care for obesity in the U.S. is \$147 billion.

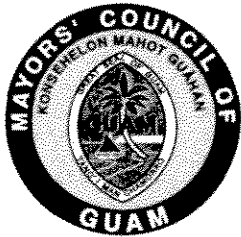
Without targeting the vulnerable youth population, we are setting our future generations to poor health outcomes. The 2011 Youth Risk Behavior Survey (YRBS) reported that only 37% of our middle school students engaged in at least 60 minutes of physical activity a day. This rate is similar in high school students. Moreover, the report also indicated that 27% of our middle school students and 17% of our high school students are already overweight.

The information provided clearly shows the need to focus our efforts to address obesity and inactivity in our community, particularly childhood obesity, where it all starts. Targeting obesity will help prevent chronic diseases, saving our government hundreds of millions in health care costs, and making our future generations healthier and more productive.

Providing funding to specifically focus on the Guam Department of Education students, which represent more than 40,000 members of our community, while also providing funds to the Department of Parks and Recreation as well as the Mayors Council for programs and equipment necessary to provide recreation services through the Department and within each village, will usher in healthier generations of Guamanians. We commend you for making the right choice for our people and we encourage your colleagues to do the same. Please act now and move Bill 3-33 for passage.

Thank you for sponsoring Bill 3-33(LS) (An act to amend 5204(d) of Article 2 of Chapter 5, Title 11, Guam Code Annotated, Relative to Authorizing the Procurement of Sports Equipment and Supplies for Youth and Community Sports Programs).

Obesity has been one of the leading health problems in Guam for many years now. In fact, data from the Guam Behavioral Risk Factor Surveillance System indicate that in 2013, 36.5% of our adult population were overweight, while 27.0% were obese. This signifies that more than half our adult population is either overweight or obese. Similarly, the 2013 Youth Risk Behavior Survey reported that 16.9% of our high school students are already overweight while 20.1% are already obese.

The urgency to address obesity in our island cannot be stated enough. Obesity is a major risk factor for non-communicable diseases which has killed more Guamanians each year for the past several years. In 2012 alone, heart disease, cancer, stroke, and diabetes accounted for 60.38% of all deaths in Guam.


Obesity is also associated with billions of dollars spent on health care related services. The Centers for Disease Control and Prevention estimated that in 2008, the total cost of medical care for obesity in the U.S. is \$147 billion. Moreover, the Robert Wood Johnson Foundation (RWJ) indicated that based on 2006 data, \$14.1 billion on direct health care costs were due to childhood obesity. Another study stated that if obesity is eliminated in the US now, Medicare spending would decrease by 8.5% while Medicaid spending will decrease by 11.8%.


It is clear that preventing obesity will not only save on health care costs, but will also improve the health outcomes of many Guamanians. And this starts by supporting strategies that improve opportunities for Guamanians to be physically active. According to RWJ's Active Living Research, "youths in neighborhoods with recreational facilities were 28% more likely to be active 5 times per week than those in areas without facilities." Another study stated that "adults were 28% more likely to participate in recreational activities if there were more recreational resources within five miles of their homes."



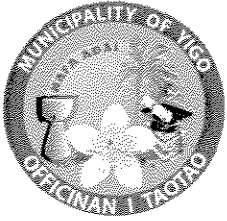
