

# **Chairman Aguon:**

Welcome to our people who are watching this particular session. This public hearing sponsored by the Committee on Guam, Public Safety, and Judiciary is hereby convened. In today's agenda we do have several items. The initial legislation or the bills that will be discussed are Bill No. 291-33 relative to custody and visitation of deployed military parents.

# Chairman Aguon:

Bill No. 296-33, relative to training requirements for concealed carry licenses. Bill No. 309-33, which is relative to compensation or promotional opportunities for ur law enforcement within the Guam Police Department and Bill No. 311-33 relative to unlawful distribution of images of persons depicted in a state of nudity or engaged in sexual activities otherwise known as revenge pornography. For the purposes of the discussion this morning, I am going to move the items around just slightly. We will entertain Bill No. 309-33 initially. We do have the Chief of Police and several individuals who would like to provide testimony and I know that the Chief of Police and his personnel are providing security for our off island delegations from Fest Pac, so we want to insure that they are given that opportunity to return and continue to carry out that particular mission. Aside from that we will go back to the sequence of the agenda. I would like to thank the Vice Chair Senator Tom Ada to my left. Thank you very much Mr. Vice Chair for joining us this morning. Senator Mary Torres. Thank you senator and Senator Brant McCreadie for joining us this morning. Thank you.

We will now proceed to Bill No. 311-33, which is. Chief can we get a copy of your chart? Thank you chief. The committee will proceed with Bill No.311-33, which is relative to unlawful distributions of images of persons depicted in a state of nudity or engaged sexual activities, otherwise known as "revenge pornography," and this is sponsored by Speaker Won Pat. I do have Mr. Andrew Quitugua signed up again to provide testimony and Chief Cruz from GPD. Speaker Won Pat, would you like to provide some comments?

# Speaker Won Pat:

Yes, and thank you very much again Mr. Chairman. The intent and purpose of this piece of legislation is to raise awareness and to educate the public about the nature and the prevalence of online abuse. You know, this wasn't a problem many many years ago until of course the advent of technology and its just changing everyday. So working with technology, industry leaders and community development of the design base solutions to non consensual pornography and other forms of online abuse. We are also then, this is also advocating for state and federal legislation to prevent such abuse when appropriate. So currently in Guam, our laws prohibit anyone from using internet to harass another person by contacting them without revealing their identity or continuing to contact them after being told to stop or sending obscene material to someone who doesn't want it, or spreading false stories about others and then violators then will face a misdemeanor charge. Guam has a sexting law, but it's specifically for minors. Those under 18 are prohibited from using telecommunication devices to knowingly or recklessly send or receive photograph, video, depiction or other material that shows himself or herself of another minor in a state of nudity, and violators then also can be prosecuted. Most will be diverted to an educational program that seeks to discourage the repeat of such behavior. So that's for the minors. Current law however, does not address revenge pornography and Bill No. 311 seeks then to fill that gap and this bill yes was based in another law and specifically Arizona law that has withstood legal challenges. There are 28 states who have revenge porn laws. There are 11 states who have pending legislations and then 9 states with revenge porn have civil remedies and although there are other legislations that addresses some of these things in isolation of what it is they are trying to do, but because like I said with the advent of technology and how it's being used and it changes everyday there is nothing really that speaks to that specifically in terms to what we call revenge.

# Speaker Won Pat:

If anyone should break up in a relationship and they want to hurt them, they can then send off those photos that is very damaging to anyone of these individuals. So that's in essence what Bill 311 you know will do. Thank you very much Mr. Chairman.

# Chairman Aguon:

Thank you Speaker Won Pat. Chief Cruz. You're recognized.

**Chief Cruz:** Good afternoon again Mr. Chairman.

Chairman Aguon:

Thank you very much Chief Cruz. Any questions for Chief Cruz? Senator Ada.

# Vice Chairman Ada:

Yeah, I just have a. So a person, so this will be a felony or a misdemeanor?

## **Chief Cruz:**

Misdemeanor based on Guam laws.

# Vice Chairman Ada:

I just have a. So we basically are proposing this legislation to anybody who sends out these pornography or what not for purposes of revenge. Now, in order to get this to the court, the AG's Office is going to have to file charges correct. I mean basically you have to take it on to take it to court right?

# **Chief Cruz:**

That is correct sir.

# Vice Chairman Ada:

So it's going to have to take it's order in the queue of what other cases are in front of it. As opposed to and again, if this was to be made a civil, and this is where I'm stepping into an area that I know nothing of, but if it was a civil. How do you put it? How do you distinguish between the two where you don't need the AG to take it to court?

# **Chief Cruz:**

Civil litigation.

# Vice Chairman Ada:

Civil litigation sort of thing then that individual that sent that can basically take them to court and is liable to a law suit and I'm wondering if that wouldn't have more of an impact than if we were to require then if it was going to be a criminal case where it could take years probably to get it to court and maybe your thoughts on that.

# **Chief Cruz:**

I would tell you Mr. Vice Chair that is something we can definitely take a look at. I think that for me to provide a better answer I would need to collaborate with the Attorney General herself and get her thoughts on that. I would tell you I think it is feasible. It is possible to make this an issue that is given or that is dealt with on the civil litigation side of the house versus the criminal side. Not withstanding anything else and understanding the adjudication process and that it might on the criminal side, it has a tendency to take a lot longer. We see it in the Guam Police Department that there would be more teeth into the law if you will. If we were to make this criminal to hold somebody criminally liable versus civilly liable. I will tell you though that we also think that the two can work in tandem wit each other. Not only could one be held criminally liable for this, arrested, charged, and then magistrate and have their day in court, but in addition to have a lawsuit filed against them as well. So the two can work in tandem with each other so that their rights are protected on both sides of the house. So I think from our perspective, from the Guam Police Department we see that approaching it from a criminal stand point and make it holding one criminally responsible will allow us to do our part that I just indicated where we can actually investigate this. If this becomes a civil manner, then it's the two parties to deal with it in court and the Guam Police Department will not necessarily get involved because it would be a civil manner. It wouldn't be a criminal matter. We enforce the criminal code on Guam. The Title 9. So we see it as if the intent of this bill is to hold people accountable, from our perspective as a police department, it would be better. Or the inclusion of criminal as well as civil would be better for the victims of this crime, but again, to understand this bill from a holistic point of view, again, I would need to confer with the Attorney General.

# Vice Chairman Ada:

Sure and I would just cite for example I believe the fire codes. Before it was a criminal offense if you were cited and then now it's a criminal if after two or three violations. Then criminal charges could actually then be charged then you know if prior citations did not catch their attention. Thanks.

# Chairman Aguon:

Thank you very much Senator Ada and thank you chief for your testimony this afternoon. Speaker Won Pat, Vice Speaker Cruz, Senator Tony Ada, Senator Tom Ada, Mr. Vice Chair, thank you very much for joining us in this public hearing. This concludes the public hearing on Bill No. 291, 296, 309, and 311 and the committee will continue to receive written testimony ten days, ten calendar days subsequent to this particular public hearing and just for the information of the senators and the public, there will be a committee roundtable discussion on the Public Defender's Service Corporation, which was originally scheduled fro 3:30 this afternoon, It has been moved to the left. BE IT ENACTED BY THE PEOPLE OF GUAM:
 Section 1. A new §28.110 is hereby added to Chapter 28 of Title 9, Guam
 Code Annotated, to read as follows:
 "§28.110. Unlawful Distribution of Images; Exceptions; Definitions; and

5 Penalties.

6 (a) It is unlawful for a person to intentionally disclose, or intentionally cause 7 another person to disclose, including disclosing by electronic means, an 8 image of another person who is identifiable from the image itself or from 9 information displayed in connection with the image, or otherwise engaging 10 in revenge pornography, if *all* of the following apply:

(1) The person in the image is depicted in a state of nudity or is engaged
in sexual contact.

I am Joseph I. Cruz, Chief of Police for the Guam Police Department, and I thank you for the opportunity to appear before you today in my official capacity along with key members of the Guam Police Department to render testimony in support of Bill 311-33 (COR).

**EXECUTIVE SUMMARY** 

The Guam Police Department is in support of Bill 311-33, an act relative to the unlawful distribution of images of persons depicted in a state of nudity or engaged in sexual activities, otherwise known as "Revenge Pornography". This Bill takes into consideration the lawful and legitimate use of nude WRITTEN TESTIMONY OF JOSEPH I. images, and narrows the focus of those harmful acts that are intended to generate physical injury, financial injury, and emotional distress.

GPD investigates public indecency cases annually. Inclusive of the crime commonly known as "sexting", these crimes are categorized as Sex Crimes in the Uniform Crime Report and are distinctive from Sexual Assault or Forcible Rape cases which are categorized as Violent Crimes. GPD does not currently capture data related to "revenge pornography", but we are confident that if Bill 311-33 is passed into law we will not only understand the extent of the problem on Guam, but more importantly, GPD will have the opportunity to address the problem through law enforcement.

GPD has seen the rise in Sex Crimes cases reported to the police in the fiveyear trend from 2010 - 2014, which can be attributed to the passage of Public Law 31-09 which in part, criminalized "sexting", or "the use of a cell phone to send sexually suggestive texts or emails with nude or nearly nude photos." in 2010 and 2011 there were seventy-four (74) and seventy-six (76) cases of Sex Crimes reported to police, respectively. After the passage of PL 31-09 in 2011, there is an almost one hundred (100) case increase reported the following year in 2012; with a total of one hundred and seventy three (173) cases of Sex Crimes reported to police that year. In 2013 and 2014 there are over one hundred cases of Sex Crimes reported to police, with one hundred eleven (111) and one hundred ten (110), respectively. This is indicative of incidents that are under reported for reasons that stem from the inability of law enforcement to act, and we are confident that the passage of this Bill will provide victims of this act to come forward.

The Office of the Attorney General (OAG) noted that it is unable to determine the fiscal impact of the bill because it is basically a newly proposed crime. This bill will expand the scope of work of the OAG as it will include minors and adults in its population of cases. With this being a new type of crime, the OAG is not able to determine the number of cases that may come into its office. It should be noted that Section 1 of the bill specifies a fine of not more than \$1,000, imprisonment or both for first offenses.



Guam - Speaker Judi Won Pat has introduced a bill that would criminalize what is commonly referred to as "revenge porn."

Bill 311 also criminalizes "sexting" among minors. The bill proposes to punish those who intentionally disclose or cause others to disclose nude or sexually explicit images or videos of another person with the intent to harm, harass, intimidate, threaten or coerce the victim. Under the bill, the first offense would be considered a

misdemeanor and the second offense a third-degree felony.

"It's a very different culture altogether when you think about social media and how now, you can send things like this and once it's out there in the inverse someone can always retrieve it, really stop and think about even before you decide to take a picture of yourself you consider private because once its out in the internet, it's not really private so i just want to caution everybody to think about their actions," said won pat.
