





COMMITTEE REPORT DIGEST

I. OVERVIEW

Bill No. 315-33 (COR) was introduced on May 06, 2016 by Senator Thomas C. Ada and was subsequently referred on May 09, 2016 by the Committee on Rules to the Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement.

The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement convened a public hearing on May 20, 2016 at 9:00 am in *I Liheslaturan's* Public Hearing Room to receive public testimony on Bill No. 314-33 (COR).

Public Notice Requirements

Public Hearing notices were disseminated via email to all senators and all main media outlets and published in the Guam Daily Post on May 13, 2016 (5-Day Notice) and again on May 17, 2016 (48-Hour Notice).

Senators Present

The public hearing was Called-to-Order at 9:00am.

II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Ada: He explained that Bills 313, 314 and 315 are similar. He further clarified that the differences between the three bills are their locations and the sizes of the water storage tanks. He then goes on to say that Guam Waterworks Authority will provide their testimony first to explain the need for the bill. Then the Chamorro Land Trust Commission will provide testimony as to their position on the bill. Chairperson Ada explains that the property in Bill No. 315 is located in *Tamuning* and that the bill would transfer an area of 5,686 square meters from the Chamorro Land Trust Commission to the GWA. Chairperson Ada explains the actual location of Lot No. 5075-REM-A NEW-1, *Tamuning* to be in Upper Tumon.

Chairperson Ada then called those who have signed up to provide testimony.

Miguel Bordallo, General Manager, Guam Waterworks Authority: He stated that in order to comply with a 2011 court order, GWA is required to upgrade and add water storage for its water distribution system. This bill relates to the water reservoir in *Upper Tumon* and the request for additional land will be to build a bigger reservoir and demolish the existing

reservoir. That is in addition to other improvements such as storm water retention to meet USEPA clean water act requirements.

Michael Borja, *Administrative Director, Chamorro Land Trust Commission*: He started by saying that a resolution has been passed by the Chamorro Land Trust Commission; which is attached to his testimony, to show that the CLTC concurs with the transfer of the land. Compensation will still be required and the period of 180 days as defined in the bill is adequate time to come up with a method.

Chairperson Ada: He stated that according to the bill, GWA will pay for the appraisal of the property, bear the cost of the surveying and the two agencies will come together on an appropriate compensation within 180 days.

Joey Duenas, *Chairman, Consolidated Commissions on Utilities*: He stated that he is here to support GWA's request and to verify that the CCU has authorized the GWA General Manager to make the request for that property. The CCU also stands ready to finance the request.

Chairperson Ada: Asked if the funds are already in place for this tank.

General Manager Bordallo: He responded yes.

Chairperson Ada: He stated that the stipulations are the same that GWA shall pay for the appraisal, the surveying of the property and both agencies will work together to determine an appropriate compensation. Chairperson Ada then asks if there is any inkling that this will be an outright purchase?

Mr. Duenas: He stated that the CCU and GWA would prefer an outright purchase because this is a long term facility.

Director Borja: He went on to say that discussions have been made about the compensation. It was more of brainstorming the concepts that can be taken. Land exchange is an option that is acceptable but if that is not viable on GWA's end, then other compensation options can be looked at.

General Manager Bordallo: He said the preference for a purchase is due to the fact that GWA is unsure if there is any excess land in GWA's inventory or if the land is suitable for the purposes of the CLTC. He stated they would like to leave options open and are open to a resolution of the issue. But the preference is for an outright purchase.

Chairperson Ada: Asked Director Borja if the property adjacent to the current tank is Chamorro Land Trust Property?

Director Borja: He responded that the property is private property and was part of a land exchange many years ago.

Chairperson Ada: Confirmed that the property GWA is seeking is immediately adjacent to the property where the current water tank sits. He then asked GWA to explain why the difference in the lot size?

General Manager Bordallo: He explained that part of the reason is not just a larger reservoir but to comply with EPA regulations that have recently been changed. He says that based on Guam EPA regulations GWA requires another acre for storm water disposal.

Chairperson Ada: He asked if these regulations existed when the current tank was built?

General Manager Bordallo: He responded No.

Chairperson Ada: He asked how the property would be accessed? And seeks clarification that the dependence for access will not be through the property behind East West Rental Center.

General Manager Bordallo: He responded that there is an easement in the Nissan Motors side.

Chairperson Ada: He asks Director Borja: is there an easement on the property behind East West Rental Center?

Director Borja: He responded that there was an easement prior but it no longer exists.

Chairperson Ada: He then asked GWA if that same access will be used during the construction phase. And also asked if Nissan is aware that it will be used during construction.

General Manager Bordallo: He stated that at this time Nissan is unaware but GWA will coordinate with Nissan prior to the start of construction.

Chairperson Ada: He asked Director Borja if access could be made available through the property behind East West Rental Center?

Director Borja: He stated that it can be done if GWA made the request. It would be an agency to agency request. He then goes on to say that property behind East West Rental Center is a remnant property that did provide access to the area behind Nissan Motors. Director Borja then explained that at a CLTC meeting yesterday Mr. Adkins was asked why he was using the property. Mr. Adkins' responded that he was permitted to use the property by the Department of Public Works after the road was no longer needed. He then said that Mr. Adkins' does not have authority from the CLTC to use the property.

General Manager Bordallo: He stated that discussions have been made for GWA to size the property adjacent to the property GWA is requesting for; for development by CLTC.

Director Borja: He stated that based on one final review, the Department of Land Management suggests that the zoning designation of the property be changed to "PF" for

Public Facility. He states that his written testimony provides other technical amendments that need to be made on the bill.

Chairperson Ada: He commends both, the Guam Waterworks Authority and the Chamorro Land Trust Commission, and says that this is an excellent example of what can be done when good lines of communication are established. And kudos to the Chamorro Land Trust Commission for recognizing that these projects will be for the good of the community.

There being no further testimony Chairperson Ada adjourns the Public Hearing for Bill No. 315-33 (COR).

III. Findings and Recommendation

The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement finds that based on testimony provided by the Chamorro Land Trust Commission, Bill No. 315-33 (COR) shall be amended to reflect technical changes:

- The change is to include language in the bill to rezone Lot 5075-REM-A NEW-1, *Tamuning* to zoning designation "PF" (Public Facility) in accordance with 21GCA Chapter 61 Section 61313.
- Changes to Section 1, Page 1, Line 3:
I Liheslaturan Guåhan finds that the Guam Waterworks Authority (GWA) has identified property, owned by the Chamorro Land Trust Commission (CLTC), for the purpose of constructing a new detention basin which will allow for the replacement of the existing one (1) million gallon water storage and for the construction of an above ground two (2) million gallons water storage reservoir.
- Changes to Section 1, Page 2, Line 9:
 - Remove "1,852" and replace with "5,868"
 - Remove "0.446" and replace with "1.40"

AN ACT TO TRANSFER A PORTION OF LOT NO. 5075-REM-A NEW-1, MUNICIPALITY OF TAMUNING WITH AN AREA OF 5,686 SQUARE METERS FROM THE CHAMORRO LAND TRUST INVENTORY TO THE GUAM WATERWORKS AUTHORITY FOR THE PURPOSE OF CONSTRUCTING A NEW WATER STORAGE TANKS.

2016 FEBRUARY 25

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.**

3 *I Liheslaturan Guåhan* finds that the Guam Waterworks Authority (GWA)
4 has identified property, owned by the Chamorro Land Trust Commission (CLTC),
5 for the purpose of providing a staging area during the construction of a new water
6 reservoir, preparing the site for the future construction of an additional 2MG
7 reservoir, and for the relocation of an existing pump station. These improvements
8 are essential in meeting current and future growth demands for drinking water and
9 improve operational reliability of the water system.

10 *I Liheslaturan Guåhan* finds that the construction of a new 2MG reservoir at
11 the selected site will increase total storage capacity from 1MG to 3MG. The
12 increased storage capacity will address growth in water demand due to population
13 growth and improve operational reliability. More specifically, the new reservoir

1 will also enhance service to the *Tamuning, Tumon, and Hagatna* service zones, as
2 well as to the water system overall.

3 *I Liheslaturan Guåhan* finds that GWA and CLTC have been working
4 cooperatively to address the critical property needs to meet the 2011 Court Order
5 deadlines and the CLTC has approved a board resolution to support GWA system
6 improvement plans.

7 *I Liheslaturan Guåhan* finds that this project is necessary and will benefit
8 the people of Guam. *I Liheslaturan Guåhan* intends to authorize the CLTC to
9 transfer 1,852 square meters (0.446 acres) more or less, to the GWA to accomplish
10 the necessary improvements described above. GWA and CLTC have agreed on the
11 basic terms of the transfer to meet the needs and mandates of both parties, and
12 have committed to finalize compensation to the CLTC within one hundred eighty
13 days (180) of the enactment of this Act.

14 *I Liheslaturan Guåhan* further finds that GWA, under United States
15 Department of Justice ORDER FOR PRELIMINARY RELIEF RE: DEADLINES
16 FOR OUTSTANDING PROJECTS UNDER THE AMENDED STIPULATED
17 ORDER Civil Case No. 02-00035 (Court Order or CO) effective as of 11/10/2011,
18 is required to “*assess and repair, rehabilitate, replace and/or relocate all Guam*
19 *Waterworks Authority water reservoirs within its systems as detailed in § II (C) ¶*
20 *29 (b) of the order, and the deadline to complete these tasks specified for the water*
21 *reservoirs is 2018*”.

22 **Section 2. Authorization to Transfer Land Identified to the Guam**
23 **Waterworks Authority.** Notwithstanding any other provision of law, rule or
24 regulation, *I Liheslaturan Guåhan* authorizes the Chamorro Land Trust
25 Commission to transfer approximately five thousand six hundred and eighty -six
26 (5,686) square meters (1.40 acres), more or less, of Lot No. 5075-REM-A NEW-1,
27 Municipality of *Tamuning*, as shown on proposed Parceling Survey Map L.M. No.

1 057FY2016, prepared by Guam Surveyor, LLC, Dennis Balagtas, P.L.S. #75 to
2 construct a new detention basin which will allow for the replacement of the
3 existing one (1) million gallon water storage and for the construction of an above
4 ground two (2) million gallons water storage reservoir from the inventory of the
5 Chamorro Land Trust Commission to the Guam Waterworks Authority. The
6 administrative transfer of property shall become effective upon the enactment of
7 this Act. (See exhibit A).

8 (a) Guam Waterworks Authority *shall* pay for the appraisal of the
9 property by two different appraisers, one which shall be selected by the
10 Director of the Department of Land Management.

11 (b) Guam Waterworks Authority shall have the property surveyed
12 at its own expense and the surveyed map shall be approved and recorded by
13 the Department of Land Management.

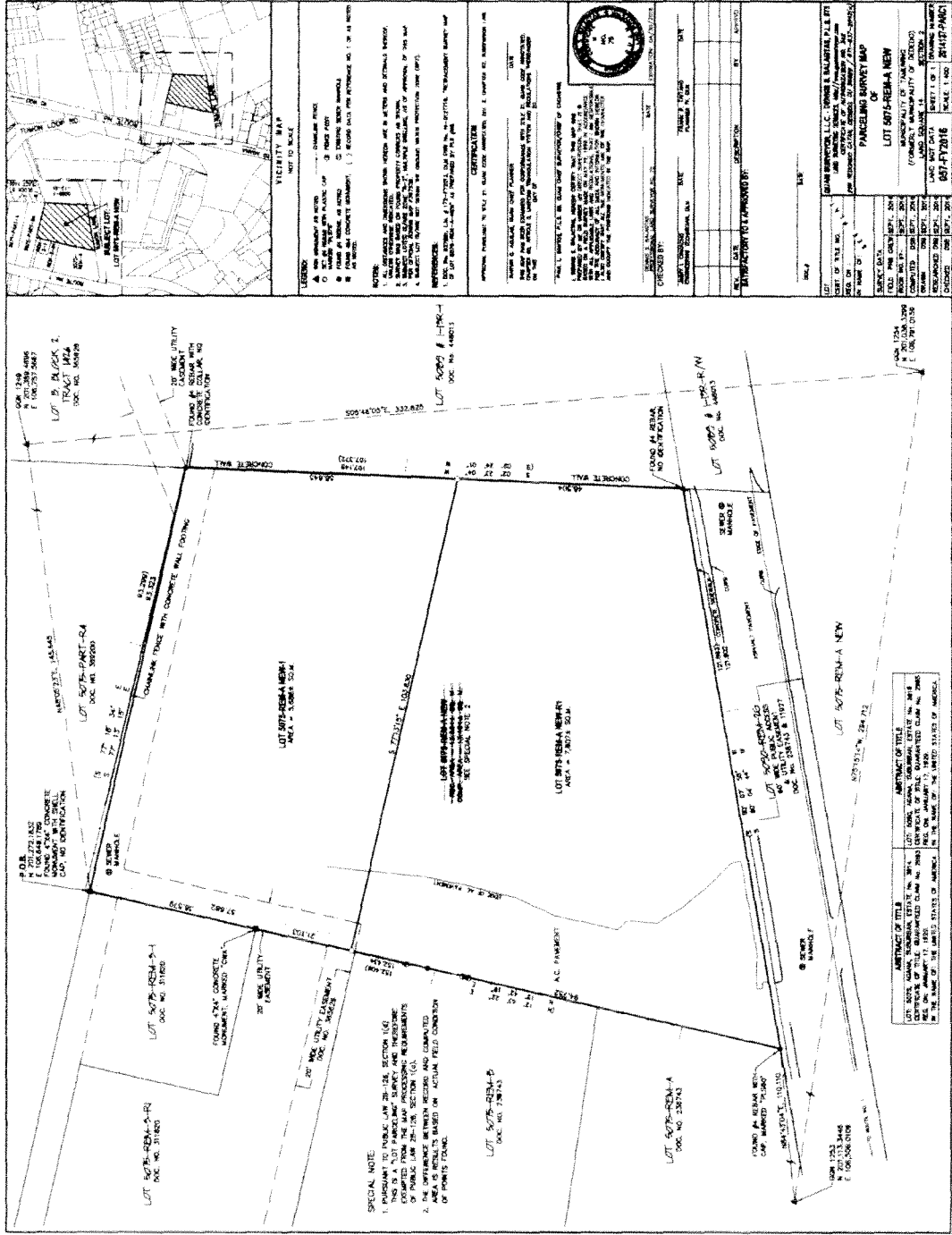
14 (c) Guam Waterworks Authority shall work with Chamorro Land
15 Trust Commission to determine an appropriate compensation for the
16 property to include but not limited to land exchange, in kind services,
17 purchase, or a combination of options to be approved by Guam Waterworks
18 Authority, Consolidated Commission on Utilities (CCU) and Chamorro
19 Land Trust Commission. GWA and CLTC will have one hundred eighty
20 (180) days to finalize a compensation agreement.

21 (d) Chamorro Land Trust Commission grants right of entry
22 immediately for GWA to complete required geotechnical survey,
23 topographic survey, archeological studies, other required testing and studies
24 to initiate design for the construction of the detention basin and construction
25 an new water reservoirs while both parties are finalizing compensation and
26 the deed is recorded.

1 **Section 3. Reversionary Clause Upon Inaction.** The Guam Waterworks
2 Authority must begin construction of the detention basin within five (5) years from
3 the date of the enactment of this act. In the event, the Guam Waterworks Authority
4 does not begin construction of the detention basin within the stipulated period,
5 without notice to the Chamorro Land Trust Commission, or defaults on the
6 compensation agreement, the property *shall* revert back to the Chamorro Land
7 Trust Commission.

8 **Section 4. Effective Date.** This act *shall* take effect upon its enactment.

9 **Section 5. Severability.** If any provision of this law or its application to
10 any person or circumstance is found to be invalid or contrary to law, such
11 invalidity *shall not* affect other provisions or applications of this law, which can be
12 given effect without the invalid provisions or applications and to this end the
13 provisions of this act are severable.

AN ACT TO TRANSFER A PORTION OF LOT NO. 5075-REM-A NEW-1, MUNICIPALITY OF TAMUNING WITH AN AREA OF 5,686 SQUARE METERS +/- FROM THE CHAMORRO LAND TRUST INVENTORY TO THE GUAM WATERWORKS AUTHORITY FOR THE CONSTRUCTION OF NEW WATER STORAGE TANKS; AND TO REZONE LOT NO. 5075-REM-A NEW-1 FROM COMMERCIAL (C) ZONE TO A PUBLIC FACILITY (PF) ZONE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

I Liheslaturan Guåhan finds that the Guam Waterworks Authority (GWA) has identified property, owned by the Chamorro Land Trust Commission (CLTC), for the purpose of constructing a new detention basin which will allow for the replacement of the existing one (1) million gallon (MG) water storage and for the construction of an above ground two (2) million gallon (MG) water storage reservoir. These improvements are essential in meeting current and future growth demands for drinking water and to improve the operational reliability of the water system.

1 *I Liheslaturan Guåhan* finds that the construction of a new 2MG reservoir at
2 the selected site will increase total storage capacity from 1MG to 3MG. The
3 increased storage capacity will address growth in water demand due to population
4 growth and improve operational reliability. More specifically, the new reservoir
5 will enhance service to the *Tamuning, Tumon* and *Hagatna* service zones, as well
6 as to the water system overall.

7 *I Liheslaturan Guåhan* finds that GWA and CLTC have been working
8 cooperatively to address the critical property needs to meet the 2011 Court Order
9 deadlines and the CLTC has approved a board resolution to support GWA system

Thank you for the opportunity to provide comments for the following bill:

- ***BILL NO. 315-33 (COR), AN ACT TO TRANSFER A PORTION OF LOT NO. 5075-REM-A NEW-1, MUNICIPALITY OF TAMUNING WITH AN AREA OF 5,686 SQUARE METERS FROM THE CHAMORRO LAND TRUST INVENTORY TO THE GUAM WATERWORKS AUTHORITY FOR THE PURPOSE OF CONSTRUCTING NEW WATER STORAGE TANKS.***

Over the last five years, the Guam Waterworks Authority has been aggressively meeting the requirements under the 2011 Court Order. Under Paragraph 29 (b) of the Court Order, GWA is required to "access and repair, rehabilitate, replace and/or relocate all GWA water reservoirs within its system." GWA identified 33 reservoirs island-wide that need to be reconstructed or built. The three bills that are being heard today will support GWA's effort to meet the requirements of the Court Order, by providing land that is critical to our reservoir projects, and will allow GWA to improve the infrastructure and overall reliability of the GWA water system, as well as to meet current and future growth demands for drinking water.

The locations identified in the bills were selected to provide optimal elevations for pressure to the GWA system, and because of their proximity to existing GWA water tanks, water lines and other appropriate infrastructure. The properties will enable GWA to rebuild existing water reservoirs, construct required stormwater detention basins to address United States Environmental Protection Agency (USEPA) Clean Water Act (CWA) requirements and construct additional water reservoirs. The construction of additional water reservoirs is critical to address population growth and provide operational storage, equalizing storage, fire suppression storage, and standby storage.

Over the last several months, GWA's staff have been working with Mr. Michael Borja at the Chamorro Land Trust Commission to identify and evaluate suitable land in the CLT inventory to support the needs identified to address the court order, as well as discussing possible options for insuring the CLTC receives the appropriate value of such lands so as not to adversely affect their programs. This bill, along with the other two, would enable and require GWA to work closely with the CLTC in developing an appropriate compensation package over the next 180 days that could include purchase/lease, in-kind services and land exchange. Further, GWA is prepared to fund required property assessments and surveys to ensure the contemplated property transfers are beneficial to both the Chamorro Land Trust and to the people of Guam.

Due to the time restraints to meet the deadlines in the Court Order, it is critical to move forward with the design and construction of these projects. Funding for these projects is in place and GWA has consultants ready to execute these projects immediately.

As population and commercial activity increases, water demands in the Agat/Santa Rita, Dededo, Tamuning, Hagatna, and Tumon areas will also increase. These projects will support anticipated development, and contribute significantly to the sustainability of the island's economy by meeting future water demands.

Over the next few years, Capital Improvement Projects will include replacement of existing water lines to reduce leaks and enhance reliability of the system, developing of additional water resources and improve overall water facilities. The projects identified in the three bills being heard today will increase water storage by four million gallons to meet our goals of improving our utility and providing outstanding water services to the community.

Based on the foregoing, GWA expresses its full support of the bill as presented and respectfully requests your vote in favor of this bill.

Thank you to Senator Ada and his staff for moving this critical legislation forward. We look forward to working with Mr. Borja and his staff to come to an agreement for appropriate compensation for these properties.

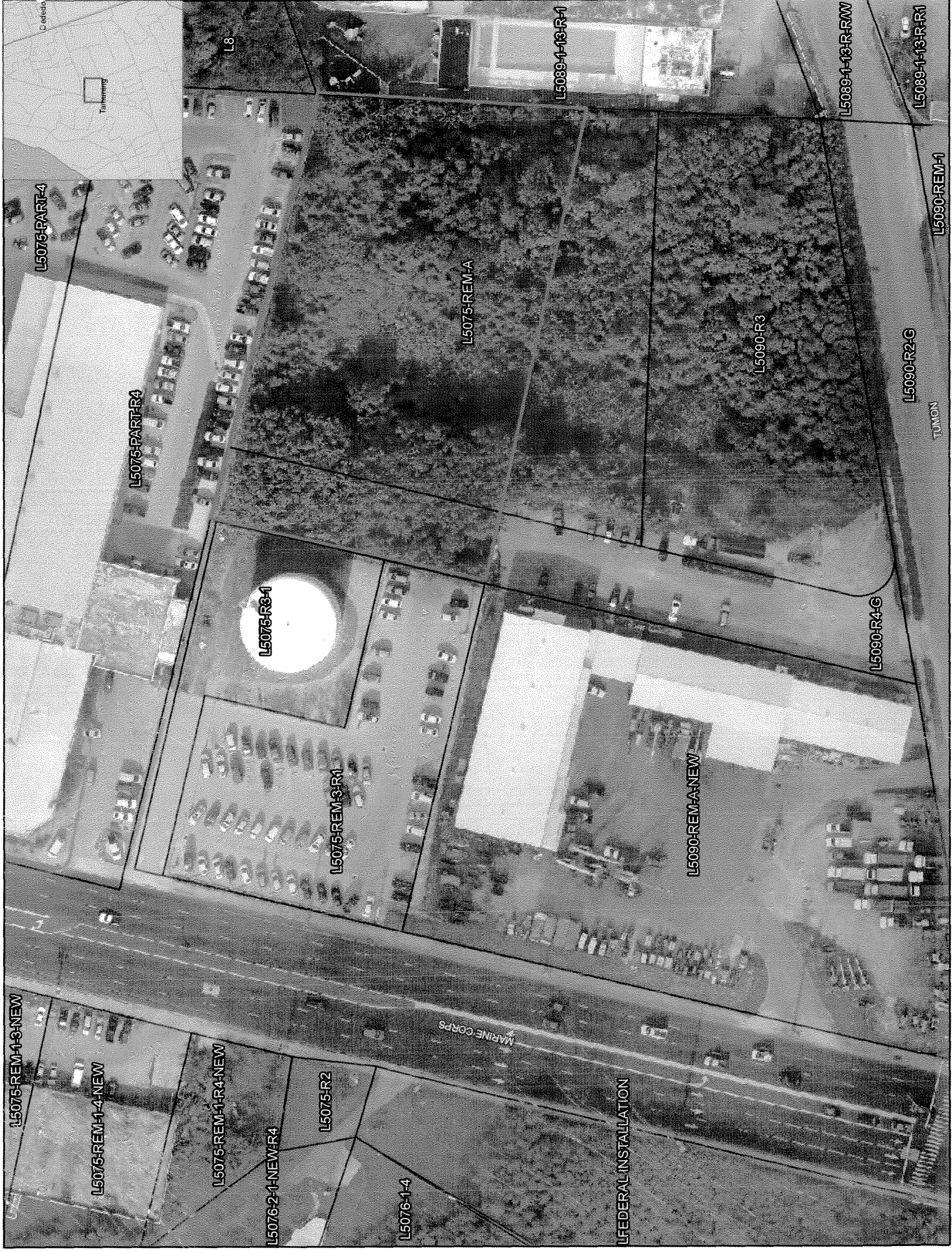

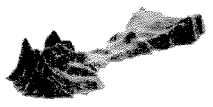

The Department of Land Management and the Chamorro Land Trust Commission (CLTC) have reviewed Bill No. 315-33. The CLTC board of commissioners, in Resolution No. 2016-02, approved the intent of this bill to provide the Guam Waterworks Authority (GWA) with land necessary for the development of water infrastructure which is in the public interest.

Nevertheless, compensation for the land is necessary but due to the immediate need for GWA to acquire the property and begin construction of infrastructure facilities, the period of 180 days is adequate time to determine the best manner of compensation. Equally, GWA would be responsible for all costs associated with this land transfer.

As shown in the exhibits to this bill, both the CLTC and GWA respective boards of commissioners have issued resolutions supporting this measure. Additionally, each have been working collaboratively because water is a necessary element for everyone. Just as many water wells and potential sites reside on CLTC property, both agencies have worked together to ensure the availability and protection of these water sources. In the same way, both agencies have been cooperative in ensuring CLTC lessees' utility authorization requests are honored and managed as expeditiously as possible.



However, there are a few technical issues with the wording of Bill No. 315-33 which may be errors in transcription:

- a. Make the following changes to Section 1, page 1, line 3:

I Liheslaturan Guahan finds that the Guam Waterworks Authority (GWA) has identified property, owned by the Chamorro Land Trust Commission (CLTC), for the purpose of ~~providing a staging area during the construction of a new water reservoir, preparing the site for the future construction of an additional 2MG reservoir, and for the relocation of an existing pump station.~~ constructing a new detention basin which will allow for the replacement of the existing one (1) million gallon water storage and for the construction of an above ground two (2) million gallons water storage reservoir.



COMMENTS ON BILL NO. 315-33 (COR)

The proposed legislation intends to transfer a portion of Lot No. 5075-REM-A NEW-1 in the municipality of Tamuning (approx. 5,686± square meters) from the Chamorro Land Trust Commission (CLTC) to the Guam Waterworks Authority (GWA) for the purpose of constructing new water storage tanks.

Sections 2(a) and 2(b) stipulate that the GWA will be responsible for covering the cost of the appraisal of the property by two different appraisers as well as the cost of the property survey that shall be approved and recorded by the Department of Land Management (DLM).

Although compensation for the transfer of CLTC property to the GWA is not specifically outlined, Section 2(c) stipulates that the two parties will determine the appropriate method of compensation to include, but not limited to, a land exchange, in-kind services, purchase, or a combination of the listed options. All compensation options shall be approved by the GWA, CLTC, and the Consolidated Commission on Utilities (CCU). The compensation agreement between the GWA and CLTC must be finalized within 180 days after the enactment of the proposed legislation.

Because the GWA does not receive appropriations from the Government of Guam, having GWA cover the cost of the appraisals and survey of the subject property will not have an impact on any of the Government of Guam's finances.

As previously mentioned, the CLTC will receive an appropriate compensation for the transfer of the subject property. However, because the specific terms of compensation have not been outlined or agreed upon at the time of preparing comments, the Bureau is unable to determine if the compensation is equal, more, or less than the value of the subject property.


