## COMMITTEE REPORT DIGEST

### **I. OVERVIEW**

Bill No. 330-33 (COR) was introduced on June 1, 2016 by Senator Frank B. Aguon, Jr. The bill was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on June 2, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a public hearing on September 30, 2016, in *I Liheslatura's* Public Hearing Room. Among the items on the hearing agenda was Bill No. 330-33 (COR). The hearing convened at 3:04 p.m. and was adjourned at 5:20 p.m.

### **II. TESTIMONY & DISCUSSION**

**Chairman Michael San Nicolas** yielded the floor to Senator Frank Aguon to offer an opening statement on Bill No. 330-33.

**Senator Aguon** explained that the bill would establish a license fee for the off-premise sales of wine.

**Chairman San Nicolas** clarified that the bill would have fees applied for off-premise wine sales which had been previously lumped in with general sales fees. Without other individuals present to testify, Chairman San Nicolas concluded the hearing for Bill 330-33.



1       **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2       **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds  
3 that §3207 of Chapter 3, Article 2, Title 11, Guam Code Annotated, provides for  
4 the application and issuance of licenses, classes, and fees for various alcoholic  
5 beverages. While §3207 allows separate on-premises and off-premises licenses for  
6 beer-only establishments and general sale establishments, it only provides for a  
7 Class 4 on-premises wine-only license, a wine bar, and it does not provide for a  
8 Class 5 off-premises wine-only license, a dedicated wine shop. *I Liheslaturan*  
9 *Guåhan* finds that many other jurisdictions have wine shops, which may contribute  
10 to the culture and the economic viability of an area.

11       It is therefore the intent of the *I Liheslaturan Guåhan* to add a Class 5 wine-  
12 only license with a fee of four hundred dollars (\$400) per year to the list of various  
13 alcoholic beverage licenses which may be issued.

14       **Section 2.** §3207 of Chapter 3, Article 2, Title 11, Guam Code Annotated  
15 is hereby *amended* to read:

16       “§ 3207. Licenses: Classes and Fees.

17       The Board is authorized to issue the following classes and kinds of licenses  
18 at the following fees:



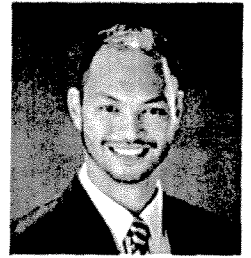
