





COMMITTEE REPORT DIGEST

OVERVIEW

I.

Bill No. <u>353-33</u> (COR) was introduced on July 22, 2016, by Senator Frank B. Aguon, Jr. and was subsequently referred by the Committee on Rules to the Committee on Guam US Military Relocation, Public Safety and Judiciary on July 25, 2016.

The Committee on Guam US Military Relocation, Public Safety and Judiciary convened a public hearing on Bill No. <u>353-33</u> (COR) on a Tuesday, August 2, 2016 at 4:30 PM in I *Liheslatura's* Public Hearing Room.

Public Notice Requirements

Public Hearing notices were disseminated via e-mail to all senators and all main media broadcasting outlets on Tuesday, July 26, 2016 (5-Day Notice), and again on Friday, July 29, 2016 (48-Hour Notice).

<u>Senators Present</u> Senator Frank B. Aguon, Jr., Chairman

The public hearing was Called-to-Order at 4:30 PM.

II. SUMMARY OF TESTIMONY & DISCUSSION

Chairman Aguon:

Thank you very much Sergeant at Arms. Good evening ladies and gentlemen, this public hearing on Bill No. 353-33 sponsored by the Committee on Guam U.S. Military Relocation, Public Safety and Judiciary is hereby convened. The only item on the agenda, like what was mentioned a little earlier is Bill No. 353-33 (COR), an act relative to add a new section one n six to chapter 4, 5 of pubic law 33-66 relative to providing authorization to the Department of Corrections for payments on all obligations incurred in prior fiscal year. In accordance with the open government law, I would like to notify the community that on July 26th, the initial notification was forwarded out to our stakeholders and as well as to our media partners and then the second notice was sent out on the 29th of July, which is last Friday. So, that being the case we are now entertaining Bill No. 353-33. We have one individual, the acting director of the Department of Corrections, Mr. and Senator Tony Lamorena.

Chairman Aguon:

Just for the information of the community, I think the title of this particular proposal is self explanatory in terms of allowing the Department of Corrections the flexibility to be able to deal with their prior year obligations in this fiscal year so that in fact if the Chief Executive is able to identify resources that they can pay off some of their outstanding obligations that was carried over into the fiscal year sixteen. So with that being the case, Senator Lamorena, if you would like to identify yourself for the record and proceed with your testimony.

Acting Director Lamorena:

Chairman Aguon:

Thank you very much Mr. Lamorena for your testimony this evening. Just a couple questions with regards to this. I know that the intent is to ensure that at least the Department of Corrections and the Chief Executive and the Executive Branch has the flexibility to take care of some of these prior year obligations. Are you aware since your arrival to the Department of Corrections in terms of what prior year obligations remain outstanding in the department?

Acting Director Lamorena:

Senator you know in my short tenure there, we're still compiling a lot of the prior year obligations. Our ASO who also just came on board a few months prior to me has been tasked to do that so we're continuing to find additional prior year obligations and currently we have identified in the last three or four years about 1.5 million dollars and this goes from Civil Service Commission settlements to GMH to various other expenses that the department has incurred. So you know again we want to make good on these debts. As we find the funds we would like to pay them off and we want to thank you for allowing us to do that by allowing us to provide language to allow us to use current funding for prior obligations.

Chairman Aguon:

Thank you very much senator and you did identify approximately, you were able to be informed of approximately 1.5 million dollars in prior year obligations.

Acting Director Lamorena:

And senator that could grow once our ASO and myself finish reviewing all the outstanding debts, this amount more than likely will grow.

Chairman Aguon:

Can I direct you to a freedom of information request for DOC prior year obligations dated April 28th 2016?

Chairman Aguon:

When in fact as a result of a FOIA request for prior year obligations and information, your predecessor had provided information as it applies to everything to that date that they identified so that identifies not only overtime, which was addressed shortly there after after this letter was received. So I really appreciate the Department of Corrections catching up with their prior year overtime as well as the current fiscal year overtime up until that day April 28th but then you also have additional obligations to vendors. I have one for JRNA air-conditioning sales and service, another to Todu Maolek and another is to HSP, which is Health Services of the Pacific and then also to GMH and you eluded to several cases not only with the Civil Services Commission, but also there is a civil case 1360-10 so Mr. Lamorena I would like to ask you to please review that and if I can request from you how soon would you be able to provide at least to your knowledge current information as it applies to prior year obligations.

Acting Director Lamorena:

Senator, maybe if you can give me a couple weeks because I know that our ASO and myself are currently at everything. It will probably take us a couple weeks to finally get everything so that we can have it ready for you.

Chairman Aguon:

Like I shared with you, I know your current ASO may have been the individual that assisted with the preparation of the April 28th communication to the committee. So you may want to discuss that with her and find out if in fact, with the exception of the over time, because that was addressed through April and the first week of May of this year. So do you have any outstanding overtime at this point?

Acting Director Lamorena:

You know, I know we're current up to the last pay period and we're working very closely with the US Department of Labor to ensure that we can keep paying on time. So.

Chairman Aguon:

Please. Thank you. Thank you because that was a major expense item up until. Up until that April letter. But if you can review that and then in two weeks time if you can provide, in writing, your findings as the incoming director, as the Acting Director of Department of Corrections, in terms of what you've been able to identify as outstanding obligations. Okay, and then we'll cross reference it with the information that was provided in 28th of April and then we'll proceed forward. I think the intent here, and I appreciate in your letter, Mr. Lamorena that you requested a continuation in the language. I will discuss that with the appropriations chair. The issue with allowing the continuation in the language is that, I really want to make sure that every effort, every concerted effort is made in this fiscal year to try to address most if not all of the outstanding prior year obligations and then we will work into the next fiscal year, subject to things that will take place in November and in January. We'll work towards making sure that a similar flexibility will be provided to the department based on information that we received at, during those times.

Provided the tool and then hopefully, some of these outstanding obligations could be addressed prior to the conclusion of this fiscal year. Okay?

Acting Director Lamorena:

Thank you sir.

Chairman Aguon:

Thank you Mr. Lamorena. I appreciate your attendance this afternoon. This concludes the hearing on bill number 353-33 and if anyone would like to provide written testimony, please forward that information to my office and by the close of business Wednesday next week. The close of this is Wednesday next week and then we'll conclude with the committee report on this piece of legislation and forward it to Committee on Rules for consideration by the body. Thank you very much.

I am appearing before you today to testify in favor of Bill 353-33(COR) "An act to add a new section 1(n)(6) to chapter V of Public Law 33-66 relative to providing authorization to Department of Corrections for payments on all obligations incurred in prior fiscal years."

I would like to thank the author Senator Frank B. Aguon, Jr. for introducing legislation that will allow the Department of Corrections the flexibility to use current funds for prior year obligations. Due to various reasons the department has accumulated prior year obligations and wants to make good on these debts but is restricted due to current language in the budget law. By affording the department the opportunity to use current financial resources we have the capacity to identify any lapse funds to address these concerns. As the legislature moves forward in approving a new fiscal year budget we would also greatly appreciated this language be included so that we can continue to identify and address any prior year obligations that remain.


