Among the items on the agenda was the consideration of **Bill No. 400-33 (COR) - "AN ACT TO AMEND SECTIONS (b)(2) AND (b)(3), BOTH OF CHAPTER V OF PUBLIC LAW 33-66 AND SECTION (b)(3) OF CHAPTER V OF PUBLIC LAW 33-185, RELATIVE TO AUTHORIZING CONTINUING APPROPRIATIONS TO THE COMMISSION ON DECOLONIZATION FOR THE PURPOSE OF CONDUCTING AN EXTENSIVE PUBLIC EDUCATION AND INFORMATION PROGRAM FOR FISCAL YEARS 2015 AND 2016."** by Speaker Judith T. Won Pat, Ed.D.

Chairman Rory J. Respicio called the public hearing on Bill No. 400-33 (COR) to order at 12:30 P.M. and asked Speaker Judith T. Won Pat, Ed.D., the main sponsor of the bill to provided remarks.

Speaker Judith T. Won Pat explained the reason for this bill was brought up at a Task Force Meeting with the concern of how the three different task forces will be able to expeditiously get their monies to be able to have this comprehensive education program knowing that the following the procurement process will become prohibited. The Governor said he would see how they can expedite this. She said that the process proved that even with the Governor's people at the front office asking for three quotes and the expiration of those quotes just pushed time further and further back and monies weren't really made available.

Jose U. Garrido stated that he represents the task force of Free Association. He noted the lack of seriousness of some of the elected officials of the Government of Guam in regards to this issue. He said that he supports the bill. He explained that he was once a student at the University of Guam and shared that the lack of knowledge of the students in regards to self-determination and colonization is because of the attitude of the Political Science

Department whose professors don't want a great deal of responsibility to explain to the students that Guam is a non-self governing territory and the native inhabitants are a self-governing people. He asked for clarification on Page 1, Line 9.

Speaker Won Pat explained that is the original language and the underscore is what she is amending.

Mr. Garrido also noted that the language "be expended exclusively as advised by the Task Forces and approved by vote of the COD" can present a problem because the task force members are members of the COD. He shared that he hopes to not see disapproval of the advice being that the three chairmen are commissioners. He stated that he approves that language. He also highlighted the language of the bill regarding "funds shall not be lapsed." He said that there is no sunshine provision in there. He wanted to clarify within the language "thirty (30) days." He wanted to know 30 days of what specifically.

Speaker Won Pat agreed to amend the bill to say, "thirty (30) days of such procurement and expenditures."

Mr. Garrido said that would be good because it provides for transparency.

Speaker Won Pat personally thanked the panel for testifying in support of the bill.

Chairman Respicio thanked the panel for testifying and **Speaker Won Pat** for being present at the hearing.

No further testimony being offered, Chairman Respicio then declared that Bill No. 400-33 (COR) was duly heard.



and giving the people the inalienable right to self-determination. Collectively, it was very challenging to get people to register. There was much resistance, hesitation, and misinformation among college students and others in our community.

I remember asking students at UOG if they wanted to register for the Decolonization Registry. One student I asked said that they were afraid to register because they felt they were betraying their close family members in the military. The student also shared that when the United States does “leave,” that Guam does not have the capability to sustain us. I shared what knowledge I knew of the registry with this student, which led to having a very long conversation about what decolonization means for Guam. I suggested to the student that they attend the different forums and task force meetings to further their understanding.

Fortunately, the student agreed to register. I was happy that what knowledge I knew was able to help one person see that decolonizing means to no longer be a possession and to be self-governing. Unfortunately, others were more hesitant. It is for this reason that it is paramount to secure the resources to educate our community. It is because the bill greatly benefits our community ensuring the decolonization of Guam that the Social Work Student Alliance stands in support of this bill. *Si Yu'os ma'ase!*


Bill No. 400-33 (COR) aims to extend the time to use the \$150,000 allocated from the General Fund appropriation in Subsection (b)(1) to conduct an extensive public education and information program by the Commission of Decolonization and the Free Association, Independence, and Statehood Task Forces. I propose that there be no restrictions of time to accessing these funds for educational and informational purposes. By having no restrictions, it will allow these task forces to creatively and effectively provide more extensive means of educating the public to raise their awareness on

independence, free association and statehood. These more extensive means could include: conferences, town hall meetings, commercials, media, mobile apps, and learning materials such as pamphlets and brochures.

The enactment of this bill is of significant importance because it will maintain the momentum and increase the education on decolonization. By removing restrictions, it will allow the task forces to reach out to a larger range of the population in a timely and effective manner. Keeping the time restriction could hinder the process of decolonization itself.

As a citizen of the Federated States of Micronesia, I believe that Guam should realize decolonization. I grew up on an island where I could identify as an FSM citizen and be proud of it. When I came to Guam, I was surprised that people were identified as citizens of the United States. I did not see people identifying themselves as the people of Guam or have any sense of national pride rooted in Micronesia. Through decolonization, Guam would be able to identify itself as its own entity and not belonging to another. I want Guam and her Chamorro people to have the same sense of pride I feel as a citizen of the FSM. In my first year as a Social Work student my community's class was tasked with registering residents for the upcoming plebiscite on decolonization. I had reservations about the purpose of the assignment and the eligibility requirements of voters. Because of this I chose to abstain from participating in the assignment. It has been a year since and in recalling my cohort's experiences with the public and the resistance and vitriol they encountered, I realize now that many of the opinions held by some of the public mirrored mine. It has been through my educational career at the university and


interactions with various groups who advocate for decolonization that my opinions have changed. I now see the need for the people of Guam to exercise our right to determine our future. I also realize that my past opinions were a product of misinformation and a Euro-centric educational system and it is an unfortunate reality that many in our community have less than accurate information about the decolonization efforts. I believe that in order for the decolonization movement to gain any traction and in order for the people of this island to make an informed decision, we must be provided with accurate information.

The concept of self-determination is a core value of the social work profession, but equally important is the idea of informed consent. If we as a people are to effectively make an informed decision on our political future, I believe it is important that the choices before us and the implications of each choice be considered.

Currently Bill 400-33 has been introduced to eliminate the deadline placed on moneys appropriated for public education on decolonization. Without this bill the deadline for the disbursement of funds will lapse and the opportunity for comprehensive public education and the dissemination of information will be lost. I hope that you will consider Bill 400-33 and allow the task forces the opportunity to access and utilize these funds by passing the bill into law.
