I. OVERVIEW

Bill No. 56-33 (COR) was introduced by Senator Frank B. Aguon, Jr. on March 17, 2015, and subsequently referred to the **Committee on Appropriations and Adjudication** on the same day.

The Committee on Appropriations and Adjudication convened a public hearing on Thursday, April 16, 2015, beginning at 10:00AM in the Guam Legislature Public Hearing Room. The hearing for Bill No. 56-33 (COR) began at 10:01AM and ended at 10:32AM.

II. TESTIMONY & DISCUSSION

Chairman Benjamin J.F. Cruz announced Bill No. 56-33 (COR), recognized the senators present, and allowed the sponsor of the bill to make an opening statement.

Senator Frank B. Aguon, Jr. thanked Chairman Cruz and continued with his opening remarks:

"This is a proposal that was submitted by representatives from the Judiciary of Guam (Judiciary) requesting consideration in terms of allowing the Judiciary to be able to administer and to acquire federal grants. And my initial question was whether in fact the partnership continues to be a very good working relationship with the Office of the Governor, and the immediate response was 'yes'. So this is certainly not a reflection of any differences that did not exist and does not exist between the Judiciary [and] the Office of the Governor. It's just that this will provide the Judiciary with additional flexibility in terms of pursuing other federal grants that otherwise [are] not readily available to the Judiciary. So I thank you for having the public hearing on this measure, and we look forward to some of the comments to be presented.

Chairman Cruz thanked Senator Aguon and recognized the individuals present to testify: Mr. Joshua F. Tenorio, Administrator of the Courts, Judiciary; Ms. Kate G. Baltazar, Administrator, Guam State Clearinghouse (GSC, Clearinghouse), Ms. Sophia S. Diaz, Staff Attorney, Judiciary; and Ms. Cerina Y. Mariano, Court Programs Administrator, Judiciary.

Mr. Joshua F. Tenorio greeted Chairman Cruz and the rest of the senators present, introduced himself, and read his testimony in support of Bill No. 56-33 (COR) as the Administrator of the Courts for the Judiciary (*appended to this report*). He noted for the record that Judiciary staff attorney Ms. Sophia S. Diaz and Court Programs Administrator Ms. Cerina Y. Mariano, who is principally in charge of administering and applying for federal funds, are present to answer questions.

Chairman Cruz acknowledged their presence and motioned for Ms. Kate G. Baltazar to proceed with her testimony.

Ms. Kate G. Baltazar greeted Chairman Cruz and the rest of the senators present, introduced himself, and read his testimony <u>in opposition</u> to Bill No. 56-33 (COR) as the Administrator of GSC (appended to this report).

Chairman Cruz thanked Ms. Baltazar for her testimony and requested that she stay for the public hearing of Bill No. 74-33 (COR) as the Committee may have some questions relative to the status of certain federal grants, to which she acquiesced. Chairman Cruz opened the floor for questions.

Senator Frank Aguon, Jr. thanked Chairman Cruz and addressed Mr. Tenorio:

"I thank you for bringing your grants administrator in the Judiciary. I'd like to understand some of the concerns the front office has, which obviously are very legitimate coming from your perspective. And the way I view this particular legislation is certainly not only recognized in the co-equal branch of government, but there are a number of grants that still must go through the state representative, which would be the Office of the Governor—the Administrator of the Federal Grants through the executive branch. And this would not remove that particular process. It would just—and I hope that the Grants Administrator or Mr. Tenorio will be able to better explain entire process—but I want to see if in fact there can be some clarification provided with regards to the issues that you expressed, because certainly this legislation is not in any way meant to be negative toward the administration but to provide the Judiciary with an additional tool that they can go out and much more aggressively pursue federal grants."

Mr. Tenorio responded:

"Ms. Baltazar has presented – the arguments that she's making are actually offensive to the Judiciary. It makes it clear that the intent for the Judiciary to be subordinate to the executive branch and to be subject to their review and compliance. And I think that is counter to the separation of powers. And the second thing I would refer to the Committee members is to reference the White House Office of Finance and Budget web site which lists that there are only twenty (20) states remaining in the union that have intergovernmental review by clearinghouses. We are not suggesting or recommending that the Clearinghouse be abolished in Guam, but if you're going to further review this matter as [Ms. Baltazar] said based on federal policy, then you'll see that the majority trend of the states of the union to move away from such intergovernmental affairs intergovernmental review for government entities to be a bit more competitive with each other, to make sure the right kinds of programs are being funded. So that would be my response."

Chairman Cruz thanked Mr. Tenorio for his position, and noted to Ms. Baltazar that she edited out a bold part of her statement, which **Ms. Baltazar** confirmed. Chairman Cruz continued:

"I think it addressed something that Mr. Tenorio mentioned. The separation of powers and the statement you bolded in your written testimony but you edited out and not utter was 'not to mention the egregiously eroding powers of the executive branch.' Was there a reason for that?"

Ms. Baltazar responded:

"Yes, and I would like to thank [Mr. Tenorio] for those comments. I could see how he could feel the tone of my testimony. However, I think the point here is that I do not believe that the Judiciary is subordinate inasmuch as it is a partnership. And we certainly don't seek to overstep or encroach on the separation and the recognition of independence. We do congratulate the Judiciary: they have stellar and outstanding performance on their grants; that is to be noted. However, we cannot afford diminishing the powers that we already have, to answer your question."

Chairman Cruz asked Ms. Baltazar whether the Clearinghouse will submit testimony from the Governor asking the Legislature to repeal the exemptions given to the other agencies.

Ms. Baltazar responded:

"If you are referring to the [Guam] Department of Education (GDOE) or the University of Guam (UOG), they are under executive purview in some way or fashion. In some sense, we can already see and look at some input and some funding, and while they do not come under our process, they are still under executive purview. To answer your question, I don't feel that a testimony is necessary to repeal the exemptions."

Chairman Cruz asked Ms. Baltazar if there will legislation proposed to ask for the repeal of exemptions.

Ms. Baltazar replied:

"At this point, no."

Chairman Cruz further inquired about "Pillar Number 2: Monitor and Compliance" [of Ms. Baltazar's testimony], specifically whether the Clearinghouse has had problems with the monitoring and compliance of the grants received by the Judiciary or the comment about the Judiciary's stellar performance stand as it relates to this area.

Ms. Baltazar replied:

"It certainly does stand. As I've mentioned, we've had a really good working relationship with their federal programs. And Jackie Cruz was on it before and now Serena Ray Dungca and the team. We have a wonderful working relationship with their court programs office. And we do not have any issues that this juncture or with their monitoring, compliance, performance, deliverables, etc."

Chairman Cruz asked Ms. Baltazar whether she, in the four years that she has served as Administrator, has known of an issue with the Judiciary in any of its applications that would have pause or reason to keep the Judiciary within her office's purview.

Ms. Baltazar replied:

"No, Vice Speaker. And the GSC to the Judiciary has not been a hindrance by mere fact that they [perform] concurrent review which is not a preclusion to applications. So [the Judiciary does not] need in some instances our clearance to apply for grants but [GSC reviews the applications] as a courtesy just to make sure that [the Judiciary is] running [the application] through our processes as well. In essence, we're not a hindrance inasmuch as we are a partner in ensuring that the projects are sound as applied for."

Chairman Cruz asked Ms. Baltazar to confirm that GSC reviews the Judiciary's grant applications despite protocol, to which **Ms. Baltazar** replied affirmatively. He questioned Ms. Baltazar further:

"And [for the application for] grants that [the Judiciary has] to cooperate with you, [it does so] because either an executive agency—or like the Guam Police Department or the Attorney General's Office—needs to be the main grantee; they all work with you on that?"

Ms. Baltazar replied:

"That's correct."

Chairman Cruz asked Ms. Baltazar:

"And you can't point to any point in the last four (4) years when you've been the head where there's been a problem with your relationship with the Judiciary as it relates to either the grants that they can apply for directly, or the grants they have to apply to conjointly with you?"

Ms. Baltazar responded:

"No. We have not taken issue with any of their applications, but we do certainly appreciate the relationship that they send forth through our processes concurrently."

Senator Rory Respicio thanked Chairman Cruz and posed a follow-up question for Mr. Tenorio:

"So, even if this bill passed and became law, there's nothing that would stop the current relationship. There's nothing that would stop the Judiciary from having the GSC as a courtesy concurrently review these grant applications. Do you foresee that that relationship can still continue?"

Mr. Tenorio answered affirmatively.

Senator Respicio remarked:

"And I think that's where you would draw the fine line and respect the separation of powers' authority. I remember when this was amended to take out

> the Guam Community College, UOG, GDOE, because to have to run-we're recognizing that these agencies deal with education and that's something within their scope of authority. And I think at the time, there was some concerns with your predecessor in how long the review took and how this government was actually losing opportunities to pursue these federal grants because of this review requirement. But I think the bill, if we're going to approach this, as the sponsor said – which I absolutely agree that it's time that we examine all of our statutes, and anywhere where there is some semblance of micromanaging a third branch of government, and not respecting a third branch of government as it being separate but coequal. I certainly would support something like that. So I understand Ms. Baltazar where you're coming from. I would probably take the same position if anybody wanted to take any of my authority away, but as you admitted in your testimony and in your follow-up responses, you really have not exerted that authority over the Judiciary, and you've never really told them, 'Don't pursue this grant,' or has there been a- there has never been an instance where they've asked you to concurrently review something and you basically said, 'No, this is not in line with what the island, the Government of Guam is supposed to be doing.' And so you've objected [to this bill]?"

Ms. Baltazar replied:

"Well, Senator, while that's true up until this point, we can't foreseeably grant this in perpetuity. Because in the future, such as [for] grants that do require intergovernmental review, we may or may not by virtue of this law be able to provide that clearance, which will cause us not to be able to avail of certain grants."

Senator Respicio continued:

"But in most instances, if you're going to do something to make it in perpetuity, it would be based on a track record. And you've admitted that their past performance has been nothing but stellar, and I can certainly attest to what the Judiciary has done over the years to pursue these federal funds, and to provide for a holistic approach to therapeutic jurisprudence so that they're not totally reliant on general fund resources. And so, I think the time is right. The Judiciary has proven themselves. And I think, and I hope that you would reconsider your position and embrace this, because if there's any semblance of this kind of relationship continuing, really would [change] your approach to this bill, and again I would hope that you would reconsider. Thank you Mr. Chairman."

Senator Tommy Morrison thanked Chairman Cruz, and thanked the panel for their testimony. He proceeded to ask Ms. Baltazar about the bill's impact on GSC, specifically administrative costs or any of the agency's resources.

Ms. Baltazar replied that the bill has no impact on GSC, and further explained:

"While there are indirect costs that are captured by the government, they're spread throughout the government. Essentially it would not have a financial impact on our office whatsoever. And I thank you for commenting; as I remember, you were working for then-Senator Kaleo Moylan in modernizing the current statute, so I thank you for that comment."

Senator Morrison continued:

"Right. And again I was leading in that direction because I remember there were many folks involved in trying to expand the GSC level and having a fully functional clearinghouse with housing many grants administrators throughout our government, and just having them go after whatever funding is available out there. As they do not only in the other states [and] jurisdictions, but also territories where these models are in place for, where there is so much opportunity but they were housed. And that was the vision behind that at the end. But, I think, I'm glad that my colleagues brought up the separations of powers, but I'm more or less focusing on the intergovernmental review process. Can you make it clear to the Committee that this does not impact any process? Apparently, this process has been in place for many, many years. And we see the relationship there. I remember working with the Judiciary, as a member of the GSC from [Bureau of Statistics and Plans] (BSP) and on some great grants. I'm very aware of the capacity there of those folks that help to facilitate these grant programs. Do you see what, how this would impact inter-government process in the future?"

Ms. Baltazar replied:

"Well, certainly. I feel as though it won't. Truly, it will not. There's nothing absent of this bill that precludes them from seeking federal assistance, applying for federal assistance, getting grants directly and we're not a hindrance to that in any way. Obviously they do so quite regularly and [they] receive and manage their grants. Absent of this bill, there's nothing that would cause hindrance."

Senator Morrison proceeded to pose his last question to Ms. Baltazar:

"You notice here in your testimony, BSP is a member of GSC; has there been plans to look at how when we look at growing building capacity or the membership, or building the continuity with those folks that go after each grants that are available for our island? Have you looked at BSP as an agency to build up on that? I've always looked at that, that could also house many administrators [who can] mainly focus on grant opportunities that are available, as a direct support to the GSC. And I know there are guys out there like Terry Quabo with great ideas and were working on some plans with the Lieutenant Governor at the time but have you seen any plans that are being pursued into that end?" *Committee on Appropriations and Adjudication Committee Report Digest for Bill No. 56-33 (COR), As Introduced Page 8 of 9*

Ms. Baltazar replied:

"At this point, Senator, we have not. We are open to that. That is something we can take back and explore further. But in relation to what we're discussing today, I do hope that this doesn't come across as a means to encroach on powers. We do respect that [the Judiciary] is separate and equal branch. Absolutely. There's no contention there. However, I feel that there is no room to gamble with our future and our federal funds. And not having a way by which certain programs are vetted, if not all. If I certainly had it my way, there would be a full-fledged office of grants management. We've just seen [the conferment] high-risk grantee status and funds returned every day. I wish I had that capacity, you know, to make sure that we don't send forth applications that are unrealistic, or have deliverables that are not in line with our plans to begin with. And, unfortunately, we don't have that capacity. However, at this point, I just feel that this is not an encroachment to powers. We can't afford diminishing the powers we currently have."

Senator Morrison continued:

"I'm glad that you're there, Ms. Baltazar. I'm glad some past visions of the former Lieutenant Governor is there. I really want to see GSC expand and go after grant opportunities. We see other territories that aggressively seek these opportunities for their territory. And the vision is always there because what I see and from experience, the grants administrators are doing their best, reaching out to whatever opportunities are available. However, not only the grants administrators but also the implementers of these grants stretch themselves very thin. And we have a house that continuously goes after these grants, and farms them out to the necessary agencies and let them start with these implementations. Because of the way things are designed now, we're seeing grants. However, we're also seeing them get tied up with over-implementation, all the way to the end result of the grants. And they end up stuck going after another grant. So I hope those plans go back into place and thank you, Mr. Chair."

Chairman Cruz remarked:

"Actually, Ms. Baltazar, you brought up a very sore point with me. Because it would seem to me that the Clearinghouse should pay more attention to the executive branch currently. And as you put it—I wasn't the one that said it as you were the one that broke it open—that every day your executive branch department [heads] are sending back millions of dollars. Some of them are sitting in this room today. And it would seem to me that you have had your hands full and should probably tend to your branch of government and leave the one that you yourself described as having 'stellar performance in compliance and implementation' to handle itself—but keep your house clean first."

Ms. Baltazar said that she absolutely does not disagree with Chairman Cruz and that his comments are noted.

Chairman Cruz notified Ms. Baltazar that he plans to file another Freedom of Information Act request to identify the amount of federal grants returned in the last year. He added that he has been pursuing the information from departments and he is shocked every time he sees how much money the government is returning. He stated that he intends to find out how well GSC is complying with its second pillar of monitoring compliance. He thanked the panel for their testimonies and, on account that there were neither further questions from the Committee nor other individuals present to testify, considered Bill No. 56-33 (COR) heard.

III. FINDINGS AND RECOMMENDATIONS

Dear Vice Speaker Cruz:

Hafa Adai! Thank you for providing the opportunity to testify IN FAVOR of Bill No. 56-33(COR), AN ACT TO AMEND §2101.1(F) AND §2101.3 OF CHAPTER 2, TITLE 5 OF THE GUAM CODE ANNOTATED RELATIVE TO RECOGNIZING THE INDEPENDENCE OF THE JUDICIARY OF GUAM RELATIVE TO THE RECEIPT OF FEDERAL FUNDS.

In recent years, the legislature has amended 5 GCA §2101.1(f) to exempt the University of Guam, Guam Community College and most recently the Department of Education from requiring the final approval of the Guam State Clearinghouse when applying for federal funds. This legislation will simply add the Judiciary of Guam to this list of government entities already exempt.

The legislation will properly recognize the Judiciary as an independent and co-equal branch of government as it relates to the receipt and expenditure of federal funds and will empower the Judiciary to pursue funding opportunities limited to state and local courts by the Department of Justice, the State Justice Institute, private foundations, and other funding agents.

This authorization will not be applicable to grant opportunities requiring designation by the Governor of Guam as a state agency authorized to apply for grant funding. In these cases, we would continue our working partnership with the Office of the Governor and the executive branch to address programs that improve the criminal justice system of our island.

The Judiciary of Guam is already the recipient of grant funds that provide direct services, resources, and programs to support collaborative work with the Guam Police Department, the Department of Corrections, the Office of the Attorney General, and the Department of Youth Affairs. We will continue to find opportunities for system improvements and continue to partner with these agencies.

The Judiciary has an excellent record of accomplishment in managing and expending federal resources to improve and expand effective services for our patrons. Our Court Programs Office is on an aggressive track to develop programs and apply for funds to expand and enhance our therapeutic strategies, reduce recidivism, implement evidence-based programs, manage sex offenders, incorporate technology and address courthouse security.

We have seen program successes in the Sex Offender Registry, Adult Drug Court, Juvenile Drug Court, Mental Health Court, and Family Violence Court, with work underway in the newly established Veterans Treatment Court and the Justice Corps Program.

The Judiciary recognizes that the sharing of information across the government of Guam is extremely important toward efforts to maximize financial assistance to the island and will continue do so if Bill No. 56-33(COR) becomes law.

Hafa adai, Senator Aguon and committee members-

I am Kate Baltazar, the Administrator of the Guam State Clearinghouse. I am here before you today to unequivocally testify against the passage of Bill 56-33. There are three pillars of purview for GSC, two of which I will speak on further to support our position:

- . The first pillar of purview of the Guam State Clearinghouse known as Intergovernmental Review, while granted under local law [Cite GCA here], originated in a 1983 Executive Order issued by then-President Ronald Reagan. This is a mechanism to ensure a way by which grant applications are reviewed by various entities, to include Legal, Bureau of Statistics and Plans and Fiscal – determining whether the grant application is in line with various state/territorial plans. In so doing, this would make certain that government resources are not overcommitted in the proposed projects and are utilized accordingly. This system of **checks and balances** is in place to **safeguard our** already overcommitted resources. Passage of this bill would remove the critical and necessary means by which we determine that only the most effective and essential proposals are sent forth. No branch of government should be exempt from this process, not to mention egregiously eroding the powers of the executive branch, directly contrary to the Presidential Executive Order's intent.
- In addition, many federal funding agencies require intergovernmental review for various projects, again not solely as GSC policy, but as mandated by the federal government. There exists a document published every fiscal year that lists these programs, as provided with my written testimony.

- Input from across the country by and large include their judiciaries in the
 intergovernmental review process. Sheila Lambert, Grants Manager for State of
 Nevada states: Nevada's judiciaries participate, unless specifically excluded by the
 federal grant announcement. We operate under the premise that the State cannot
 over-rule the federal EO, regardless of agencies. We operate with the judiciary,
 attorney general's office, district, municipal and supreme court in the same way. It
 is not a matter of what "agency" or branch of the "government" but more about
 ensuring federal compliance with grant funds, of which our office is responsible.
- Our second pillar of purview is **monitoring and compliance**. This has been a dormant power of the GSC in past administrations, which is apparent in the various agencies with a high-risk grantee status and years of millions in lost or returned federal funding. Since becoming the Administrator, the Guam State Clearinghouse has been ever more aggressive in monitoring federal grants across the board throughout the government; we have saved millions of dollars in potentially lost federal funding through our advocacy with federal funding agencies, corrective action plans and increasing capacity and skills through an annual grantsmanship training. Monitoring and compliance is a provision granted by law and when exercised has proven to be effective and beneficial to our government.

I will close my testimony to this good body with this: In practice of good government, we amend our laws to become **more aligned** with meeting federal standards and requirements, to provide greater transparency and accountability. We must do all we can to encourage better monitoring and compliance of grants throughout the government. This bill seemingly is contradictory as such.

Executive Order 12372--Intergovernmental review of Federal programs

Source: The provisions of Executive Order 12372 of July 14, 1982, appear at 47 FR 30959, 3 CFR, 1982 Comp., p. 197, unless otherwise noted.

By the authority vested in me as President by the Constitution and laws of the United States of America, including Section 401(a) of the Intergovernmental Cooperation Act of 1968 (42 U.S.C. 4231(a)), Section 204 of the Demonstration Cities and Metropolitan Development Act of 1966 (42 U.S.C. 3334) and Section 301 of Title 3 of the United States Code, and in order to foster an intergovernmental partnership and a strengthened federalism by relying on State and local processes for the State and local government, it is hereby ordered as follows:

[Preamble amended by Executive Order 12416 of Apr. 8, 1983, 48 FR 15587, 3 CFR, 1983 Comp., p. 186]

Section 1. Federal agencies shall provide opportunities for consultation by elected officials of those State and local governments that would provide the non-Federal funds for, or that would be directly affected by, proposed Federal financial assistance or direct Federal development.

Sec. 2. To the extent the States, in consultation with local general purpose governments, and local special purpose governments they consider appropriate, develop their own processes or refine existing processes for State and local elected officials to review and coordinate proposed Federal financial assistance and direct Federal development, the Federal agencies shall, to the extent permitted by law:

(a) Utilize the State process to determine official views of State and local elected officials.

(b) Communicate with State and local elected officials as early in the program planning cycle as is reasonably feasible to explain specific plans and actions.

(c) Make efforts to accommodate State and local elected officials' concerns with proposed Federal financial assistance and direct Federal development that are communicated through the designated State process. For those cases where the concerns cannot be accommodated, Federal officials shall explain the bases for their decision in a timely manner.

(d) Allow the States to simplify and consolidate existing Federally required State plan submissions.
Where State planning and budgeting systems are sufficient and where permitted by law, the substitution of State plans for Federally required State plans shall be encouraged by the agencies.
(e) Seek the coordination of views of affected State and local elected officials in one State with those of another State when proposed Federal financial assistance or direct Federal development has an impact on interstate metropolitan urban centers or other interstate areas. Existing interstate mechanisms that are redesignated as part of the State process may be used for this purpose.
(f) Support State and local governments by discouraging the reauthorization or creation of any

planning organization which is Federally-funded, which has a Federally-prescribed membership, which is established for a limited purpose, and which is not adequately representative of, or accountable to, State or local elected officials. **Sec. 3.** (a) The State process referred to in Section 2 shall include those where States delegate, in specific instances, to local elected officials the review, coordination, and communication with Federal agencies.

(b) At the discretion of the State and local elected officials, the State process may exclude certain Federal programs from review and comment.

Sec. 4. The Office of Management and Budget (OMB) shall maintain a list of official State entities designated by the States to review and coordinate proposed Federal financial assistance and direct Federal development. The Office of Management and Budget shall disseminate such lists to the Federal agencies.

Sec. 5. (a) Agencies shall propose rules and regulations governing the formulation, evaluation, and review of proposed Federal financial assistance and direct Federal development pursuant to this Order, to be submitted to the Office of Management and Budget for approval.

(b) The rules and regulations which result from the process indicated in Section 5(a) above shall replace any current rules and regulations and become effective September 30, 1983.

[Sec. 5 amended by Executive Order 12416 of Apr. 8, 1983, 48 FR 15587, 3 CFR, 1983 Comp., p. 186]

Sec. 6. The Director of the Office of Management and Budget is authorized to prescribe such rules and regulations, if any, as he deems appropriate for the effective implementation and administration of this Order and the Intergovernmental Cooperation Act of 1968. The Director is also authorized to exercise the authority vested in the President by Section 401(a) of that Act (42 U.S.C. 4231(a)), in a manner consistent with this Order.

Sec. 7. The Memorandum of November 8, 1968, is terminated (33 *Fed. Reg.* 16487, November 13, 1968). The Director of the Office of Management and Budget shall revoke OMB Circular A-95, which was issued pursuant to that Memorandum. However, Federal agencies shall continue to comply with the rules and regulations issued pursuant to that Memorandum, including those issued by the Office of Management and Budget, until new rules and regulations have been issued in accord with this Order.

Sec. 8. The Director of the Office of Management and Budget shall report to the President by September 30, 1984 on Federal agency compliance with this Order. The views of State and local elected officials on their experiences with these policies, along with any suggestions for improvement, will be included in the Director's report.

Appendix I: Programs Requiring Executive Order 12372 Review

This appendix lists programs requiring Executive Order 12372 review. Executive Order 12372 "Intergovernmental Review of Federal Programs," structures the Federal government's system of consultation with State and local governments on its decisions involving grants, other forms of financial assistance, and direct development. Under E.O. 12372, States in consultation with their local governments, design their own review processes and select those Federal financial assistance anddirect development activities they wish to review.

Since October 1, 1983 most States have acted to establish a review and comment system in response to E.O. 12372. In such cases, applicants for grants will need to meet the requirements of the intergovernmental consultation process established by a particular State and its local governments before Federal agencies take action on an application.

For more information on the process a particular State requires to be followed, an applicant should contact the office or official designated as the single point of contact in his or her State. Consult the individual program description in the Catalog to determine whether the programs under which he/she plans to apply is subject to E.O.12372. Consult the Federal agency's application package for instructions on State notification.
