



#### **COMMITTEE REPORT DIGEST**

#### OVERVIEW

1.

The Committee on Guam US Military Relocation, Public Safety and Judiciary convened a public hearing on Friday, July 29, 2016 at 4:30 PM in I *Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of Alberto A. Lamorena, V. to serve as the Director of the Department of Corrections (DOC), and whose appointment history is as follows.

- Appointed by the Governor of Guam on June 20, 2016, to serve at the pleasure of the Governor;
- Appointed packet forwarded to I Liheslatura on July 12, 2016;
- Appointment packet forwarded to this committee for public consideration on July 12, 2016.

#### **Public Notice Requirements**

Public Hearing notices were disseminated via e-mail to all senators and all main media broadcasting outlets on Wednesday, July 20, 2016 (5-Day Notice), and again on Wednesday, July 27, 2016 (48-Hour Notice).

The public hearing was Called-to-Order at 4:30 PM.

#### II. SUMMARY OF TESTIMONY & DISCUSSION

#### Chairman Aguon:

The confirmation hearing on the appointment of Mr. Anthony Lamorena as Director of the Department of Corrections is hereby convened, sponsored by the Committee on Guam US Military Relocation, Public Safety, and Judiciary. For information of the general public, the initial notification was forwarded to our stakeholders as well as to our media partners on the 20<sup>th</sup> of July, and the second notification was forwarded out to the community on the 27<sup>th</sup> of July. This afternoon's agenda has one particular item, and it was mentioned earlier. Can I please invite Mr. Tony Lamorena to please join us in the front? Okay let me start off with the others who may want to testify. I know that Joe signed in, and I want to thank everyone who are in attendance for signing and signifying whether you are here in support or if

If any of you will be providing oral testimony this evening, I would like to invite you to the front. I would like to also, before we recognize any of you to provide your testimony on the appointment of Mr. Tony Alberto A. Lamorena, V. as the Director of the Department of Correction, I would like to recognize my colleague and member of the committee Senator Tommy Morrison. Thank you Senator Morrison for joining us this evening, and we will start from your far left. So, if you can just identify yourself for the record, please proceed with your testimony and the appointment.

#### Mr. Jeffrey Limo:

I am Lieutenant Jeff Limo, Department of Corrections Internal Affairs Supervisor. Good afternoon Mr. Chair, Senator Tommy Morrison. It's my pleasure to sit before you to endorse Tony Lamorena to be the Director of Corrections. Tony has been here approximately a month, a month and a half now and after sitting with Mr. Lamorena, conversing with what he has planned for DOC in the next two years that he has up there, he has a very interesting vision. Again, two years that Tony has a lot to work with the upcoming dissent decree. He has a good vision on that. He's faced with the new 43 recruits now that we're hiring, and he's on board to help alleviate some of the overtime in the Department of Corrections. He's very clear with that. What Tony's month and a half has done here, he's really established the command staff to: 1) give the chain of command back to its operations which is the adult correctional facility, and having said that, now Tony's concentrating merely on the admin part of Department of Corrections which was, for the longest time, one of the hardest tasks up in DOC. Tony comes from a dynamic administrator around Guam. He served GVB, CAHA, and then now Department of Corrections. So I ask you Mr. Chairman and Senator Tommy Morrison, that we give Mr. Lamorena an opportunity. Again, he's going to be my ninth director, and I have confidence that he will carry out the mission. That's all I have.

#### **Chairman Aguon:**

Thank you very much Lieutenant. I noticed you were counting. Ninth director. Mr. Lamorena?

#### Mr. Anthony Lamorena:

Anthony Lamorena, private citizen. [Written Testimony attached]

#### Chairman Aguon:

Thank you very much Mr. Lamorena. Mr. San Agustin?

#### Mr. Joe San Agustin:

Mr. Chair, Senator Morrison, good afternoon. I thank you for the opportunity here this afternoon to speak in support of Tony Lamorena as the next Director of the Department of Corrections. My name is Joe San Agustin, and I'm the prior Director of the Department of Corrections. I've known Tony for probably 6 years, and I knew Tony as he was the administrator for the Civil Service Commission. I have high regards and high respect for Tony. He's been in government for a long time. Tony understands policy. Tony understands government, and there's not much more I could speak of someone who is taking the helm of the Department of Corrections but Tony. He's got a vision. He's got the compassion. He's got the knowledge, and he's got the heart to lead the men and women of the Department of Corrections. This afternoon I'm here to ask you all to please consider and confirm this individual as one of the highly most qualified individual to take over the Department of Corrections. Thank you very much.

#### **Chairman Aguon:**

Thank you very much Mr. San Agustin. Senator Morrison any questions for the panel?

#### Senator Morrison:

Thank you Mr. Chair. I just wanted to comment and thanks Mr. Anthony Lamorena, Jr for sharing his kind words. After his father, I know those words are so sincere, and everything I know you put in there were a direct experience because everywhere your father went you were right next to him, and I appreciate that you're here today.

#### **Chairman Aguon:**

Thank you very much Senator Morrison. Gentlemen thank you. You're dismissed. We do have a few more individuals who have signed in that if by any chance you're going to provide oral testimony, you're more than welcome to join us up front. We have Julius Tano and Rebecca Concepcion. If either of you are going to provide oral testimony, you're more than welcome to join us up front. Okay. Mr. Lamorena. Senator. Please identify yourself for the record and please proceed with your testimony.

#### Mr. Alberto A. Lamorena, V.:

Thank you senator. My name is Alberto Tony Lamorena V. Senator Aguon, chairman of the Committee on US Military Relocation, Public Safety, and Judiciary. Senator Tommy Morrison and the other members of the committee. Many of you know me. I've served in the government for over 30 years in various capacities, and every government agency is a challenge. Every government agency is unique, and the Department of Corrections is in fact one of those very unique organizations. I want to thank the governor and lieutenant governor for appointing me to be the director of corrections, and I'll be honest with you, when they first tapped me, in my mind, I was the general manager for GVB and the Bureau of Statistics and Plans, which Senator Morrison was also director of, and various other agencies, and DOC was definitely a challenge. It's a paramilitary organization. It was very different from what I've normally managed in the past, but I tell you after 4 weeks of working in the Department of Corrections, I love it, and I am proud to be the Director of Department of Corrections and serving under these fine men and women who are behind me. They are in fact true professionals, and I applaud them. Every day my wife says, "So how's work?" I say, "I love it." I wake up every morning looking forward to go to work because it's a challenge, and it makes it so much easier when

you have professionals such as these fine people behind me to back you up. What we face at the Department of Corrections obviously is a staffing shortage. We wanted to thank the legislature. We're currently processing 43 individuals. I believe we're just almost including the polygraph test, and we'll be doing the psych examinations shortly, and hopefully, we'll try to get these individuals on board so that we can begin to relieve some of the undue stress on of our current personnel. Being short-staffed makes it difficult for our staff to take the necessary time off. We've also established a committee that's going to look at reestablishing or reorganizing our schedules so it gives more opportunity for our officers to have time off and spend quality time with their families. Of course, in the same token, we're going to be cutting down on overtime. This year alone, we're hitting almost three million dollars in overtime. Our projection for next year is to stay within budget of a little over a million dollars, and so it's going to take dedication and hard work from everyone within the organization. One of the things that I was really tremendously impressed with when I, on my first day in, first of all, you know my first week was a, talk about baptism under fire. On my second day, Judge Tydingco-Gatewood, we had an inspection of DOC because of our dissent decree, then I went to court that afternoon, and then the following Tuesday, we had our budget hearing which was a budget that I didn't put together so I was not as familiar with it as I should have been, but I trusted the prior director and the staff to ensure that all the necessary expenses and needs were covered for next year, and I applaud former Director San Agustin for his leadership and likewise with the deputy director and the entire staff. Because really, an organization functions not because of one individual. I've always believed, in my years of service in the government of Guam, is that a true leader leads an organization that can function without the leader. If I, as a manager of any organization, left that organization tomorrow, and that organization can function without me, then I've done my job. If an organization needs a leader in order to function because it needs constant direction, then obviously that manager was a micromanager, and that I am not. I allow people to do their jobs. That's what we pay them for. I am there to support them, to see what they need, and to assist in any way that I can. So, DOC is guite unique, and you know I apologize that I don't have a written statement, but my schedule has been really busy, and I really haven't had time to sit down and really write something, and senator trust me I will, and I will prepare that for you and get that to you, but as we move forward in the Department of Corrections, and I'd like to offer the senators a tour of the facility. The staff has done a tremendous job with the facility. It's old. You know, it was intended for about 300 inmates. Currently we have, including detainees, over 700, but it's clean. It's functional. When I was a senator in the 90s, and I took a tour of the Department of Corrections, what you see today is just night and day. I mean, you can literally eat off the floor. I mean you don't want to, but you literally could, and a lot of it is because of the dedication of the staff at the Department of Corrections, and you know I might seem like I'm constantly applauding them for their work. It's because they deserve it, and the more and more and every day I continue to work there, I understand more and more... You know I am their student at this point in time. They are teaching me what DOC is all about, and one of the things that we have a tendency of forgetting what DOC is. I remember during the budget hearing, our budget hearing a couple of weeks ago, and the senators were strictly asking me questions in relations to incarceration, but we also need to remember that, using the holistic approach, we are also a correctional facility. It's our responsibility to ensure that we provide the necessary skills and training to individuals, so that when they leave our facility, they don't come back. Our recidivism rate is 68%. That means 68% of the people that leave our facility come back. visitor rate was 35%. I will come to the legislature asking for more money so we can increase that visitor return rate. Well, I'm coming to you so we can decrease it. We don't want to see individuals come back. We want to be able to provide the necessary skills to these individuals, so that when they're released, they can make a living outside the walls of the department of corrections. The former director and a lot of the staff set had very good foundation. They set the foundation with the Guam Trades Academy, in fact I met with them today, including with the Department of Labor, and they've been able to train individuals who are certified to teach the core skills within DOC, so we're going to continue that program. I've met also with Dr. Robert Underwood to see what we can do to collaborate, and then I'll be meeting with GCC and other industry partners to see what we can collaborate in establishing training programs within the facility that will give them the certification. You know it's hard enough for an individual to have that cloud over their head that they're an excon, but if they leave our facility with a certification that they're skilled in a certain skilled labor, it gives them more opportunity to succeed in life, and I think that's our goal. Our goal is not to incarcerate, but our goal is also to create the environment necessary so that we can lower that recidivism rate. I mean that's our primary function, and I think that the dedication of the men and women, the folks in social work, and we have Dr. Taimanglo here. I mean these are individuals that are dedicated to their work, and we're going to try our best in the next two and a half years to establish programs that will eventually reduce the number of individuals that return back into the system, and hopefully, we can feature more of the successes rather than the failures. Thank you senator.

#### Chairman Aguon:

Thank you very much Mr. Lamorena. Just a couple of items that I know that you touched on in terms of overtime. Right now you're tracking approximately three million dollars in overtime, and you anticipate that in a matter of two months, three months, you're going to start trimming that significantly down to incur an obligation of about a million dollars in the subsequent twelve months.

#### Mr. Alberto A. Lamorena, V.:

We are going to try our best senator.

#### **Chairman Aguon:**

That's very ambitious.

#### Mr. Alberto A. Lamorena, V.:

Yes it is.

#### Chairman Aguon:

But I don't know if you've ever had any of your people really crunch the numbers in terms of what the anticipated overtime will be, and I say this because three years ago you accumulated, if my numbers serve me right in terms of looking at your oversight hearing, in the documents you accumulated about 1.8 million dollars. Prior to this fiscal year, last fiscal year you accumulated 2.3 million dollars in overtime. Now, you're tracking 3 million dollars. You're trying to close the loop in processing 43 recruits to bring them on, but even with that, the requirement in terms of the overall training to get them ready and suited so, in fact, they can serve in any capacity within the confines of the Department of Corrections and ensure the public that SUITE 503, DNA BLDG, 238 ARCHBISHOP FLORES STREET HAGATNA, GUAM 96910

#### Chairman Aguon:

their safety is continuing to, is being provided. That training timeline is anywhere from six months to a year. So, I think that it's very ambitious that you're making a public pronouncement of reducing the overtime to 1 million dollars, when in actuality those are factors that really have to be considered, and that doesn't even take into consideration of the attrition rate of your personnel in terms of just over the course of the last two years you've had double digit attrition rates in terms of uniform personnel. So, there are challenges the Department of Corrections has, and I bring this up because I recognize that overtime, the Department of Corrections is a necessary factor. It's how can we work towards making sure that we can keep that to a minimum so that we don't overwork our personnel. We give them the opportunity to be able to spend time with their families, and that we allow for other individuals to be able to assume that additional responsibility by virtue of bringing additional officers, correctional officers, into the system. The other issue that I want to bring to your attention, and I'd like to see if I can get some thoughts from your, in terms of prior year obligations because I know that there are a few items that remain pending in terms of addressing prior year obligations. What are your thoughts in trying to close the loop on that and making sure that your personnel are compensated for anything that's outstanding?

#### Mr. Alberto A. Lamorena, V.:

Of course, see I know senator that you introduced legislation at the public hearing scheduled for Tuesday, and we'll be there to support your legislation. You know any opportunity to be given the authority to pay our past due debt. It would help us tremendously. Again, you know, the bill doesn't appropriate additional money, but to work within our existing budget. So, again we're going to have to get very creative. In regards to cutting down on overtime, again you know with the staff, we'll be meeting, and we'll be devising a scheduling alternative so we can see what we can do to in fact cut back on overtime but also allow our officers more time off and more quality time with their families. We're looking at various schematics at this point in time, and you know, hopefully we can come up with some workable solutions by the time our 43 new recruits come on board, but in regards to our prior year obligations, of course we would like to bury that debt. These our obligations that we do owe, but we have been unable to pay them because we don't have the proper authorization based upon the current budget allocations to spend current appropriations for prior debts. By allowing us that opportunity, it gives us at least the opportunity to see at least where we can move money around, so we can pay off this existing debt.

#### **Chairman Aguon:**

I'm pleased to hear that certainly that's an issue that you want to get off your books in terms of carrying over prior year obligations. I know you mentioned about the recidivism rate and try to ensure that these individuals who exit your doors at the Department of Corrections do not return, and I think that's certainly an area that we as a community, and particularly Department of Corrections, really has to focus on in terms of making these individuals, ensure that these individuals who exit the Department of Corrections look at that facility as correctional in nature and rehabilitative in nature so that they can eventually have a decent lifestyle outside of that particular facility. The other aspect is with detention. You know there are various programs that are being utilized nationwide, and I know that the Department of Corrections has to coordinate this with the Judiciary of Guam because programs such as the ankle bracelet is one component. would be given leniency and perhaps be detained at their respective homes. So, I mean there are other programs that the Judiciary of Guam is working actively on trying to implement, so that we can reduce the number of detainees over at the Department of Corrections, so I hope that you look at that program and you work collaboratively so that we can at least try to bring down your population.

#### Mr. Alberto A. Lamorena, V.:

Just to let you know senator, the courts are working with our staff, and they're doing what they call the ORAS, the Ohio Risk Assessment Survey, and primarily we have... Our detainee population is as great as our inmate population. The courts are trying to do as much as they can to conduct the ORAS and all the detainees and then go back to the judges that detained them and to review and possibly release some of these detainees, so we're working very closely with the courts, and hopefully that can happen very soon.

#### Chairman Aguon:

Thank you. I appreciate it, and you know, you take a look at your work employment background and what not – I think your son highlighted it very very well – having served as civil service commission, having served as CAHA, Guam Visitors Bureau, and then some of the other Bureau of Statistics and Plans. So the administration expertise that you bring to the Department of Corrections is without question, without any doubt. You bring that expertise. You bring that knowledge in terms of how to work within this system so that you can get things accomplished. Regardless of where you're at, you bring that skill to the table in terms of this new responsibility. The added component is obviously you always have an appreciation of where you've come from, and you sat on this side of the table, and you understand exactly what the process is and how to go about being able to acquire resources or authorizations or get some additional tools from the legislative body. So, you also bring that, and I certainly wish you the best of luck. There's one thing that I want to close with, and you have highlighted it in your opening statement, and that's the professional staff and personnel you have in your department. To this very day they continue, at least from under my oversight, they have really done an outstanding job in terms of making sure that they tried to work within the system and keep our people safe outside the confines of the Department of Correction. So, to those men and women in uniform and also some of the civilian employees who work there, I thank them really for the work that they do, and I appreciate you recognizing them also. So, please let's continue to work together. In this particular situation, let's do the best we possibly can in ensuring that these inmates and these detainees are properly confined, and we also look at ways in which we can help support them.

#### Mr. Alberto A. Lamorena, V.:

Senator, you know me, I'm not shy. When we come up for our initiatives and we need legislation, then you know I will come forward and ask for your assistance.

#### Chairman Aguon:

Thank you senator. Senator Morrison?

#### Senator Tommy Morrison:

Thank you Mr. Chair. I want to thank all those who provided testimony here, former director and the staff of DOC and the rest of the DOC team that are here to support you Mr. Lamorena. First off, I have a lot of high regard for you. Of course, I had tough shoes to fill after you at the Bureau of Stats and Plans, and I know that firsthand reading the reports there, and some of the reports that you took on even as chairing one of the biggest, largest task forces – building a military task force that guided and developed documents that will help guide policymakers or decision makers going forward. I appreciate that and all the work you've done there as well having first hand, and of course the staff sometimes missed you more than me. It tells me a lot. I thank you for the invitation to visit the area. The former director did invite us in the past. We've been up there I think twice, and I have firsthand experience of the challenges there and of course a lot of the progress that's been made by the team there. I would love to come up there and see where things are at in how we can work with the Chairman and how we support DOC going forward. I know in the last go around we did discuss, again bringing to light the discussion of how looking at the landmass, the area there and how much ground officers have to cover, and I'm sure these folks definitely know their jobs well, but looking at opportunities on, the road in planning for growth or development of bringing more efficient structures to the area that would be able to handle and accommodate these changing times, and of course what's out there in the industry that are best practice or models that showcase clearly how this industry can be managed well. I know we had some discussion about that, and I hope we can revive that discussion because I think it's very... I think there was a lot of momentum with those discussion, and a lot of input provided by the DOC team and staff that were providing what could work there and what could not work there, and again I want to learn how things could work with models that were out there within Guam, and of course, I'm looking down the road developing a masterplan. I seem to bring up a lot, but I think we need to do things according to planning. Of course, as former director of Bureau Stats and Plans, you know that full well. So, I'm humbled to say that I support you fully.

#### Mr. Alberto A. Lamorena, V.:

Just to let you know that, again, I'm not going to take all the credit because I just got there, but prior management and existing staff were able to get a DUI grant for \$250,000 for the purposes of doing an assessment and doing a master plan for DOC. So, we're working on putting together the specs for the RFP and hopefully put that out so we can have a plan that we can actually put in place so we can have a goal into the future for DOC.

#### Chairman Aguon:

Thank you very much Senator Morrison and Mr. Lamorena. I just want to close with this. First and foremost, thank you for taking on the charge that the governor has extended to you in terms of serving in this capacity because it's always been one of the agency's that continues to experience challenges, and we certainly hope that over the course of the next couple of years that we'll be able to work together to get you the resources and additional personnel. I want to also thank Mr. Lamorena for allowing you to serve in this capacity because, very similar to your previous jobs, this one may be even more time consuming. It requires some additional commitment because it's regarding the safety of our people. The other jobs have their respective responsibilities in terms of supporting the community, but this one is going to continue to be a challenge


