#### **COMMITTEE REPORT DIGEST**

#### I. OVERVIEW

The nomination of Antoinette T. Johnson to serve as the Real Estate Broker Member to the Real Estate Commission, for a term of four (4) years, was made by Governor Edward J.B. Calvo on October 26, 2016. The nomination package was received by the Office of Speaker Judith T. Won Pat, Ed.D., on October 27, 2016, and was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on October 27, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a legislative hearing on November 7, 2016, in *I Liheslatura*'s Public Hearing Room. Among the items on the agenda was the nomination of Ms. Johnson. The hearing convened at 9:11 a.m. and was adjourned at 10:33 a.m.

#### **II. TESTIMONY & DISCUSSION**

Chairman Michael San Nicolas convened the hearing on the nomination of Ms. Antoinette Johnson and yielded the floor for her opening statement.

Ms. Johnson spoke about her experience in the real estate industry. She asked for favorable consideration of her nomination.

**Chairman San Nicolas** commended the nominee for her experience in the area of real estate. He mentioned that the current Commission is actively working to update some of the licensing requirements and that the nominee will be walking into a working group.
