



#### I. OVERVIEW

The Committee on Higher Education, Culture, Public Library and Women's Affairs convened a public hearing on July 22, 2015 at 2:00 p.m. in *I Liheslatura's* Public Hearing Room.

On the agenda was the consideration of the appointment of Mrs. April L. Flores as a Member of the KGTF/PBS Board of Trustees, for a Term of Four (4) years commencing July 1, 2015 to June 30, 2019; and whose appointment history is as follows:

- Appointed by Governor Edward J.B. Calvo on June 30, 2015.
- Appointment packet forwarded to I Liheslatura on June 30, 2015
- Appointment packet forwarded to this committee for public consideration on July 8, 2015

#### Public Notice Requirements

Notices were disseminated via electronic-mail to all senators and all main media broadcasting outlets on July 13, 2015 (5-day notice), and again on July 19,2015 (48 hour notice).

II. SUMMARY OF TESTIMONY & DISCUSSION

Speaker Won Pat called the public hearing to order at 2:02 p.m.

Speaker Won Pat asked Mr. Taggerty and Mrs. Aguon to testify.

Mr. Taggerty testified in support of Mrs. Flores. He stated that the nominee's computer and corporate background will be beneficial to the board. He pointed the urgency of her appointment, since the board is currently is unable to meet because of quorum. He stated that he looks forward working with her on the issues facing PBS.

Mrs. Aguon testified in support of Mrs. Flores. She stated that the board is unable to meet because of a lack of a quorum and the addition of Mrs. Flores will allow the board to act more timely on matters. She stated that she does not know the nominee personally, but she believes her background working for GTA will be helpful to PBS.

Senator Ada asked how many board members are needed to make a quorum.

Mr. Taggerty replied that the board consists of 7 members, the board needs 4 to make a quorum, but currently there are only 3 members. He stated that last year Mrs. Flores' nomination was placed before the legislature, but it was not placed on the December legislative agenda.

Senator Ada asked if additional names have been submitted to the governor to be on the board.

Mr. Taggerty responded yes there are two more individuals. He mentioned that one of the individuals is off-island and could not be placed on the agenda for today's hearing and the second individual has not completed their nomination packet.

Senator Ada stated that leaves one more vacant to be filled.

Mrs. Aguon replied yes and that she has been assured by the Governor's chief of staff that the remaining vacancy will be filled.

Speaker Won Pat clarified that Mrs. Flores' nomination last year was handled by the previous chairperson and it may have been an oversight as the legislature closed the end of the term. The Speaker expressed that she is pleased that Mrs. Flores once again accepted the nomination.

Speaker Won Pat asked Mrs. Flores to testify.

Mrs. Flores testified before the committee. Her written testimony is appended to the committee report.

Speaker Won Pat stated that previous experiences on being a board are important, but the willingness to be a member and learn how to be a productive board member is just as important. The Speaker stated the nominees' private sector experiences will help PBS grow. The Speaker thanked the nominee for accepting the appointment to be on the board.

Senator Ada thanked the nominee for accepting the nomination for the second time. Senator Ada stated that she has his full support and he encourages the Speaker to move forward with her nomination.

Speaker Won Pat asked Mr. Taggerty that if the meetings would conflict with the nominee's work schedule.

Mr. Taggerty replied that it would be appropriate for Mrs. Aguon since she is the chairperson of the board.

Mrs. Aguon stated that she accommodates the time of the meetings around work and school schedules of the members.

Speaker Won Pat asked how frequent does the board meet.

Mrs. Aguon stated that meetings are once a month.

Speaker Won Pat asked if PBS been has been impacted because the board lacked a quorum.

Mr. Taggerty replied that bringing the physical plant, equipments and especially technology (internet connection) up to date needs approval of the board.

Speaker Won Pat acknowledged Mr. Taggerty's statement that PBS has to keep up with the technology to provide quality service.

Speaker Won Pat adjourned the public hearing.




