COMMITTEE REPORT DIGEST

I. OVERVIEW

The nomination of Christopher S. Murphy to serve as a Real Estate Broker member to the Real Estate Commission, for a term of four (4) years, was made by Governor Edward J.B. Calvo on March 15, 2016. The nomination package was received by the Office of Speaker Judith T. Won Pat, Ed.D., on March 16, 2016, and was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on March 16, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a legislative hearing on April 14, 2016, in *I Liheslatura*'s Public Hearing Room. Among the items on the agenda was the nomination of Mr. Murphy. The hearing convened at 5:30 p.m. and was adjourned at 6:33 p.m.

Public Hearing notices were disseminated via electronic mail to all senators and all main media broadcasting outlets on April 7, 2016, and again on April 12, 2016. Notice was also posted on *I Liheslatura*'s website beginning on April 7, 2016.

II. TESTIMONY & DISCUSSION

(Chairman Michael San Nicolas heard the nominations of Christopher Murphy and Odessa Martinez concurrently)

Chairman Michael San Nicolas convened the hearing on the nominations of Mr. Christopher Murphy and Ms. Odessa Martinez. He yielded the floor for the nominees to make opening statements.

Chritopher Murphy spoke about the work that the Real Estate Commission has been doing since his initial appointment. He mentioned that they have been reviewing and working to update and improve local laws which benefit the public. He stated that the Commission has been actively approaching community stakeholders and hope to have proposed legislation ready to present to the Legislature. Mr. Murphy also stated that the Commission is looking at ways to update the real estate examination process to ensure efficiency.

Odessa Martinez mentioned that the Commission is continuing to work at improving access to materials and information that better prepares individuals wishing to take the real estate examination. She stated that they are also looking at tenant/landlord laws in Guam.

Chairman San Nicolas stated that he is happy to see both nominees taking a proactive role in ensuring that the Commission fulfills its mandates with many of the proposals they have brought up. He thanked them for working with the various community stakeholders and getting their input on how to improve local statutes.

Senator Frank Aguon inquired about a timeline for the proposed rules and regulations.

Ms. Martinez stated that they are waiting for the additional members to be appointed to the Commission.

Mr. Murphy explained that the Commission has laid good groundwork for the eventual adoption of rules and regulations. He said that they have been meeting regularly with the Guam Association of Realtors to review the local laws and have been reaching out to other community stakeholders.

Senator Aguon stated the importance of getting rules and regulations in place because of the impending buildup.

Mr. Murphy explained that the biggest hurdle the Commission faces is attaining quorum to make decisions on several issues pending before them.

Ms. Martinez stated that, as word about the Commission is getting around in public, she has experienced more individuals approaching them for assistance with their concerns and issues.

Chairman San Nicolas explained that the greatest difficulty will be stakeholder consensus but that having a fully functioning Commission should help to move the working process along. Absent additional individuals present to testify, he concluded the hearing on the nominations.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Finance & Taxation, General Government Operations, and Youth Development hereby reports out the nomination of Christopher S. Murphy to serve as a Real Estate Broker Member to the Real Estate Commission, for a term of four (4) years, with the recommendation
