### COMMITTEE REPORT DIGEST

#### I. OVERVIEW

The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement convened a public hearing on March 13, 2015 at 1:30 p.m. in *I Liheslaturan Guahan* Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Ms. Deedee S. Camacho to serve as a member of the A.B. Won Pat International Airport Authority Board of Directors whose appointment history is as follows:

- Appointment by Eddie Baza Calvo, *Governor*, On February 09, 2015;
- Appointment packet forwarded to *I Liheslaturan Guahan* on February 10, 2015;
- Appointment packet forwarded to this committee for public consideration on February 12, 2015.

#### Public Notice Requirements

Public Hearing notices were disseminated via email to all senators and all main media broadcasting outlets on Thursday, March 5, 2015 (5-Day Notice) and again on Wednesday, March 11, 2015 (48-Hour Notice).

#### II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Ada called the hearing to order at 1:30 p.m.

**Chairperson Ada:** states the purpose of this hearing is to receive testimony for the executive appointment of Ms. Deedee S. Camacho, to serve as a member of the A.B. Won Pat International Airport Authority Board of Directors.

Chairperson Ada starts by calling up those who have signed up to give testimony.

**Charles H. Ada II, Executive Manager, A.B. Won Pat International Airport:** Mr. Ada read his testimony and gave favorable testimony on the appointment of Ms. Camacho and recommended that she be confirmed. (see attached testimony)

**Rubyjane Buhain-Redila, Member, Pink Ball Committee:** Ms. Redila read her testimony and gave favorable testimony on the appointment of Ms. Camacho and recommended that she be confirmed. (see attached testimony)

**Edward Untalan, Chairman, A.B. Won Pat International Airport Authority Board of Directors:** Mr. Untalan read excerpts of his testimony and gave favorable testimony on the appointment of Ms Camacho and recommended that she be confirmed. He explains that Ms. Camacho will be the seventh member that will complete the membership of the board. Her knowledge in the insurance field as well as her outside perspective will be a great attribute to the board. She will know if the airport is paying too much of something and this situation is where her expertise will certainly be needed. Ms. Camacho has a real private sector perspective type of mentality. (see attached written testimony)

**Miki R. Moylan, Director P&C, Moylan's Insurance Underwriters Inc.:** Mr. Moylan read his testimony and gave favorable testimony on the appointment of Ms Camacho and recommended that she be confirmed. (see attached testimony)

Chairperson Ada opens the floor up for questions to the panel.

**Senator Underwood:** Asked the panel what are the critical skills and attributes for a board member to have?

**Mr. Untalan:** Answers by saying having the willingness to serve the public and having an eye for service. You want to be able to look at how and what is being provided by the airport. With Ms. Camacho being in the insurance industry, this makes her used to serving people. He explains the third attribute is Ms. Camacho's freshness in serving in her first board and bringing a new perspective. Her final attribute is her experience in the insurance field, which would help the airport look at things from a private sector perspective. Which can in then help serve the Board well.

**Senator Underwood:** She continues to ask if there is any prerequisite knowledge about the airport, about tourism or anything else that would be important for her to have?

**Mr. Untalan:** He says the most important is the willingness to serve and be in front of the public as well. When he first joined the airport board, he came from the Guam Community College and didn't know anything. He goes on to say that he spent two years learning about education and its importance, he walked into the airport board only looking at the finances and not realizing the magnitude. However, the desire to want to learn is going to help her in wanting to understand, she understands that if tourism doesn't grow and the economy falls then her business will fall as well. She knows people will not be able to make their payments, etc, with that she is going to want to ensure that tourism grows and prospers. With the airport being the first and last point, she is going to want to make sure that people are taking care of.

**Mr. Chuck Ada:** He says that he would like to add, upon successful completion of this process, Ms. Camacho would have a [steep] learning curve. Chairman Untalan has made it easier for the board members to integrate with the airport activities, by developing subcommittees. With that in place, it fast tracks the learning process and provides instantaneously clarification of policies that are set within the board and allows board working

groups to adjust to the challenges they are currently facing. He finishes by saying that they look forward to the confirmation of Ms. Camacho and having a full board.

Chairperson Ada then calls upon Ms. Deedee Camacho to testify.

**Deedee Camacho, *Appointee*** Ms. Camacho reads her written testimony (See Written Testimony)

Chairperson Ada opens for questions from the panel.

**Chairperson Ada:** He states that Ms. Camacho has been in the insurance industry for a long time, and ask that with the airport, as is typical of many autonomous agencies insured, when it gets to the point when the airport moves to procure insurance how would you avoid any conflict of interest with the industry?

**Ms. Camacho:** She says with the company that she works for there is no conflict of interest because they don't do business with the airport. There may be a time when other colleagues may solicit and what is important is what is good for the airport as far as the coverage, value and everything that goes into that. She goes on to say that she has to look out for what is for the best interest of the airport.

**Chairperson Ada:** He refers to Mr. Untalan's testimony about how Ms. Camacho's insurance background will be valuable to the airport. He states that it will be a constant challenge for Ms. Camacho to balance the conflict of interest when the airport is procuring insurance.

**Senator V. Anthony Ada:** He starts by thanking Ms. Camacho for her willingness to serve on the board. There are learning curves on any board/commission or with anything that you do in life. He goes on to say that she will be able to get over the obstacles and be a good member to the airport board and see where savings can be made. He ends by saying that Ms. Camacho has his full support.

**Senator Underwood:** She thanks Ms. Camacho for accepting the nomination and does expect that there will be a steep learning curve. She asks Ms. Camacho to say what her perspective of the board and the role of the board in regards to the airport.

**Ms. Camacho:** She says that from her understanding the board is a policy board, weather it be through guidance, financials and ensure that everything the board does is based on knowing all the information. The interest of the airport and the public who use the airport will always be the main priority.

Chairperson Ada ends the confirmation hearing for Ms. Deedee Camacho.
