COMMITTEE REPORT DIGEST

I. OVERVIEW

The nomination of Elmore A. Cotton to serve as a Member of the Guam Board of Equalization, for a term of four (4) years, was made by Governor Edward J.B. Calvo on January 27, 2016. The nomination package was received by the Office of Speaker Judith T. Won Pat, Ed.D., on January 28, 2016, and was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on January 29, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a public hearing on February 10, 2016, in *I Liheslatura's* Public Hearing Room. Among the items on the hearing agenda was the nomination of Mr. Cotton. The hearing convened at 10:00 a.m. and was adjourned at 11:23 a.m.

Public Hearing notices were disseminated via electronic mail to all senators and all main media broadcasting outlets on February 3, 2016, and again on February 8, 2016. Notice was also posted on *I Liheslatura's* website beginning on February 3, 2016.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas convened the hearing on the nomination of Mr. Elmore Cotton. He yielded the floor to the nominee for her testimony.

Mr. Elmore Cotton first asked if Board members assume any personal liability with the decisions they make in their official capacity on the Board. He stated that with the recent property appraisals conducted by the Department of Revenue and Taxation, the Board is in receipt of numerous complaints and he inquired about liability.

Chairman San Nicolas stated that the Board members receive indemnification when carrying out their duties as officers of the government of Guam. He advised Mr. Cotton that members of the Board take all legal inquiries they may have to the Attorney General of Guam. He asked the nominee if his professional capacity in the area of real estate has ever presented any conflicts of interest during his previous service on the Board.

Mr. Cotton stated that he has not had any previous conflicts and would recuse himself if any did arise in the future.

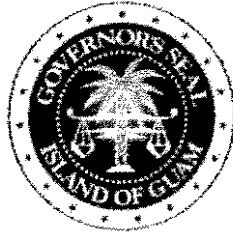
Chairman San Nicolas stated that Mr. Cotton's expertise in the real estate market is a tremendous asset to the Board especially with the recent property revaluation that was conducted.

Mr. Cotton clarified that he was not an appraiser but looks at pricing versus value.

Chairman San Nicolas thanked Mr. Cotton for his acceptance of the nomination and concluded the hearing.
