- Appointed by Governor Edward J.B. Calvo on February 17, 2015.
- Appointment packet forwarded to *I Liheslatura* on February 19, 2015;
- Appointment packet forwarded to this committee for public consideration on February 20, 2015.

#### II. SUMMARY OF TESTIMONY & DISCUSSION

The confirmation hearing was Called-to-Order at 5:32PM.

**Chairman Senator Dennis Rodriguez, Jr:** I'd like if there's no one here who wishes to make any oral testimony, I'd like to call the nominee, Mr. George Chiu. Thank you again for serving and congratulations on your reappointment. You served 4 years now on the Board of Trustees, I meant Board of Directors of the Guam Economic Development Authority. At least for me I want

to let you know, I appreciate the work you have been doing with the committee as well this past 4 years. And so now you're here for your re appointment and if you have any opening statement, you like to say to the committee now, your opportunity & I open it out to question or comments.

**Mr. George Chiu:** Okay, thank you very much Senator Rodriguez, Senator Espaldon, Senator Respicio, and Senator Underwood, thank you very much. I'm honored to be reappointed for a second term to serve on the Board of Director to Guam Economic Development Authority. The past 4 year has been very encouraging to see the development of the economy of Guam and I look forward to serving another 4 years on behalf of the Government of Guam and the people of Guam to try to further develop the economy of Guam, not just all island visitors but for the people of Guam especially. Thank you.

**Chairman Senator Dennis Rodriguez, Jr:** Thank you very much Mr. Chiu. Senator Respicio do you have any questions or comments? Senator Underwood.

**Senator Nerissa B. Underwood:** I don't have any questions but I do want to thank you Mr. Chiu for your service. I do know you're quite a busy man and just the fact that you're willing to put another 4 years to serve in a very important hoard is just appreciated so thank you very much.

**Mr. George Chiu:** Thank you Senator.

**Chairman Senator Dennis Rodriguez, Jr:** Senator Espaldon.

**Senator Jim Espaldon:** Mr. Chiu, again same sentiments and that you have been very instrumental in serving our public and just for the record since this is one of those things I think we have to be transparent, make sure nobody out there would have any questions concerning your qualifications. I do need to bring to light something that you did disclose and that is basically that you are the Director and an officer in certain companies that do have qualifying certificates for GEDA, is that correct?

**Mr. George Chiu:** Yes sir that's correct.

**Senator Jim Espaldon:** And there are 3 companies that you do cite and I won't name them but there are 3 companies. I guess the question would be. When it comes to qualifying certificates, how do you handle it as a member of the board?

**Mr. George Chiu:** As a member of the board for the past 4 years, anything regarding to qualifying certificates I have recused myself from participating in any discussions or casting any votes, either in favor or against any QC situations.

**Senator Jim Espaldon:** And I appreciate the answer again I just want to make sure that we're very transparent about because I believe that you're going to have some good support if not unanimous support for your nomination and I just want to make sure that there are no questions that we bypass this whole issue of the company you may be involved with which qualifying certificates have been issued. Going forward, if I can just ask you a question, there seems to be an effort to kind of take a look at the whole qualifying certificate program and to see if we need to tweak it one way or the other cause we know that there are certain industries that are ready matured, perhaps or other industry sectors that perhaps necessarily need them. Do you feel there is a need to take a look qualifying certificate program and to see if we need to re-tweak it and perhaps put those funds towards other emerging sectors that we may view, may have potential for our economy?

**Mr. George Chiu:** Senator, that's a very good question and I think the board of directors of Guam Economic Development Authority is already taking a serious look at it. I think the qualifying certificate has been a very hot issue and previous legislature and probably be so again during this current legislature. As a business person, we always want to see the Government encouraging business development and economic development. So do I think the qualifying certificate will help in that area? Definitely it does help in that area. How it's managed and how it's implemented is also very critical I think there has been past complaints about the benefits of the qualifying certificate. So I think there's a new view of looking at it to make sure that any investment that's made to benefit the qualifying certificate will not exceed the investment that was made. Whatever additional gain has made a tax saving to the qualifying certificates will basically be equalized and I think that's the direction that the board has been working on.

**Senator Jim Espaldon:** Thank you. Mr. Chairman, thank you for the opportunity. Thank you sir.

**Chairman Senator Dennis Rodriguez, Jr:** Thank you very much Senator Espaldon. Mr. Chiu, again congratulations on your re-appointment. You have my full support as you have for the past 4 years and we'll make sure that we pretty quickly to get your nomination confirmed. Okay, so thank you very much again.

**Mr. George Chiu:** Thank you.



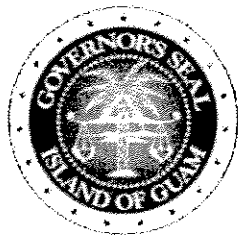
