#### COMMITTEE REPORT DIGEST

#### I. OVERVIEW

The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement convened a public hearing on March 29, 2016 at 2:00 p.m. in *I Liheslaturan Guahan* Public Hearing Room. Among the items on the agenda was the consideration of the appointment **Ms. Gyongyi "Pika" P. Fejeran** to serve as a member of the Chamorro Land Trust Commission, whose appointment history is as follows:

- Appointment by Eddie Baza Calvo, Governor, on March 15, 2016
- Appointment packet forwarded to I Liheslaturan Guahan on March 16, 2016
- Appointment packet forwarded to this committee for public consideration on March 16, 2016.

#### **Public Notice Requirements**

Public Hearing notices were disseminated via email to all senators and all main media broadcasting outlets on March 21, 2016 (5-Day Notice) and again on March 24, 2016 (48-Hour Notice). Publication was conducted in the March 24, 2016 issue of the *Guam Daily Post, a newspaper of general circulation*, fulfilling the 5-Day Notice of the Open Government Law requirements respectively.

The confirmation hearing for Ms. Gyongyi "Pika" P. Fejeran commenced at 2:00 p.m.

#### II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Ada calls those who have signed up to give oral testimony.

**Jackie Arriola Marati**, Board Member, *Guam Women's Chamber of Commerce* (written testimony): She reads her testimony in verbatim (see attached testimony). She is in support of Ms. Fejeran's confirmation because she brings a wealth of education, experience, and an understanding of the Chamorro culture.

**Michael Borja**, *Director*, Department of Land Management (written testimony): He reads his testimony in verbatim (see attached testimony). He is in support of Ms. Fejeran's confirmation

because she has been an active member in the Guam business community and will bring a new perspective and ideas to the commission.

Rita Franquez (oral testimony): Ms. Pika Fejeran's education and experience are quite extraordinary, extensive, and very impressive. With all of those qualifications, I think she would be a superb choice, unanimous choice for her confirmation. This commission is very important to many people and there are so many people wanting land. Land is not a renewable resource so I think with her qualifications, she will do very well to protect the land and see that it goes to those who are worthy and qualified for it. Not to turn it into a business that could be outsourced from there. She has to be very strict and it's going to be very unnerving for her because so many people have applied since the 1960s. Maybe this agency should put a moratorium here. Finish out what's on the table, but put a moratorium on the rest of it until they have funding to do a proper job to screen, survey, and serve the people. The people first are who need it, not the corporations.

Chad Ascura (oral testimony): Pika and her husband has been a friend of mine for a very long time. I've seen them grow as a couple, get married, and create a family here on this island. I've seen them provide jobs for this island. You go to Pika's Café, you see the staff, everybody's happy. It reflects from the management all the way down to the cook and the dishwasher. They love their staff and treat them with the utmost respect and provide as many benefits for them to grow. She's an awesome person and would be a new vibe to this commission. Some may look at her as inexperienced, not ready, but she brings a new vibe to this island. She should be given a chance to show what our generation can bring to the table.

**Ann Marie Arceo** (oral testimony): She speaks in Chamorro. She is in favor of Ms. Fejeran's confirmation.

Lou Leon Guerrero, Past President, *Guam Women's Chamber of Commerce* (written testimony): She reads her testimony in verbatim. She is in favor of Ms. Fejeran's confirmation because Pika is resourceful, detailed, plans her path, logical, and not ashamed to seek help and consultation. Our land in our island is the basic root of our culture, family, livelihood, and sustainability... it is crucial that those individuals given the authority to administer our lands must be capable and competent to do so. Pika is indeed that individual.

**Senator Mary Torres:** She converses with Ms. Arceo in Chamorro. When I met with Pika, I asked her what her interest was in the Chamorro Land Trust. She explained to me that she was Chamorro and she was studying at the Hurao Academy then I understood that she is very sincere in wanting to do what is right. I'm even more confident in Pika's ambition and her desire to the right job for the commission.

**Mel Mendiola**, *Project Director*, Farm to Table (oral testimony): I've been acquainted to Pika for about four years now. We are an organization that works with small businesses and farmers in areas of agriculture and agricultural business. In her capacity as a business owner, Pika and her family live what it means to support local. Pika and Lenny take on a role as big brother and big sister for all of their employees. She's also a buyer of local produce and supports farmers as often as they can. Pika and Lenny have always been there for us on behalf of the people we help

and our beneficiaries. She's creative, approachable, smart, and is making an effort to learn Chamorro and a lot of farmers would really appreciate that. I would appreciate her perspective in the CLTC as well and so I ask the Committee to unanimously confirm her.

Cara Flores (oral testimony): As a people, we've always been connected to our land, and more recently we've been disconnected from it. We're at an important point in time in which we must decide as a community what is more important than our land. While the confirmation of a new commissioner will not fix the legislation or the politics that challenge this commission from functioning in the manner for which it was intended, the role of a commissioner is an important one and I believe that Pika Fejeran will collaborate fairly and with the best interest of those who the Trust seeks to benefit as her foremost priority. I've watched over the years as Pika and Lenny have grown their business with a strong commitment to the community and to our culture and I've grown to respect her leadership, humility, and integrity. This kind of leadership is needed more than ever so I would ask that you unanimously accept her appointment.

**Gyongyi "Pika" P. Fejeran,** Nominee (written testimony): She reads her testimony in verbatim (see attached testimony).

Senator Rory Respicio: Your testimony is consistent with what you told me yesterday. You put your passion aside to pursue your husband's passion and his dream and now you're facing an opportunity where your education can be put to good use. We talked about the idea of the requirement of a Master Plan for the Chamorro Land Trust Commission and I'm sure that Mr. Borja, his staff, and the commissioners are moving forward to develop that kind of a master plan. At your first official meeting with the Chamorro Land Trust Commission, I'm sure you'll make the suggestion to create a task force or subcommittee on master plan and compliance. We also talked about the struggle of wanting to make sure we honor the tenants of the Chamorro Land Trust Commission. I agree with Senator Leon Guerrero that Governor Calvo made an excellent choice and I'm certainly in support of your confirmation.

**Senator Nerissa Underwood:** It was really a pleasure to have a lengthy conversation with you and she authentically has impressed me with her knowledge and research she has done relative to the critical issues that are confronting the Chamorro Land Trust. She is very clear on the mission of the commission and she knows how complex, she knows how important it is, not only to her, but to the Chamorro people. We would also expect that you will take on those very tough issues and there are still some very big items on the agenda so I look forward to working with you and seeing through to the mission of the commission.

**Sen. Torres:** I just want to congratulate you on stepping up to the plate. Please work with the Legislature because we do want to facilitate your efforts as you tackle on with your fellow commission members some of the tasks, issues, and problems that have been looming. We're always here to help and I want to thank you for demonstrating to me that sincere passion that we were all looking for.

**Chairperson Ada:** I really appreciate the fact that you've taken the initiative to call the office and ask to meet. I think you have an understanding of what you're getting yourself into and you bring a lot to the table. I want to see you serve on the commission. With that, the Committee will

make sure that we get this committee report done tonight in time for tomorrow's session. The confirmation for Ms. Pika Fejeran is completed. Thank you.

Chairperson Ada adjourns the confirmation hearing for Ms. Gyongyi "Pika" P. Fejeran.

Hafa adai, Honorable Chairman Tom Ada and Members:

I am pleased to submit this testimony on behalf of the Guam Women's Chamber of Commerce in support of the nomination of Gyongi (Pika) Fejeran to serve on the Chamorro Land Trust Commission.

Born and reared on Guam, Pika is a 2002 graduate of St. John's School earning an International Baccalaureate before attending and graduating from the University of Southern California with a Masters in Urban and Regional Planning.

Pika worked for 4 years in southern California for Parsons Corporation as a Planner and Deputy Project Manager, performing environmental planning, involving impact assessment and regulatory compliance. She has a strong multidisciplinary grounding in numerous environmental issues including water and air quality, noise, hazardous waste and materials, aesthetics/visual resources, agriculture, recreational resources, cultural resources, land use and planning, biological resources, socio-economics, environmental justice and community impact.

On her return home to Guam in 2010 until 2013, Pika was Superintendent, Environmental for DZSP21, LLC and managed environmental compliance and hazardous waste operations offices at Andersen Air Force base, managing the budgets for the Andersen and Navy DZSP21 environmental offices.

Pika has a unique understanding of the interplay between land use and the environment and how laws and regulations lead this interplay. As well, through her experience as a small business owner (Pika's Café and Kitchen Lingo), she has developed that rare perspective as a business owner, combining the interest in Guam's economy and the health of our environment, intertwined with the perpetuation of our Chamoru culture and compliance with federal regulations.

Pika is articulate and poised, mature and experienced. She has an earnest willingness to serve. She brings a wealth of technical and tested knowledge, combined with sensitivity to our cultural and economic challenges. On behalf of the Guam Women's Chamber of Commerce, we submit our wholehearted support for the nomination of Pika Fejeran.

Hafa adai todo hamyo! I na'an hu si Gyongyi Pilar Fejeran, lao tododododo I lina'la-hu I na'an-hu si Pika. Pues aggang-yu "Pika" put fabot. Si yu'os ma'ase Senators, Vice Speaker, Senot Borja, I familia-ku, yan I manggachong-hu para tiempon-miyu. Malago' yu bai hu patte i estoria-hu, hayi-yu, yan 'sa hafa na malago-yu bai hu saonao gi I Kumision Inangokkon Tano Chamoru.

Hafa adai! My name is Gyongyi Pilar Fejeran, but all my life, I've only been known as Pika. Please call me Pika. Thank you Senators, Vice Speaker, Mr. Borja, my family and friends for your time. I would like to share with my story with you...who I am and why I want to be a commissioner on the Chamorro Land Trust Commission.

I am the daughter of Frank Borja Rosario, taotao Sinahana, familian nga'nga'. My mother is Gyongyi (my namesake), a Hungarian from New York City, who has chosen to make Guam her home for the last 40 years. I was born and raised here on Guam, and my parents provided a very charmed and fortunate life, surrounded by countless aunts, uncles and cousins...at last count, my first cousins on my father's side numbered 86. I graduated from St. John's School and left for college in Los Angeles. College education was ingrained in me by my parents from a young age, so there was no question I was going. However, when I left, my goal was to one day return home with education and experience that I could use to contribute as an adult to este i sen bonita na isla-ta.

I attended the University of Southern California, where I received my B.S. in Policy, Management and Planning, and my Master's Degree in Urban and Regional Planning. When I declared my majors, urban planning was so new to me, but I could see the potential it had to improve our island's environment and our people's quality of life. Planning became my passion. I worked for several years, in transportation and environmental planning for various communities throughout California.

While in California, I reconnected with Lenny Fejeran. He was an Agat boy I had known since I was 16, and I always knew I would one day spend my life with him. Unfortunately, he is not here today, but he should be logged in via live stream on the internet. He is in the states for business- doing "Research and Development"...but don't feel bad for him, as a restaurant owner, that just means he's eating and drinking to get some inspiration! Lenny joined me in Los Angeles, and was following his passion in the restaurant industry. We both had aspirations of returning home one day to give back to the island we felt was such a beautiful unique place to grow up in.

In 2009, Lenny and I came home to get married surrounded by our friends and families. We were here for three weeks, and not once did we miss Los Angeles. That is when we decided, the time to move home was upon us. For the next year, Lenny and I worked to make our transition home everything we wanted it to be. He wanted to open up a restaurant, so we worked on his business plan. Someone had to support the family while he was chasing his

dreams, so I secured a job with DZSP21 as the Environmental Superintendent at Andersen Air Force Base.

We moved home in 2010, and hit the ground running. Lenny opened Pika's Café four months after we moved home. So, I'm sure many know my name because of Pika's Café. As I joked with Senator Espaldon, my sandwiches precede me! We have been so fortunate to have been so well received by our island. Within 2 years we expanded Pika's Café, and are still doing well. We believe our success is because we are fully integrated into our island community. We know that when others succeed and do well, we do too. We support many small local businesses and artisans, we support local music and local art, and especially, our local farmers. We promote everything local, because we believe that Guam and her people our family.

While Lenny was running Pika's Café, and I was helping him with the bookkeeping at night, I was also doing very well transitioning into my new job with DZSP21...within 1 year I had absorbed a second office under my leadership. At Andersen, my teams and I ensured environmental compliance for the base. We protected the northern aquifer, the air, cultural resources, and the health of those that lived and worked on the base. I managed our \$1 million budget and in a very short time, turned the often-times adversarial relationship between our contract and our military clients, into a collaborative, trusting relationship. I loved the work I did, and the people I worked with. However, by the time we got projects, someone in the Pentagon had already decided them. I knew what I was doing was important - to ensure the projects went ahead with as little harm to our environment as possible, however it was a constant internal struggle knowing that our beautiful land up north was being developed without our people's input, and that one was not able to enjoy some of the most beautiful clifflines and land of Guam, unless they had a base access card.

So, at the end of 2013, as Lenny was on his way out the door to go snorkeling, and I was headed into work at Andersen, he told me "Pika, quit your job and work with me." It was a very difficult decision, to leave behind my career, a fantastic job and people I loved. However, I took the leap. And I prayed that though I left my career for my husband's career, that I would have other opportunities to continue to pursue my passion for planning, and making Guam a better place.

My good friend Sheena Black was a phenomenal supporter and believer in me. She recommended me for participation in Imagine Guam, and I was called in to join the Community Values Team. I was on the team with Ann Marie Arceo, Pale Mike, Dan Ho, Mayor Tayama, Marie Benito, and many others in the community, whom I realized I shared so much with. The resulting Community Values document that we produced goes back to basics...our basic Chamoru values and behaviors. I could not be more proud of our work together that will lead the Strategic Vision for Guam for the next 50 years.

From my participation in Imagine Guam, I got to know Ann Marie. She helped me understand something that I always knew but never fully acknowledged...that I was not confident in my identity as a Chamoru woman, because, like many in my generation, I did not speak Chamoru. My father and his siblings are all fluent, but it was never taught nor expected of me or my sister. So, I decided to make the commitment, and 8 months ago, my family and I, including my haolie mother, began attending Hurao Academy. I still have so much more to learn, and my goal is to be fluent in 5 years. But, a year ago, I would not have been able to do write or say even half of what I said in the beginning of this speech. Saina, thank you. You are truly a gift.

I believe that because of my participation in Imagine Guam, Governor Calvo has afforded me this amazing, and humbling opportunity to be appointed to the Chamoru Land Trust Commission.

When I left my corporate job for self-employment, I didn't know where or how I could best use my passion for land use planning and environmental protection, for the betterment of our people. However, I see it now. The Chamoru Land Trust Commission, and the 1975 Chamorro Land Trust Act that it is based on, is where my service belongs. The mission of the CLTC says it all: "The Chamorro Land Trust Act was intended to advance the well-being of the Chamorro people by way of equitable land distribution and CLTC was created to carry out this mission."

Even in this modern day and age, our land remains the base of our Chamorro culture. We call ourselves "I taotao-tano"- people of the land. And, for the last 400 years, we have not been in full control of our land. In fact, today, the land comprising the Chamorro Land Trust, is land that was taken from the Chamorro people by the Spanish, then the Japanese, then the Americans. The Chamorro Land Trust Act seeks to give back what was wrongfully taken, and give it back in an equitable way to raise our people up.

It has been 40 years since the passing of the Chamorro Land Trust Act, and 20 years since the passing of the Rules and Regulations for residential and agricultural leases, and 20 years after that, just last year, the Rules and Regulations for commercial leases was passed.

In all of that time, we are not sitting here today applauding the advancement of our Chamorro people because of the Land Trust Act's implementation for the last 20 years. We are sitting here today, because not enough has happened for our people. We are broken, we are protesting, we are afraid that our family's land will never be our children's land.

I believe that the Commission and the Land Trust holds so much promise for our people. And when our people do well, everyone that calls Guam home, does well.

I am committed to the mission of the Chamorro Land Trust Act, and, if confirmed today, I will work collaboratively with my fellow commission members, I will be open and transparent,

and I will always come back to the mission of the Chamorro Land Trust Act- to advance the well-being of the Chamorro people by way of equitable land distribution.

I would like to end with a quote from the late Governor Ricardo J. Bordallo, whose time in office saw the passage of the 1975 Chamorro Land Trust Act:

"Guam is not just a piece of real estate to be exploited for its money-making potential. Above all else, Guam is the homeland of the Chamorro people. That is a fundamental, undeniable truth. We are very profoundly 'taotao tano' – people of the land. This land, tiny as it is, belongs to us just as surely, just as inseparably, as we belong to it. No tragedy of history or declaration of conquest, no legalistic doubletalk can change that fact. Guam is our legacy.".



#### Legislature readies for monthly session, hearings

Appointments to CLTC, GIAA to be heard

The Committee on Rules will meet today, March 28, at 2 p.m. to set the agenda for the legislative session for the month of March.

According to the office of Speaker Judith Won Pat, session is expected to be scheduled to begin on Wednesday, March 30. Won Pat and other lawmakers are scheduled to tour the Ordot Dump today and by order of District Court Chief Judge Frances Tydingco-Gatewood, will be in the U.S. District

Court tomorrow for a hearing on the status in the Ordot Dump consent decree case.

While the agenda will not be known until after today's meeting, Sen. Rory Respicio, rules committee chairman, said that his office will continue the usual issuance of daily updates at 5 p.m. regardless of whether or not the legislature has recessed for the day.

Ahead of session, Sen. Tom Ada will host an oversight hearing on the Chamorro Land Trust Commission. On top of the agenda is the relocation of tenants from Lot 7128-REM, in Yigo.

Also on Ada's agenda are the executive appointments of Gyongyi "Pika" P. Fejeran to serve as a member of the Chamorro Land Trust Commission and the appointment of Ricardo C. Duenas to serve on the A.B. Won Pat International Airport Authority board of directors.

Fejeran, 32, from Tumon is the president of Pika's Cafe. This will be her first nomination to a government board, though she was appointed to Gov. Eddie Calvo's Imagine Guam Commission.

A 2002 graduate of St. John's Episcopal School, Fejeran earned a master's in urban and regional planning from the University of Southern California in 2007.

#### Round out

Fejeran will round out the CLTC membership which currently includes Joseph I. Cruz, vice chairman; Amanda L.G. Santos; and Pascual V.A. Sablan. The term of David Matanane, chairman, is up for consideration by lawmakers. Fejeran's appointment will expire April 2017.

Meanwhile, Duenas, 53, of Piti, succeeds Edward Untalan who resigned as the chairman of the board of the GIAA. Untalan resigned effective Feb. 12 for "personal reasons." Untalan's nomination was for a three-year term, which began in June 2014. Duenas will complete Untalan's term on the board which ends in June 2017.

Duenas is currently a trustee with Robert J. Torres Trust, and also worked as chief financial officer of Western Sales Trading Co., a wholesale company under the Torres Group.

Duenas also worked as an Ernst & Young senior tax manager. He served for eight years on the Guam Economic Development Authority board from 2005 to 2013. If confirmed, Duenas will join current airport board members Martin Gerber, Lucy Alcorn, Linda Tolan, Gurvinder Sobti, Kathy Sgro and Dee Dee Camacho.
