COMMITTEE REPORT DIGEST

I. OVERVIEW

The nomination of John R. Taitano to serve as a Member of the Alcohol Beverage Control Board, for a term of two (2) years, was made by Governor Edward J.B. Calvo on September 14, 2015. The nomination package was received by the Office of Speaker Judith T. Won Pat, Ed.D., on September 15, 2015, and was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on September 15, 2015.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a public hearing on September 29, 2015, in *I Liheslatura's* Public Hearing Room. Among the items on the hearing agenda was the nomination of John R. Taitano to serve as a Member of the Alcohol Beverage Control Board. The hearing convened at 10:02 a.m. and was adjourned at 11:30 a.m.

Public Hearing notices were disseminated via electronic mail to all senators and all main media broadcasting outlets on September 22, 2015, and again on September 25, 2015. Notice was also posted on *I Liheslatura's* website beginning on September 22, 2015.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas convened the hearing on the nomination of Mr. John Taitano. Chairman San Nicolas stated that his office has not received any complaints about the Alcohol Beverage Control (ABC) Board or its members and believes that the nominee's experience as a past member would be beneficial. Mr. Taitano was called forward to make an opening statement.

Mr. John Taitano stated that he has served two terms on the Board and that he continues to learn from members of the community. He stated that the current Board is working to implement the alcohol server training program that is required by law.

Chairman San Nicolas asked if the issue about ratio laws with regards to alcohol licenses was being addressed.

Mr. Taitano stated that the current Board is enforcing that law and continues to evaluate existing laws to determine if changes need to be made in other areas under the purview of the Board.

Chairman San Nicolas inquired about the enforcement efforts of the ABC Board and the existing division within the Department of Revenue and Taxation.

Mr. Taitano stated that the division has a new supervisor who has been aggressively stepping up efforts to ensure compliance with updated alcohol licenses and business licenses for establishments. He stated that compliance efforts have also been increasing during both day and evening business hours in establishments.

Chairman San Nicolas asked if there was a hotline that members of the public could call to report possible regulation violations.

Mr. Taitano stated that he was not aware of any type of hotline but stated that he would ask and, if there is not one already established, advocate that one be implemented.

Chairman San Nicolas stated that the implementation of a hotline will help the members of the community “self-police” themselves if infractions are occurring.

Senator Nerissa Underwood asked about the alcohol server training program and if it was a prerequisite to receiving a license.

Mr. Taitano stated that public law requires the Board to implement an alcohol training program that businesses and employees participate in which ensures that alcohol beverage control laws are properly followed. He further stated that businesses and employees will be required to attend the program before getting a license.

Senator Underwood asked what steps the Board was taking to address underage drinking.

Mr. Taitano stated that the Board was working closely with the Department of Youth Affairs and the non-communicable disease group from the Department of Public Health and Social Services in putting out public service announcements in the community about being alcohol free. He stated that the Board intends to discuss outreach plans.

Senator Underwood asked if the Board collects data about the effectiveness and success of past Board policies.

Mr. Taitano stated that he was not sure and would inquire with the Board.

Vice Speaker Benjamin Cruz asked if any establishments have been temporarily closed for non-compliance of existing law within the last six months.

Mr. Taitano stated the he did not know of any businesses which were shut down but believed that several were cited for various infractions.

Vice Speaker Cruz mentioned the he and his office receives calls about establishments violating the law and requested that the Board try to look into these claims. He also asked about the training

programs and whether the proper timelines are being met. Vice Speaker further asked why the training program has not yet been approved.

Mr. Taitano answered that there is a misperception that only one organization will be responsible for conducting the training program. He stated that the Board is trying to find the best way possible to have the training program available to the license applicants in the quickest amount of time. He mentioned that a previous attempt failed and that he was not inclined to let that take place again.

Vice Speaker Cruz urged the Board to decide on a training program so that part of the licensing process can begin. He stated that the Board should choose the service provider that is ready to start the training.

Mr. Taitano stated that the Board has decided on what they believe to be the ideal training program model and are now going through due process to ensure that all groups interested in providing the training are aware of what the Board is looking for when deciding on a provider. Mr. Taitano stated that he believes that a decision will be finalized by the end of October.

Senator James Espaldon asked the nominee why he accepted the nomination to serve on the Board.

Mr. Taitano stated that he has a young daughter and he wants to ensure that she grows up in a safe community and that people are not hurt or do not hurt others as a result of alcohol misuse.

Senator Espaldon asks how often the Board meets and if Board members ever conduct inspections.

Mr. Taitano answered that the Board meets twice a month. He further explained that Board members would sometimes conduct inspections themselves but it was later agreed that they should not do inspections because those members would be prohibited from voting in adjudication hearings because of a conflict which would affect the Board's ability to attain quorum.

Senator Espaldon mentioned that the ABC compliance division is understaffed and lacks the manpower necessary to fulfill its mandate. He asked the nominee how the Board intends to address this problem.

Mr. Taitano stated that the Division head has implemented a work schedule that allows employees to make arrangements to work evening so they may conduct inspections. He stated that the addition of a hotline would be beneficial.

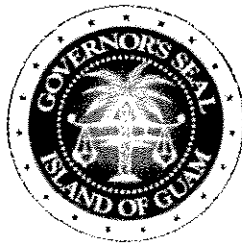
Senator Espaldon suggested that the Board discuss and examine what the future needs of the ABC division are and look toward advocating for additional funding with the overall Department of Revenue and Taxation operational budget.

Chairman San Nicolas spoke about the experience of the nominee. He stated that he is happy with the work being done by the Board and the ABC division but wants to explore new ways to get more support for the mandates they have. Chairman San Nicolas expressed his support for the nomination and adjourned the hearing.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Finance & Taxation, General Government Operations, and Youth Development hereby reports out the nomination of John R. Taitano to serve as a member of the Alcohol Beverage Control Board, for a term of two (2) years, with the recommendation


