#### **COMMITTEE REPORT DIGEST**

#### I. OVERVIEW

The nomination of Kamia L.G. Dierking to serve as a member to the Guam Board of Equalization, for a term of four (4) years, was made by Governor Edward J.B. Calvo on March 31, 2016. The nomination package was received by the Office of Speaker Judith T. Won Pat, Ed.D., on March 31, 2016, and was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on April 1, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a legislative hearing on April 14, 2016, in *I Liheslatura*'s Public Hearing Room. Among the items on the agenda was the nomination of Ms. Dierking. The hearing convened at 5:30 p.m. and was adjourned at 6:33 p.m.

#### II. TESTIMONY & DISCUSSION

**Chairman Michael San Nicolas** convened the hearing on the nomination of Ms. Kamia Dierking. He yielded the floor for the nominee for an opening statement.

Kamia Dierking stated that she is grateful for the renomination and looks forward to continuing the work of the Board.

Chairman San Nicolas asked what her experience was with the land revaluation and appeals process.

Ms. Dierking mentioned that there are many appeals to review and all appeals will be presented at one time to the Board.

**Chairman San Nicolas** asked how the Board will approach the review process.

**Ms. Dierking** answered that the Real Property Division of the Department of Revenue and Taxation is in the process of going through all the appeals and will present those to the Board so they can decide how to conduct the review.

**Chairman San Nicolas** stated that the Committee will contact the Department and ask for a status update on the appeals so that the Board can begin the review process. He thanked the nominee for her acceptance of the nomination. He stated that her experience of having gone through the revaluation process will be invaluable to the Board over the course of future revaluations.

Senator Dennis Rodriguez expressed his support for the nominee.

**Chairman San Nicolas** again thanked Ms. Dierking for her time and her acceptance of the nomination before concluding the hearing.


