COMMITTEE REPORT DIGEST

I. OVERVIEW

The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement convened a public hearing on June 8, 2016 at 9:00 a.m. in *I Liheslaturan Guahan* Public Hearing Room. Among the items on the agenda was the consideration of the appointment **Ms. Melanie R. Mendiola** to serve as a member of the Guam Port Authority Board of Directors, whose appointment history is as follows:

- Appointment by Eddie Baza Calvo, Governor, on May 19, 2016
- Appointment packet forwarded to *I Liheslaturan Guahan* on May 19, 2016
- Appointment packet forwarded to this committee for public consideration on May 20, 2016.

Public Notice Requirements

Public Hearing notices were disseminated via email to all senators and all main media broadcasting outlets on May 31, 2016 (5-Day Notice) and again on June 6, 2016 (48-Hour Notice). Publication was conducted in the May 31, 2016 issue and the June 6, 2016 issue of the **Guam Daily Post,** a newspaper of general circulation, fulfilling the 5-Day Notice of the Open Government Law requirements respectively.

The confirmation hearing for Ms. Melanie R. Mendiola commenced at 9:00 a.m.

II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Ada calls those who have signed up to give oral testimony.

Francisco Santos, Chairman, *Port Authority of Guam Board of Directors* (oral testimony): He is in support of Ms. Mendiola's confirmation. She's young, very intelligent, and her background in finance, administration, human relations, and grant writing. I'm asking you Mr. Chairman to find favor in her to be confirmed as one of the board members and join us because we want to fulfill our mission to move the port forward and take care of our assets, which are our hard working men and women at the Port Authority of Guam. I believe that she can share with us her knowledge and experience.

Joanne Brown, General Manager, *Port Authority of Guam* (oral testimony): She is in support of Ms. Mendiola's confirmation. She's pretty dynamic and I look forward to what her future will

be. She's sharp, smart, grounded. The innovative work that she's doing at Farm to Table and pioneering certain developments on Guam take things to a new level. There's no doubt that her presence and engagement with us will continue to move the Port forward. With our board, as you know, we've only had three board members which is the minimum to meet quorum so having an additional female member is a tremendous asset. We certainly hope the Committee gives her a favorable vote.

Ted Nelson (oral testimony): He is in support of Ms. Medniola's confirmation. The Governor has recognized her leadership and she will play a major role in the overall development of the commercial port. I ask, Mr. Chairman, for your favorable vote.

Melanie Mendiola, *Appointee* (written testimony): She reads her testimony (see attached testimony). Two reasons why I want to serve on the Port Authority of Guam Board involves my dad, Fred Mendiola. He joined the Port for eight years and saw the many developments and acquisitions of the Port's assets. He had tremendous respect for the importance of this agency that he instilled in me at an early age. Secondly, is what my dad called the "whole man concept". This concept takes into account academics, aptitude, demonstrated leadership, moral conviction, and ongoing community service. Her contributions to the Port are that she's a bridge builder that connects people to information and resources, strategic planning, stakeholder management, ethics, and sustainability.

Chairperson Ada: If it came to the point where the Port would have to pay the \$14 million liability to YTK, how would you address that kind of situation?

Ms. Mendiola: In financial planning, we call it an "income shock". It is when something happens to your balance sheet such as sickness, accident, or house burning down. This would be an income shock to the Government of Guam. I would look at which of the various options to meet that debt would impact the progress of the Port's strategic plan the least. Which of those options would have the smallest adverse effect in both the short and long terms. I'd also like to see that there are proper controls in place to minimize risks such as a bad lease. I'm very confident that the Board has highly skilled directors that would be able to facilitate the Port through this income shock.

Chairperson Ada adjourns the confirmation hearing for Ms. Melanie R. Mendiola.

III. Findings and Recommendations

The Committee finds that Ms. Melanie R. Mendiola received increasing support in testimony from the public at the public hearing. According to Title 12, Chapter 10 GCA, all members of the Port Authority of Guam (PAG) Board of Directors are appointed by the Governor for 3-year terms.

The Committee also finds that the terms of each member on the PAG Board of Directors are staggered and that the remaining two vacant seats on the PAG Board of Directors must be female members. Therefore, Ms. Mendiola will be filling one of the two vacant female seats for the remainder of a staggered three (3) year term from July 1, 2014 to June 30, 2017.



Dear Chairman Ada & Senators of the 33rd Guam Legislature:

I thank you for taking the time to add me to the agenda to discuss my nomination for the Board of Directors for the Port Authority of Guam. I further thank my friends and family for joining me today through their presence and testimonies of support. I wanted to share a bit of my background, which I believe will equip you to make a sound decision regarding my appointment.

1. Family

My full name is Melanie Rose Blas Mendiola. My mom is Sylvia Blas Mendiola, who is here with me today and my dad is Frederico Weilbacher Mendiola, who passed away in 2012. I am also joined by my brother, his wife, and son, Fred, Mae, & Noa Mendiola. I have one sister, Jennifer Mendiola, who passed in 2013. I reside in Pagat, Mangilao, behind the old Kinney's Café — which belonged to my Grandfather and then was run by my Uncle. The Blas family here in Guam and the Weilbacher's and Mendiola families in Pohnpei, Kosrae, and Rota have been involved in government service, and are much of the inspiration why I am here today.

II. Education

As far as my educational background, I am a 1999 graduate of the Academy of Our Lady of Guam. I double majored – in Economics and East Asian Studies in 2003 – from New York University. I received my MBA from the University of Guam in 2012. Currently, I am pursuing a PhD in Personal Financial Planning from Kansas State University. I am done with all my classes and my preliminary exams. I am basically in the dissertation process. I anticipate being complete in the next year.

III. Work Experience

I have been fortunate in my career to wear a variety of hats. I worked as an Analyst at HSBC Bank in New York. I was a Financial Advisor at Merrill Lynch here in Guam for 3 years. I spent a short time at ANZ, and lastly, at Empower Retirement — the current contractor for the defined contribution plan in the Government of Guam where I was a Retirement Counselor for 4 years. During my time at Empower, formerly known as Great West, I met with thousands of employees and conducted over 500 seminars concerning the importance of saving towards a comfortable retirement.

I am the current Project Director at Farm to Table Guam, a not for profit to assist farmers and agriculture based businesses in growing their business. I realize that this seems like a departure from my formal finance background, however, it is very interesting how my roles in finance have prepared me for this job that I hold today. I supervise 17 employees, 4 of whom, are physically disabled. I am very proud of all the work we do, the progress we have made, and the community's reception to what we have to offer which is to encourage individuals and businesses to support your local farmer.

IV. Community Service

With regard to community involvements, I am the President of the Board of Directors of the Guam Girl Scouts, an organization I have been involved in for the last 6 years. I am also the Treasurer of the Tourism Education Council, a member of the Guam Young Professionals, member of the American Council on Consumer Interests as well as the YMLG Women's Auxiliary.

V. Special Talents

I enjoy writing. I have written stories for local magazines including Guam Business News and the Marianas Business Journal. I have written over \$2 million in successful grant funding and I currently have \$1 million in the grants pipeline for organizations in the CNMI to stimulate trade with Guam.

A few of your local businesses will tell you that I have written their business plans, so that they may seek financing at our local banks - among them, 9th Street Rotary across the street, Lotus Surf Shop for my brother, and Gabriel's House of Pasta's expansion into Tumon.

Lastly, in the academic sphere, I am published. I presented on College Student Financial Wellness which was subsequently turned in to a paper which is *in press* for the Journal of Financial Counseling and Planning. I also presented at a national conference for the Association for Financial Counseling and Planning and a recent Korea Financial Planning Association seminar on Income Disparities and Marital Arguments.

V. Religious and Political Beliefs

I am a Catholic and a registered parishioner at Santa Teresita Church in Mangilao. I am also a registered Republican. I have not held positions in either of those capacities in the church or Government of Guam. This appointment would be my first.

VII. Why do I want to serve on the Port Authority?

There are two reasons why I want to serve on the Port board, both of which involve my dad, Fred Mendiola. After his retirement from the USAF, he joined the Port Authority for 8 years, where he served as Procurement Administrator. During that time, he oversaw the acquisition and development of many of the Port's assets. He had tremendous respect for the importance of this agency, which he instilled in me at an early age.

The second reason is because of what my dad called, the "Whole Man Concept", in my case, the "Whole Woman Concept". My father told me that when he was up for promotion in the Air Force, these were the pieces of evaluation that demonstrated if you were worthy of attaining the next level – in my father's case – it was E-9 – Chief Master Sergeant in the USAF. I am sure Chairman knows this, but for those not familiar, Whole Man Concept takes into account academic aptitude, demonstrated leadership, demonstrated moral convictions, and ongoing community service.

I have steadily garnered increasing levels of responsibility and experience in all my roles at school, work, and the community. When asked by the Governor's Office if I would be willing to serve, sentimental ties aside, I thought I would be a great fit. The Port Authority is an autonomous revenue generating agency with a lot of responsibilities including: 365 day/24 hour operations, revenue and overall fiscal management, being conscientious of local and maritime jurisdictions, employee relations, stakeholder management, strategic planning, and sustainability planning.

Yes, I have sentimental ties to the Port. I know employees from my time at retirement and through my dad, but I believe that I have the willingness and capability to take part in all these areas of leadership as demonstrated by my past experience.

VIII. What I bring to the Port Authority

- Building bridges connecting people to information and resources. When I was at retirement, it
 was about encouraging people to save and to do for themselves, not to wait for the government
 to do it for them. At Farm to Table Guam, I find that farmers are often intimidated by the prospect
 of working with big customers, like the hotels, or going after federal grants. I am their partner –
 and I pride myself on helping them find resources and build their businesses.
- Strategic planning I have been trained formally and informally about the importance of proper planning prior to execution. I have learned the hard way, when things have not worked out. I have learned the pain and hardship of last minute decisions. I have also learned the pain of bad decisions and long term consequences.
- The importance of stakeholder management Farm to Table Guam largely runs on collaboration with Government agencies, private companies, and the goodwill of the people of Guam. I realize that in the event I am confirmed, I will serve on the Board because elected leaders have put their trust in me. I think the only way to do that right, will be to build and strengthen collaborative relationships with Port leadership, the legislature, Adelup, and then customers and tenants of the agency itself.
- Ethics The Board and its members answer to the people of Guam, and anyone who believes in God, believes that we answer to him too. I take my fiduciary responsibility seriously in my current job at Farm to Table particularly with regard to federal funds and assets as well as all my other community involvements.
- Sustainability My role at Farm to Table is to rely less on food being imported from outside Guam. This however, does not remove the need for a Port. Farmers need supplies, building materials, and producers aspire to move into the point of exporting off island. If the Port is poorly managed, the farmer growing our food pays, as do the rest of the residents of Guam.

IX. YTK

On YTK. I have kept up with what has been reported in the news on a daily basis. What I do know is this:

- At least three gubernatorial administrations have been involved somehow in this lease arrangement.
- A decision has been made by the arbitration panel.
- There are parties in the government that disagree with the arbitration settlement.
- The Judiciary will decide where it should go from here.
- If it results in payment. This, to me, is what's called, an income shock. Income shocks generally have the following solutions:
 - Generate more revenue through greater volume or higher prices.
 - Generate cash through the disposition of assets.
 - Generate cash through the removal of expenses.
 - Free up cash flow through financing.
- Each of these four solutions comes with a whole lot of other implications, and the only way to get through it will be through collaboration with leadership, rolling up our sleeves, and getting to it.
- I would want to know before proceeding:
 - Which of these options will impact the progress of our strategic plan the least?
 - Which of these options will have the smallest adverse effect in both the short and long term?
 - Are the proper controls in place so the risk of a "bad lease" or any other such risk is minimized?

Thank you for listening to my statement concerning joining the Board of Directors of the Port Authority, and I humbly ask for the committee's confirmation during the next legislative session.
