#### COMMITTEE REPORT DIGEST

#### I. OVERVIEW

The Committee on Health, Economic Development, Homeland Security and Senior Citizens convened a public hearing on **September 11, 2015 at 9am** in *I Liheslatura*'s Public Hearing Room.

Among the items on the agenda was the consideration of the appointment of Ms. Sharon J. Davis as a Member of the Guam Memorial Hospital Authority Board of Trustees and whose appointment history is as follows:

- Appointed by Governor Edward J.B. Calvo on July 22, 2015.
- Appointment packet forwarded to *I Liheslatura* on July 22, 2015;
- Appointment packet forwarded to this committee for public consideration on July 23, 2015.

#### **Public Notice Requirements**

Notices were disseminated via electronic-mail to all senators and all main media broadcasting outlets on **September 2, 2015** (5-Day Notice), and again on **September 8, 2015** (48-Hour Notice).

#### II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 9:06AM.

**Senator Dennis Rodriguez, Jr.:** I'd like to now call on Ms. Sharon Davis If you could please come forward. Good morning. Thank you Sharon and it's nice to see you again. This morning I'd like to congratulate you on your appointment to the Board of Trustees, the Guam Memorial Hospital. If you have any prepared statements to go ahead and proceed with that now.

Ms. Sharon Davis: Hafa Adai Mr. Chairman, thank you for this opportunity to provide testimony on my appointment to serve the Guam Memorial Hospital's Board of Trustees. I'm humbled by the confidence that Governor Eddie Calvo has afforded me to be considered for this position. As a single mom, I raise my son Wade here on Guam, I've had the gift of support from our island community to raise my son here. I'm grateful for this opportunity to serve and give



back to that community that embraced my family and I. While I have a full time career at Guam Telephone Authority (GTA) I look forward to contributing my attention in this civic capacity as a Board Trustee. I will focus on the primary mission of quality patient healthcare for the island residence at GMH. From my work experience I will contribute a customer centric perspective to support the management staff and executing the GMH vision. I will bring the voice of the customer to the decision makers of GMH to develop products, services and leading customer experiences. I thank you Chairman Rodriguez for your time this morning and respectfully request your consideration to serve as Board Trustee. Thank you very much.

**Senator Dennis Rodriguez, Jr.:** Thank you very much Ms. Davis. Senator Underwood, do you have any questions or comments?

Senator Nerissa Underwood: I'll hold my question until after.

Senator Dennis Rodriguez, Jr.: Thank you very much. Ms. Davis, thank you again and congratulations. I know we had an opportunity to speak before today and I've discussed with you at least my vision and how I think the hospital will be, three (3) years from today five (5) years from today but also as we look towards that as I mentioned we do have a GMH Task Force that I've put together. We're looking at some viable solutions that we haven't tried, we haven't gone down and so we're looking at that, we'll be able to present it to the public but even with that plan, that master plan for the hospital, there's needs for a short term solution and perhaps you can share with the committee some of those short term visions that you would like to see and you would like to contribute to the board if you're confirmed.

Ms. Sharon Davis: I have not read or seen that plan as we discussed. I think it's exciting that you've got a task force behind it and I'm sure they're looking for what the top 10 things are, going to go after the easy things that you can change and that immediately but I read the other day about the maternity ward which I think is very exciting, a lot of folks visiting that section. To be very honest, I don't know have enough information to really give you what a vision would be at and I think it would be unfair for me to kind of throw that out there without having all that information. I just look forward to participating and reviewing and asking questions and getting to the vision that the board has today. What I did when I was thinking about taking the appointment for the board is that jumped online, started looking at all the information that's out there. There's a nice plan that's presented and I'm sure they're working towards it. I think it's exciting that the task force has been putting their energy behind something that's a lot of work to do and I hope to be able to be a part of that. So as far as long term vision, I mean I hope that they start making money which seems to be the concern that everyone has.

Senator Dennis Rodriguez, Jr.: Great. Okay thank you. Yes the report, the plan hasn't been published yet and so when that time comes we'll of course present that to the public as we move forward, but let me ask you, you're from GTA, you've worked there for many years, successful career there and it's become a successful entity, prior to it being run privately it was the



Government of Guam that was running it and as we move forward with this, the discussions at least Guam Memorial Hospital, we're looking at perhaps a public-private partnership in moving forward and really trying to get the Government out of operating the hospital but of course as I've mentioned the Government still has to be a part of it, but perhaps not as the operators and every time I talk, even with our task force I always reference the GTA, the GTA arrangement on how it was Government and it was ran by the private sector, as one of the executives here now. And so it's become successful and that's the type of models that we're taking a look at. What is your position on that? Or have you thought about it? Since the last time we spoke and is that something you think that you now have a new private hospital and is that a vision that you think you could support and be behind?

Ms. Sharon Davis: Yes. Absolutely. Again, I'm a firm believer in looking at all the data and making decisions based on that, talking with the employees there. But for sure I think that as you said and we discussed that GTA is a perfect example of that and it's important that you get the group of people that are working at the hospital behind the plan before you implement it and I think that GTA did a good job of that and carried that plan through the first few years which could have been a very difficult situation, we can't operate if we don't have employees. I think it's doable, I know that it's doable for GTA, and so I think it's exciting to look at that in a different perspective.

Senator Dennis Rodriguez, Jr.: Great and that's why I said I support your nomination, your confirmation, I think having the knowledge of how that evolved from Government to Private ensuring that we looked at a lot of factors, a lot of factors in the staffing, and that's one thing that I'm going to ask you to do once you get on the board is you really take time to meet the staff and talk to them because that is the biggest asset of the hospital is employees that work there and you hear that all the time. You hear that the care and the service is great there but the facility, the physical infrastructure is something challenged for us, it has been for many years but the employee's has always been an asset and you're right, to be successful you got to get them involved and to be able to support that. I wanted to let you know that I do support your confirmation and we'll move this through the process and get this through the next legislative session. Thank you. (Recognize Senator Underwood)

**Senator Nerissa Underwood:** Thank you Mr. Chairman. Sharon I do want to thank you for stepping up and being willing to serve as a board member. I did serve as a Guam Memorial Hospital Board of Trustees decades ago and so I do know how complex this could be. But I do have three (3) questions I want to ask you. What do you think is the role in the board in relation to management of the Guam Memorial Hospital Authority?

Ms. Sharon Davis: This would be my first board appointment and thank you for recognizing the stepping up to and I'll tell you as I was asked to participate I was very excited because I thought I could make it a positive contribution being where I'm from. As I read through the bylaws that



are published I think that my role and the boards' role is to guide and support and to push forward policies that make sense for GMH.

**Senator Nerissa Underwood**: So let me give you a hypothetical situation. You have a group of employees that will come to you concerning a situation that they have brought to the management's attention but has not been persistently addressed. How would you address that?

**Ms. Sharon Davis:** Address the group?

**Senator Nerissa Underwood:** How would you address the complaint that a group of employees are bringing to your attention?

Ms. Sharon Davis: Well I could give you an example of what I would do today with my own folks and that is certainly listen in a very respectful environment, we wouldn't be having this conversation in the middle of the call center and then ask them, well listen and let them know that I'm hearing them and ask them what they want to do about it and if it is important to them so much that they want to put energy behind it, I think that they'll right the things down and we'll get them organized and put them in front of someone that can make a difference about it. I think what you're referring to is, would I bring it to the board and have them review it, I'm not sure how that complaints would be address at the Guam Memorial Hospital if it came from a group of folks that's there.

**Senator Nerissa Underwood:** So this actually goes to the role of the board that sometimes becomes a conflict with the operations of the organization.

Ms. Sharon Davis: Okay I think I understand what you're saying. Well what I would say is that, there's three (3) sides to every story. His side, her side, and the truth and so I think it would be important to get all the sides and then put it in front of somebody, if it was a valid complaint. I'm not sure if we're talking about somebody, taking somebody's lunch out of the refrigerator or they feel like they need to get paid more money, I'm sure there's rules for those things. Somethings are simple to solve and I think for the most part senator. Folks want to be heard and if they feel like they're not being heard then they're going to tell somebody about it and if you don't address it then it gets worse there not comfortable with their job and that hurts everybody, the company, customer. So I think that it's important that folks get heard.

**Senator Nerissa Underwood**: So you would entertain that, employees?

Ms. Sharon Davis: I would certainly listen to what they had to say, yes.

**Senator Nerissa Underwood**: Would you involve the management at that point?



Ms. Sharon Davis: I think the question that I would ask is if they did do it, chain of command, you know, did you talk to your supervisor about this? Did you talk to your manager about this? And what did they do about it? I'm sure those kinds of things. I really believe that most people want to be heard, a lot of times those kind of, maybe somebody got their feelings hurt.

Senator Nerissa Underwood: Well Guam Memorial Hospital is a very sensitive but highly stressful asset and I wouldn't compare it to education but having been at Department of Education (DOE) I clearly know that any given day things could go wrong and that given day people would be happy and some people would be not so happy and so there's always something that might be brought to the boards attention, but what makes it complex and difficult is the management, is when the board would entertain their group without their knowledge, right. And then you become a manager, because once employees know that they can go to the board directly then what's the point of going to, because the board ultimately for some employees is really the one that has a say-so and can make the managers do what they want. So you know what I'm talking about?

Ms. Sharon Davis: I do.

Senator Nerissa Underwood: So the role of board members has to be clearly defined, right? In relation to the operations and in relation to the management then it would become very difficult for your managers. So I just wanted to ask you not to be difficult but because this is really critical, your relationship to the management will determine the extent which the board can really support and it's in those complex interpersonal relationships are those conflicts that you will define your relationship. So I would just want you to think about that. What do you think would be the three policy priority? You've been here, you know what's going on, the challenges in the hospital. What do you think the three or two policies that you think are critical to the success of GMH?

Ms. Sharon Davis: Coming from where I sit in my career, I would definitely say service. Service is important across any company and interestingly enough all of the information that I've read about GMH there's not one measurement to service for that side of the house. Most of it is the operational data about health and safety and that which is also very important so I would say, service would be one of mine. And I think second would just be to keep, well I would like to update the website and give the public more information about what's really going on at GMH. So those two things are top of the mind for me.

Senator Nerissa Underwood: Thank you Mr. Chairman.

Ms. Sharon Davis: Thanks for the tip too, it sounds like that was something that you were faced with when you were a board member, that folks were constantly coming to you and then you really had to consider.

**Senator Nerissa Underwood:** And faced as a manager as the largest agency.



Senator Dennis G. Rodriguez, Jr.: Great, thank you very much Sharon. Thank you senator. We have Senator Espaldon, thank you senator for joining us this morning. We're about to wrap up this hearing on her. Do you have any questions for Ms. Davis? None. Okay Sharon I just want to congratulate you again and we'll move this confirmation process forward, okay? And we'll keep the record open for the next few days and the public is invited to present any written testimony that they'd like on the appointment of Ms. Sharon Davis, to serve as a board of trustee, member of the Guam Memorial Hospital Authority.
