The Committee on Transportation, Infrastructure, Lands, Border Protection, Veterans' Affairs and Procurement convened a public hearing on April 6, 2015 at 1:30pm. in *I Liheslaturan Guahan* Public Hearing Room. Among the items on the agenda was the consideration of the appointment for Mr. Tae S Oh. to serve as a Member of the Guam Land Use Commission., whose appointment history is as follows:

- Appointment by Eddie Baza Calvo, *Governor*, On March 9, 2015;
- Appointment packet forwarded to *I Liheslaturan Guahan* on March 10, 2015:
- Appointment packet forwarded to this committee for public consideration on March 11, 2015.

## II. SUMMARY OF TESTIMONY AND DISCUSSION

**Chairman Ada**: Calls on Mr. Tae Oh and Mr. Mike Borja Director of Land Management to approach the panel to give their testimonies.

**Mr. Tae S**. Oh (see transcript of oral and written testimony): Read his written testimony.

**Mr. Mike Borja** ( *see* transcript of *oral and written testimony*): Is in support of Mr. Oh's nomination to sit on the Guam Land Use Commission. He believes Mr. Oh's experience in engineering, real estate, and business in the private sector provides him with the attributes that would make him an effective Commissioner.

**Chairman Ada**: Then opens up the panel to the senators for questions and comments.

**Sen. Aguon**: Asks a question about how Mr. Tae Oh would approach an application for zone change if it had to deal with Mr. Oh's family business of buying and rehabilitating building units.

Mr. Tae Oh: said he will recuse himself from anything that may be a conflict of interests.

**Sen Aguon**: stated he anticipates the Guam Land Use Commission will have their hands full with zone changes when the military build-up happens and hopes Mr. Oh continues to look out for the best interest of the community.

Vice Speaker Cruz: Stated he is comfortable with Mr. Oh's nomination.

**Sen. Morrison**: Asked if Mr. Oh has ever sat in on any of the Board Meetings.

**Mr. Tae Oh**: Stated that he did sit in on one GLUC board meeting, which he was invited to by Mr. Mike Borja. It was a quick learning experience and was very familiar with what was being discussed at the meeting.

**Sen. Barnes**: Stated she is hoping that Mr. Oh can make all the board meetings, because there is history with GLUC not making quorum.

**Chairman Ada**: stated his belief that the GLUC will drive the face of this community in regards to zoning. Mr. Oh's engineering background, real estate experience and being a businessman is a great attribute to the GLUC.

**Mr. Tae Oh**: Just wanted to thank everyone and will make sure to do his best as a GLUC member.

Chairman Ada: Confirmation stated the hearing has been deemed completed.
