



II. SUMMARY OF TESTIMONY AND DISCUSSION

Ms. Maria Alicia G. Tenorio mentioned that Mrs. Tes Reyes Burier is a good person and that she has known Tes for about 20 years working at Agana Shopping center. She is in full support of Mrs. Tes Reyes Burrier.

Speaker Won Pat, Ed.D. asked Mrs. Reyes-Burrier about her legal name since her police clearance and court clearance has her by the name of Maria Teresa C. Reyes. Speaker asked Mrs. Reyes-Burrier to state her legal name.

Mrs. Tes Reyes-Burier stated that her legal name is Maria Teresa Reyes Burier.

Mrs. Tes Reyes-Burier testified before the committee and her written testimony is appended to the committee report.

Mrs. Tes Reyes Burier thanked her friends and family who came to support her, and her husband. She mentioned that she has been here for over 30 years and Guam has molded her to the person she is today.

Speaker Won Pat, Ed.D. asked if Tes had the opportunity to sit on any of the board meetings for CAHA, not as a voting member but, to be introduced to see what they do.

Mrs. Tes Reyes-Burrier replied that she has yet to attend, but she did go to their website, to check on the latest updates.

Speaker Won Pat, Ed.D. asked, "So then are you aware of its mission and what you need to do?"

Mrs. Tes Reyes-Burrier answered with a Yes.

Speaker Won Pat, Ed.D. thanked the appointee for accepting of course the appointment and mentioned that it is very important to accept it first. Speaker is also very happy to hear that absence is not the case especially with board members who are appointed but been absent a lot. Speaker also mentioned that it is very difficult sometimes to have a quorum and that is quite critical because CAHA is in the middle of being involved with FESTPAC that Guam will be hosting in 2016. Speaker mentioned that because everyone is watching, Hawaii, the United Nations, we have to do whatever we do to make FESTPAC successful.

Speaker Won Pat, Ed.D. asked, "With all your skills and abilities, is there one thing that you can bring to CAHA to help it move forward?"

Mrs. Tes Reyes-Burrier replied that she worked at Lotte, and she had to incorporate the culture of Korea because Lotte is Korean owned. She also mentioned that the Korean form of respect is to bow so she incorporated that with the Håfa Adai pledge. Mrs. Reyes Burrier briefly talked

about the art of culture of Guam to be marketed globally. Mrs. Reyes Burrier wants people to experience the culture of Guam without coming here; to have Guam globalized and to make artists and art exposed.

Speaker Won Pat, Ed.D. mentioned that she is glad that Mrs. Reyes-Burrier brought that up, the idea to market globally and mentioned that Mrs. Reyes-Burrier's major in marketing will definitely help.

Mrs. Tes Reyes-Burrier mentioned the pages of art, a book to be used for generations to come for tourist and visitors or for people living off island.

Speaker Won Pat, Ed.D. mentioned that she and Mrs. Reyes-Burrier are of like minds, and that Mrs. Reyes- Burrier has her vote. Speaker thanked everyone who came forward to provide testimony.




