COMMITTEE REPORT DIGEST

I. OVERVIEW

The nomination of William West L.G. Cassidy to serve as the Insurance Business Officer Representative to the Guam Banking and Insurance Board, for a term of six (6) years, was made by Governor Edward J.B. Calvo on October 17, 2016. The nomination package was received by the Office of Speaker Judith T. Won Pat, Ed.D., on October 18, 2016, and was subsequently referred by the Committee on Rules to the Committee on Finance & Taxation, General Government Operations, and Youth Development on October 19, 2016.

The Committee on Finance & Taxation, General Government Operations, and Youth Development held a legislative hearing on November 7, 2016, in *I Liheslatura*'s Public Hearing Room. Among the items on the agenda was the nomination of Mr. Cassidy. The hearing convened at 9:11 a.m. and was adjourned at 10:33 a.m.


