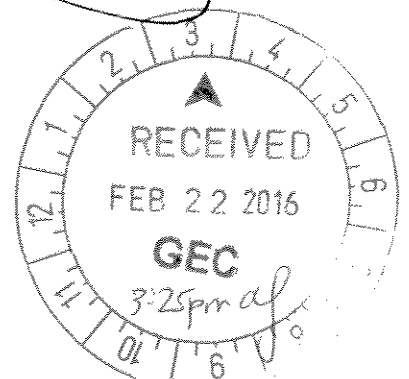
1. The Legislature did consent to the nomination of Frank P. Arriola to serve as a Member of the Guam Community College Board of Trustees.
