Dear Governor Eddie Calvo:

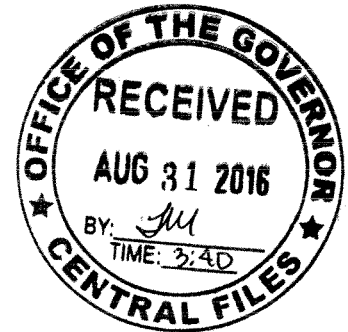
