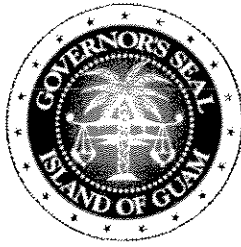

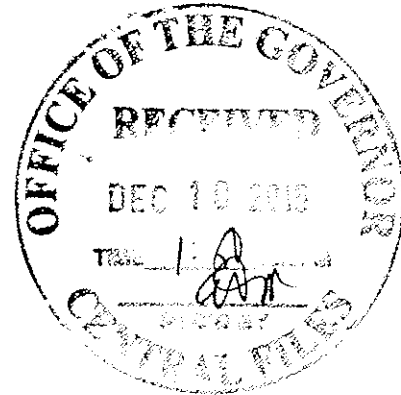

Dear Governor,


I regret to inform you that I'm resigning as a member of the board of trustee at Guam Memorial Hospital Authority effective today.
