4 Guam in 1983; and

5 **WHEREAS**, as a result of the demand for regularly scheduled flights,
6 All Nippon Airways inaugurated service to Guam in 1986; and

2 way for additional visitors to Guam from its main market of Japan by utilizing
3 its Osaka gateway; and

5 scheduled flights, All Nippon Airways continues to play a role in Guam's
6 visitor industry by offering daily wide body service from Osaka's Kansai
7 International Airport; now, therefore, be it
