**Relative to congratulating Fiesta Resort Guam on its
grand opening celebration on March 11, 2006.**

1 **BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF I**

3 **WHEREAS**, in March 17, 1971, Fiesta Resort Guam, formerly known as
4 the Guam Dai-Ichi Hotel, was the first high rise hotel on Guam and expanded
5 with a new wing known as the Tower, in 1986, to accommodate three
6 hundred thirty seven (337) guests and provide a chain of eleven (11) food and
7 beverage outlets; and

1 **WHEREAS**, in March 2002, Fiesta Resort Guam became the newest
2 member of Tan Holdings, a diverse holding company operating in fourteen
3 (14) industries located in Guam, Saipan, Micronesia, Japan, and the Northern
4 Mariana Islands; and

5 **WHEREAS**, Fiesta Resort Guam and Fiesta Resort and Spa, Saipan are
6 owned and operated by Asia Pacific Hotels, Inc., a subsidiary of Tan
7 Holdings; and

8 **WHEREAS**, in December 2005, the three hundred eighteen (318) rooms
9 and four (4) food and beverage outlets of the Fiesta Resort Guam underwent
10 major renovations designed to treat guests to an experience of a modern,
11 sophisticated tropical design; and


12 **WHEREAS**, Fiesta Resort Guam is committed to providing the people
13 of Guam and visitors a new venue to relax, enjoy our surroundings,
14 entertainment and beaches, and appreciate the culture; now, therefore, be it

15 **RESOLVED**, that the Executive Committee of *I Mina'Bente Ocho Na*
16 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
17 people of Guam, congratulates Fiesta Resort Guam on its grand opening
18 celebration on March 11, 2006 in the heart of Tumon Bay, Municipality of
19 Tamuning; and be it further


20 **RESOLVED**, that the Executive Committee of *I Mina'Bente Ocho Na*
