15 Inaugural moment; and


16           **WHEREAS**, Mr. Romeo A. Angel will be installed by past District

19 Guam Reef Hotel; now, therefore, be it


20           **RESOLVED**, that the Executive Committee of *I Mina'Bente Ocho Na*
