4 **Owner and Chairman of the Board opened its doors at the lowly streets of**
5 **Rizal Avenue in downtown Manila, Philippines; and**

1 **WHEREAS**, Shoe Mart pioneered in the latest fashion trends of shoes
2 and bags, presented in a distinct scheme comparable to the best department
3 stores throughout the world; and

4 **WHEREAS**, with the success of Shoe Mart on Rizal Avenue, several
5 stores were opened in Carriedo and Tabora (Divisoria) in the 1960's and
6 expanded to ready-to-wear apparel and accessories in Quiapo in 1972; and

7 **WHEREAS**, despite the political and economical turmoil of the country
8 during the 1980's, the growth of the company persisted and revolutionized
9 the retail industry, creating another milestone by building its first Shopping
10 Mall at North Edsa, Philippines; and

11 **WHEREAS**, in May 2006, Shoe Mart brought shopping, leisure and
12 entertainment to another level by opening the Mall of Asia, which sits on a
13 nineteen (19) hectare property overlooking Manila Bay with more than four
14 hundred thousand (400,000) square meters consisting of four (4) buildings
15 linked together by elevated walkways; and


16 **WHEREAS**, with more than four (4) decades of success, the company
