4 to providing quality entertainment to the people of Guam; and


5 **WHEREAS**, Tango Theaters and Tan Holdings Company are devoted to

9 the people of Guam; now, therefore, be it


10 **RESOLVED**, that the Executive Committee of *I Mina'Bente Ocho Na*
