1 BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF I  
2 *MINA'BENTE OCHO NA LIHESLATURAN GUÅHAN*:

3 WHEREAS, the Filipino community on Guam has been growing and  
4 thriving as families relocate and younger generations start families of their  
5 own; and

1           **WHEREAS**, members of the Filipino community have initiated formal  
2 associations according to provincial and professional affinities, to celebrate  
3 common traditions, perform works of general benefit to the community at  
4 large, and promote the interest of their members; and

5           **WHEREAS**, the members of each such association has recognized and  
6 placed in positions of authority and trust nominees from their own ranks,  
7 producing a growing number of recognized community leaders; and

8           **WHEREAS**, in 1997, a group of current and former elected association  
9 leaders organized to accommodate the energies, and further the interests of all  
10 past and present Presidents and Vice Presidents of the various Filipino ethnic  
11 organizations; and

12           **WHEREAS**, the Association of Filipino Presidents On Guam  
13 (“AFPOG”) was duly established as a charitable organization under the laws  
14 of Guam on July 9, 1997; and

15           **WHEREAS**, the first Induction of Officers and Board of Governors was  
16 held at the Palace Hotel on August 15, 1997, under the chairmanship of Mr.  
17 Ernie Cid; and

18           **WHEREAS**, since that first Induction of Officers other prominent  
19 leaders from the Filipino community have chaired the Association of Filipino  
20 Presidents on Guam, namely Jose R. Guevara, Concepcion Viray, James  
21 Robinson, and Mert Uy; and

22           **WHEREAS**, the Association of Filipino Presidents on Guam (“AFPOG”)  
23 was formed to promote and enhance the professional development of its

1 members, and to foster camaraderie, good relationships and unity among its  
2 members; and

3       **WHEREAS**, AFPOG further seeks to actively participate in community  
4 affairs and extend assistance as its members deem appropriate; and

5       **WHEREAS**, the accomplishments and good works of AFPOG are many,  
6 including contributions to the American Red Cross Guam Chapter, a  
7 scholarship for deserving Business majors attending the University of Guam,  
8 professional development sessions for its members, and participating in  
9 various community activities and projects; and

10       **WHEREAS**, members of the Association of Filipino Presidents on Guam  
11 celebrate their cumulative progress and look forward with confidence on the  
12 occasion of the Eighth (8<sup>th</sup>) Anniversary and Induction of Officers and Board of  
13 Governors, held on May 27, 2005 at the Guam Marriott Hotel's Chamorro  
14 Ballroom A; now, therefore, be it


15       **RESOLVED**, that the Executive Committee of *I Mina'Bente Ocho Na*
