- 7 is "Identity Theft", which embodies not only the emerging electronic market,
- 8 but also the more traditional methods of theft, such as stealing sensitive pieces

WHEREAS, the Consumer Advocate, with oversight from the Consumer Counsel, upon receipt of consumer complaints responds, and takes appropriate action; now, therefore, be it
