10 superiors and subordinates; and


11 **WHEREAS**, looking to the future and working towards the betterment of

22 Cameron, Fiona, and Ian; now, therefore, be it


1 **RESOLVED**, that the Executive Committee of *I Mina'Bente Ocho Na*
