- 3 WHEREAS, Mary M. Roth, was born in Palmyra, Pennsylvania, to
- 4 Clarence and Nettie Mehaffey; and
- 5 **WHEREAS**, Ms. Roth chartered a path of education and educating; first,
- 6 by earning a Bachelor of Arts Degree with a major in English and History, and
- 7 a minor in French and Education in 1943 from Lebanon Valley College in
- 8 Annville, Pennsylvania; and later by obtaining graduate courses from the
- 9 University of Guam; and
- 10 WHEREAS, after first imparting knowledge and wisdom to the school
- 11 children in Maryland, Ms. Roth came to Guam in 1960, along with her
- 12 husband, the late Captain Alexander Roth, Jr., of the Merchant Marines, and
- 13 their daughters, Susan and Jennifer. Together they made Guam their home

- 1 for the next forty-five (45) years, and exclusively during the last thirty (30)
- 2 years; and
- 3 **WHEREAS**, Ms. Roth has been recognized as an invaluable educational
- 4 asset in our island's public educational system, which she first joined in 1960.
- 5 She later retired in 1994 with a distinguished thirty-three (33) years of
- 6 dedicated service; and
- WHEREAS, Ms. Roth has earned numerous awards and recognition
- 8 from all sectors of the community that laud her efforts to ensure excellence in
- 9 education; commending her for her continued efforts that have contributed to
- 10 the improvement of education on Guam; and
- 11 WHEREAS, testimony to Ms. Mary M. Roth's legacy is found in her
- 12 being awarded the title of "Mama Shark," a term of endearment offered to her
- 13 by the students, staff and faculty of Simon A. Sanchez Junior/Senior High
- 14 School, Home of the Sharks; a school where she spent the last twenty (20)
- 15 years of her employment with the Department of Education; and
- WHEREAS, prior to teaching at the Simon Sanchez Junior/Senior High
- 17 School, Ms. Roth taught students at the former George Washington
- 18 Junior/Senior High School in Maite, and the former Tumon Junior/Senior
- 19 High School (John F. Kennedy High), where her work was credited with
- 20 ensuring the schools were successful in acquiring accreditation by the
- 21 Western Association of Schools and Colleges; and
- WHEREAS, Ms. Roth's efforts in education was recognized by
- 23 induction into the prestigious Phi Delta Kappa Chapter 1302 Guam Education
- 24 Fraternity as a "Hall of Fame" member in 1995; and

1 WHEREAS, Ms. Roth continues to remain active in our island 2 community, assisting and contributing insurmountable amounts of assistance to various organizations, including current work and membership in various 3 capacities with the International Reading Association (IRA), the Lutheran 4 Church of Guam, the Phi Delta Kappa, the Guam Duplicate Bridge Club and 5 the Habitat for Humanity; now, therefore, be it 6 **RESOLVED**, that the Executive Committee of I Mina' Bente Ocho Na 7 8 Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the people of Guam, commend and recognize Ms. Mary M.
