6 **WHEREAS, in 1971 Joseph R. Reyes graduated form George**

7 **Washington High School; and**

8 **WHEREAS, in 1975 Joseph R. Reyes earned an Associates**

9 **Degree in Physical Education from the University of Guam; and**

10 **WHEREAS, in January 12, 1981 Joseph R. Reyes was sworn**

11 **into office having the Honor and privilege to serve as assistant**

12 **Commissioner for the people of Agat; and**

1 **WHEREAS, in January 14, 1985 Joseph R. Reyes was sworn in**
2 **again to serve a second term as assistant Commissioner for the**
3 **people of Agat; and**

4 **WHEREAS, Joseph R. Reyes served the Island Community as**
5 **an actively assistant Commissioner and participated in various**
6 **organizations for the betterment of the island community; and**

7 **WHEREAS, because of Joseph R. Reyes' passion for baseball,**
8 **he shaped Guam's Youth by being a participant in the Guam Little**
9 **League and the Bambino Hafa Adai League and preparing for the**
10 **next level of Guam's baseball; and**

11 **WHEREAS, Joseph R. Reyes' participation in Guam's Youth**
12 **baseball has advanced many to the Guam Amateur Baseball**
13 **League and Guam Major League Baseball league; and**

14 **WHEREAS, Joseph R. Reyes was instrumental in assisting the**
15 **Department of Youth Affairs for the welfare of Guam's troubled**
16 **youth; and**

17 **WHEREAS, Joseph R. Reyes was actively and spiritually**
18 **involved in the Agat Parish Council in bringing faith in the**
19 **community to the Lord and the Agat parish; and**

1 **WHEREAS; Joseph R. Reyes was an active participant in**
2 **assisting the American Red Cross Guam Chapter for those in need;**
3 **and**

4 **WHEREAS; Joseph R. Reyes was an active participant in the**
5 **awareness of Cancer in Guam for the American Cancer Society; and**

6 **WHEREAS; Joseph R. Reyes was a member of the Anderson**
7 **Air Force Base Community Council working closely with the**
8 **military community; and**

9 **WHEREAS; Joseph R. Reyes was a member of the Legislative**
10 **Committee under the Mayors Council working collaboratively**
11 **with Law makers for the betterment of Guam's community; and**

12 **WHEREAS; he is survived by his mother Felisa R. Francisco**
13 **and his siblings Antonio R. Charfauros, Florence R. Anderson,**
14 **Clarita R. Babauta, Jeanette R. Peckich, John R. Reyes, Annie R.**
15 **Abrenilla, George Guevara (Vallejo, California), Connie Febres**
16 **(Vallejo, California), and Helen Vegas (Vallejo, California); now,**
