

WHEREAS, Mr. Chris Anthony M. Dangan attended high school and graduated from Guam Community College in 1996; and

WHEREAS, Mr. Chris Anthony M. Dangan graduated from the 37th Police Cycle in November 1997 and was assigned as a Patrol Officer in the Patrol Division of the Guam Police Department; and

WHEREAS, Mr. Chris Anthony M. Dangan throughout his career offered his services to fellow law enforcement officers and the community in the *Hagåtña*, *Dededo*, and *Tamuning-Tumon* Precincts, where he is currently assigned; and

WHEREAS, Police Officer II Chris Anthony M. Dangan has been vital to the Department by taking on numerous high profile cases through which he recovered sixty-five thousand dollars (\$65,000) worth of stolen property and cash; and

WHEREAS, Police Officer II Chris Anthony M. Dangan was later assigned to the Tamuning-Tumon Precinct Command where he proved his compassion and dedication to serve well, evidenced by his selection as the 'Police Officer of the Quarter' from January to March 2005; and

WHEREAS, during May 2005 Officer Chris Anthony M. Dangan and Officer Yi responded to a call for distressed swimmers off Ypao Beach during which the Officers managed to swim out and successfully escort a family to safety; and

WHEREAS, on June 15, 2005 Officer Chris Anthony M. Dangan was awarded the 'Above the Call of Duty for Life Saving' by the Guam Hotel & Restaurant Association (GHRA) for saving the lives of the distressed swimmers; and

WHEREAS, Police Officer II Chris Anthony M. Dangan continues to distinguish himself with superior performance by demonstrating his ability, competency, efficiency, hard work and loyalty to the Guam Police Department and the island; now therefore, be it

RESOLVED, that the Executive Committee of *I Mina'Bente Ocho Na Liheslaturan Guåhan* does hereby, on behalf of the people of Guam, commend and congratulate Police Officer II Chris Anthony M. Dangan '2006 Police Officer of the Year,' bestowed upon him on May 18th, 2006; and be it further
